## CAPITAL IMPROVEMENTS FUND

A. BA15-77, Project No. REM0002\_P — Office of Business and Financial Services — Request to budget additional revenue derived from the sale of property at 3680 Mercy Drive to Xiaoyu Abrasive, Inc. Net Increase: \$215,048.

### GRANTS FUND

- A. BA15-74, Grant No. OPD0035\_G and OPD0036\_G Police Request to budget FY2015/16 VAWA/STOP Intimate Violence Enhanced Service Team (InVEST) Grant Award through the Florida Coalition Against Domestic Violence as well as the corresponding grant match. Award approved by City Council on 7/13/15. Net Increase to Grants Fund: \$107,315. Transfer of Existing Budget from General Fund to Designated Revenue Fund: \$35,771.
- B. BA15-75, Grant No. OPD0037\_G Police Request to budget Organized Crime Drug Enforcement Task Force (OCDETF) Agreement approved by City Council on 7/13/15, for overtime reimbursement. Net Increase to Grants Fund: \$2,430.
- C. BA15-78, Grant No. TRE0003\_G Public Works Request to budget Local Agency Program Agreement with Florida Department of Transportation for the design and construction of the Colonial Drive Pedestrian Overpass. Agreement approved by City Council on 5/18/15. Net Increase to Grants Fund: \$9,190,531.

D. BA15-73, Grant Nos. FPR0009\_G and FPR0010\_G; Cost Centers FPR0004\_C, FPR0005\_C, and REC0001\_C - Families, Parks & Recreation - Request to recognize grant and prorated match funding for the third installment of the O-PASS AmeriCorps Grant (Orlando Partnership for School Success) as approved by City Council on 8/26/2013. This grant will also provide an additional Contract Administrative Assistant to help manage the grant. This item is related to 6A. # 3. 911 EMERGENCY PHONE SYSTEM FUND

A. BA15-76, Cost Center Nos. OPA0005\_C and OFS0004\_C - Police and Fire - Request to allocate Emergency Phone System Fund Balance to go towards the purchase of 911 Call Center furniture. Contract to purchase the 911 Call Center furniture is scheduled to be approved by City Council on 7/27/15. Net Increase: \$503.333.

# 4. STORMWATER <u>UTILITY FUND</u>

A. BR15-17, Project Nos. CIP0123\_P, CIP0128\_P, CIP0086\_P and STW0001\_P – Public Works – Request to reprioritize project funds to repair damaged pipes and various emergency infrastructure failures in the Stormwater drainage system. Transfer of Existing Budget: \$2,200,000.

# 5. BUILDING CODE EN811FORCEMENT FUND

A. BA15-79, Project No. PER0002\_P - Economic Development - Request to allocate fund balance to purchase equipment needed for the Economic Development Information System project installation. Net Increase: \$2,000,000.

A. Families, Parks, & Recreation – FPR0004\_C – Request to add two (2) Contract Regional Recreation Specialist positions to support the expansion of the program to Carver and Memorial middle schools. Existing budget will cover the additional costs incurred the remainder of the fiscal year. Funding was awarded for FY15/16 that will cover future costs.
