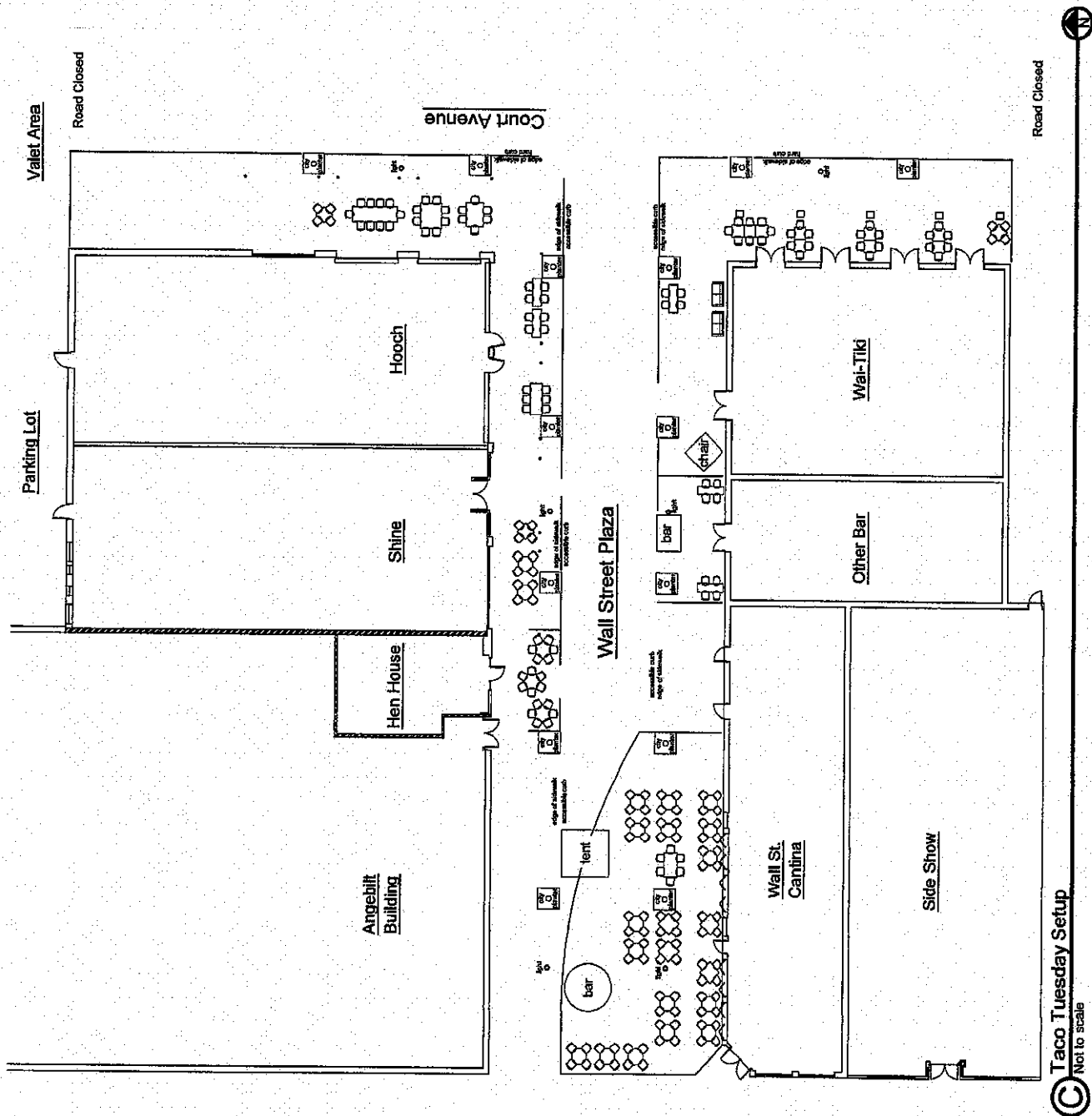


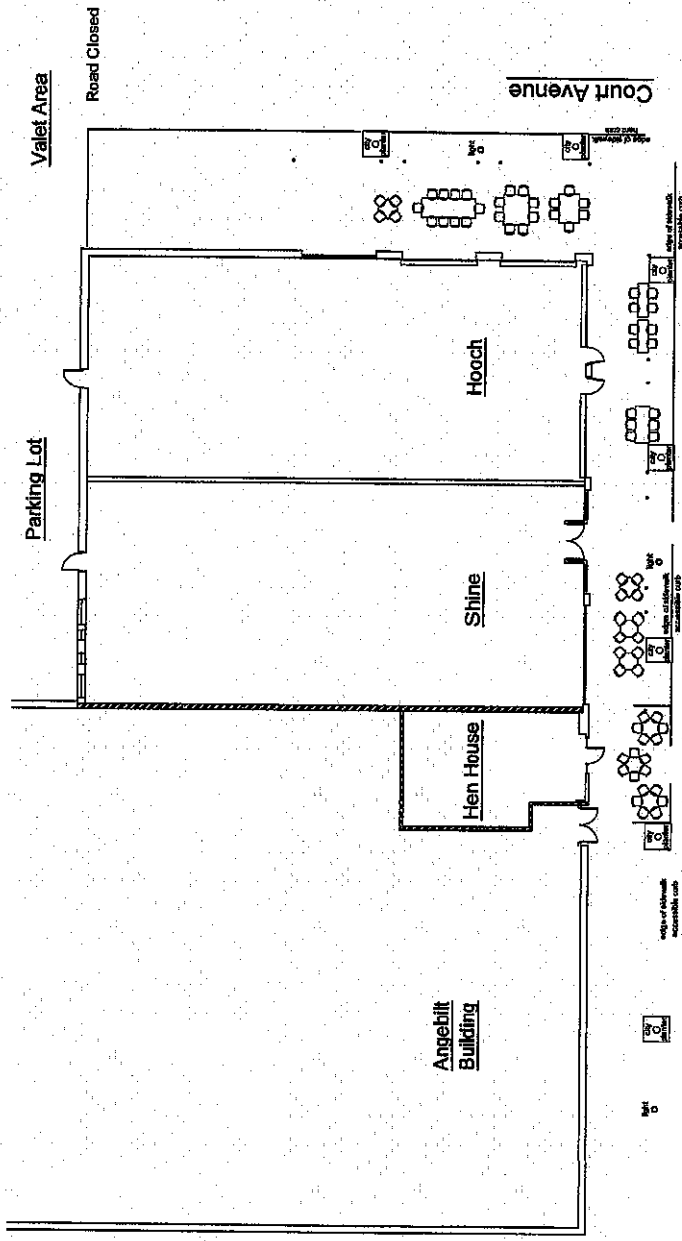
A Main Weekend Block Parties & Special Events Setup

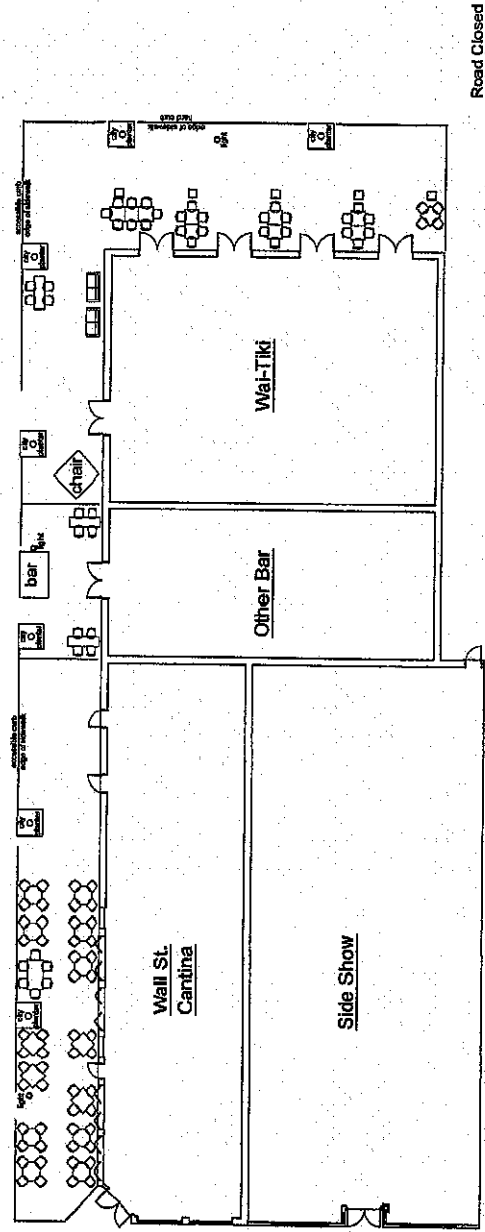
(B) Weekend Setup with Food Trucks

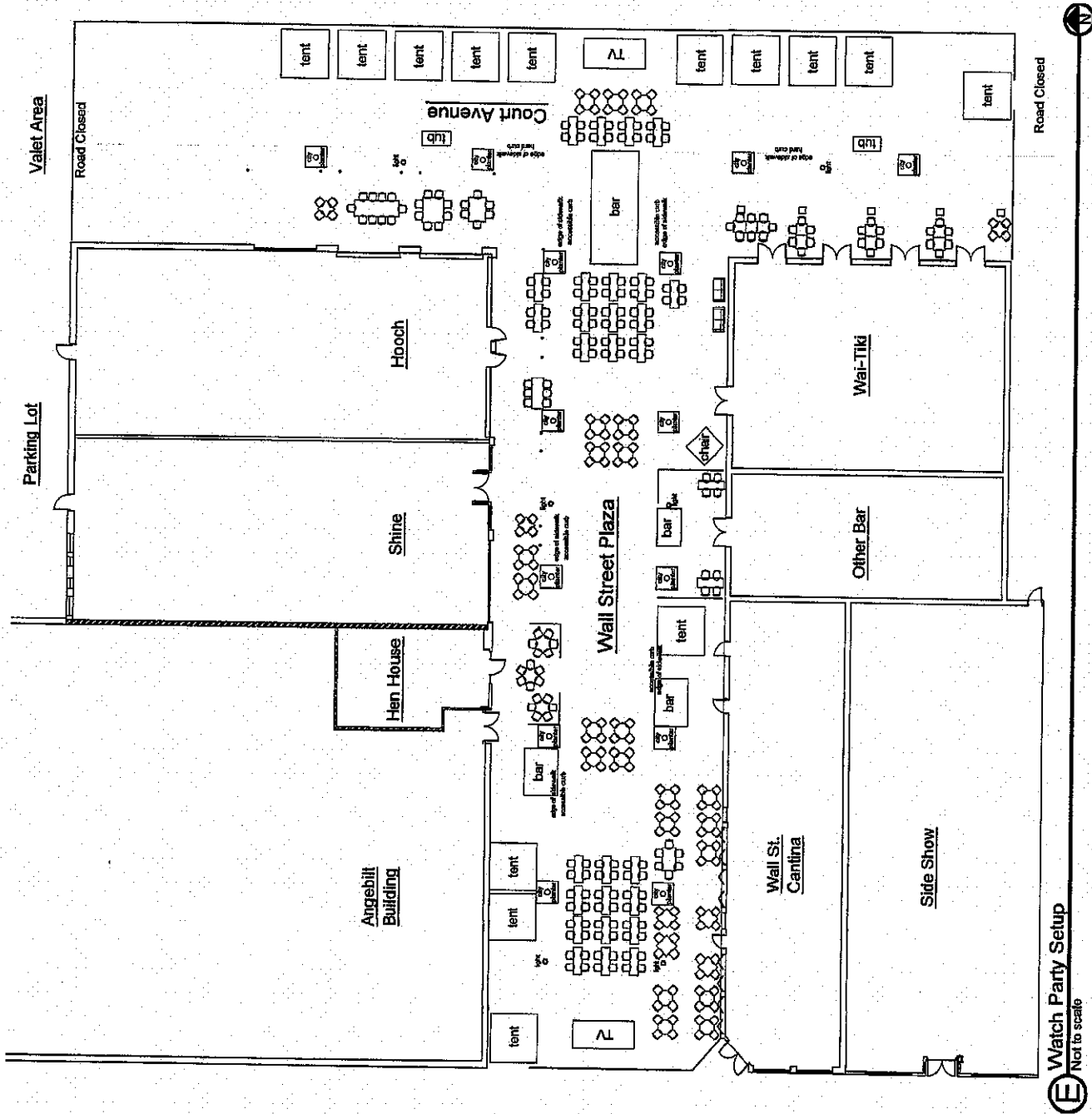




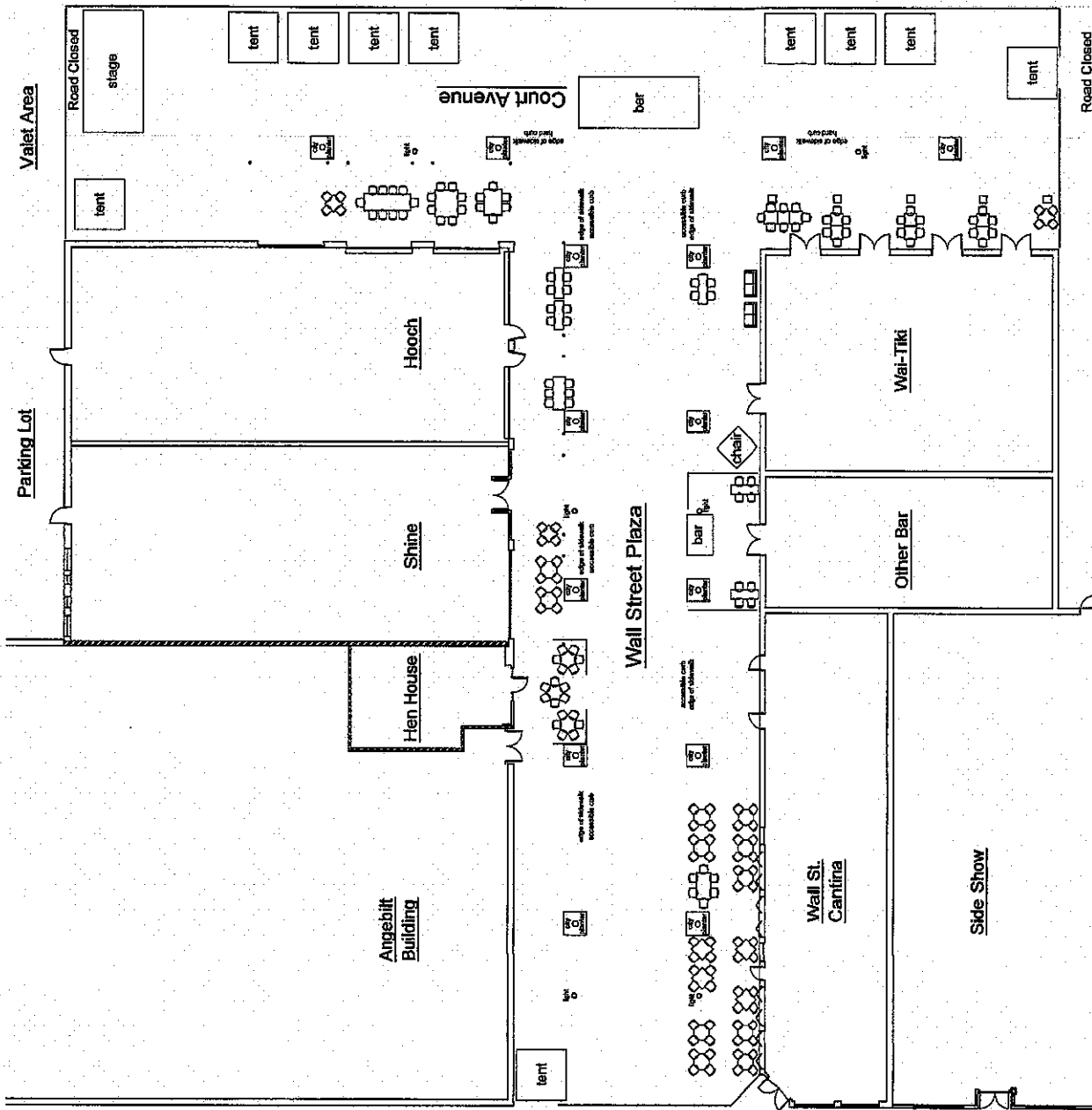
Wall Street Plaza
