For individuals who conduct lobbying activities with Aviation Authority employees or Board members, registration with the Aviation Authority is required each year prior to conducting any lobbying activities. A statement of expenditures incurred in connection with those lobbying instances should also be filed prior to April 1 of each year for the preceding year. As of January 16, 2013, lobbying any Aviation Authority Staff who are members of any committee responsible for ranking Proposals, Letters of Interest, Statements of Qualifications or Bids and thereafter forwarding those recommendations to the Board and/or Board Members is prohibited from the time that a Request for Proposals, Request for Letters of Interests, Request for Qualifications or Request for Bids is released to the time that the Board makes an award. As adopted by the Board on September 19, 2012, lobbyists are now required to sign-in at the Aviation Authority offices prior to any meetings with Staff or Board members. In the event a lobbyist meets with or otherwise communicates with Staff or a Board member at a location other than the Aviation Authority offices, the lobbyist shall file a Notice of Lobbying (Form 4) detailing each instance of lobbying to the Aviation Authority within 7 calendar days of such lobbying. As of January 16, 2013, Lobbyists will also provide a notice to the Aviation Authority when meeting with the Mayor of the City of Orlando or the Mayor of Orange County at their offices. WHEREAS, Central Florida benefits from having two world-class global gateways for international travel and cargo transport in the Orlando International Airport and Port Canaveral, and WHEREAS, the Airport's status as the 14th busiest in the United States with nearly 39 million annual passengers and the Port's ranking as the 2nd busiest cruise port in the world with more than 4 million annual passengers create numerous business and leisure opportunities for the region, and WHEREAS, each port is recognized as an industry leader with a reputation for foresight and innovation, both are currently engaged in planning, developing and building for the future. Fort Canaveral has \$244 million in capital projects in progress and Orlando International has \$1.1 billion in construction and renovation projects underway, and WHEREAS, Fort Canaveral and Orlando International Airport have taken steps to remain at the forefront of connectivity by strengthening ground transportation options between the two venues in addition to exploring and developing plans and advocacy for increased access and security, and WHEREAS, the direct and indirect revenue generated from the diverse activities at Port Canaveral and Orlando International have a profound effect on Central Florida's economy with the Airport contributing \$31 billion and the Port contributions totaling more than \$3.5 billion annually. NOW THEREFORE be it resolved that this Joint Resolution be presented in recognition of the collaborative efforts of the Greater Orlando Aviation Authority and the Canaveral Port Authority to pursue the strategic objectives as follows; Improved ground transportation services and enhanced revenue; Improved passenger throughput and security; Increased commercial activities and revenue generation. BE IT FURTHER RESOLVED that the Greater Orlando Aviation Authority and the Canaveral Port Authority jointly pursue improved utilization of the corridor between Port Canaveral and Orlando International Airport for the movement of passengers and goods for the enhanced economic benefit of the region. - State Road 401: Single point of failure for major transportation artery with consequences for cruise passengers and fuel deliver to Central Florida and OIA (40% aviation fuel received for CPA/Vitol.
- Joint state and federal lobbying efforts to enhance freight movements, request additional CBP/TSA officers.
- Possible passenger rail connection in future (TPO has evaluated All Aboard Florida stops in Brevard County and is in early planning of transportation hub at the intersection of 528 and 95 with possible train stop/station there as well.)

**JOINT RESOLUTION:** A joint resolution was read by both Boards' attorneys. Motion was made, seconded and passed to accept the resolution.
