MAYOR'S UPDATE

Citrus Bowl - Mayor Dyer invited everyone to join him, together with the City Commissioners, Orange County Mayor Teresa Jacobs and Florida Citrus Sports, to officially kickoff the reconstruction of the Florida Citrus Bowl with the start of demolition on Wednesday, January 29 at 10 a.m. The reconstruction will transform Orlando's historic venue to usher in a new era of sports, entertainment and events that will build on the City's rich history and ensure a prosperous future for Orlando.

Dr. Martin Luther King, Jr. Holiday - Last week the City observed the Dr. Martin Luther King Jr. holiday with a series of activities coordinated and supported by Orlando's Martin Luther King, Jr. Commission. The Mayor and Commissioners attended numerous events that were made possible by the 24-member Martin Luther King, Jr. Commission. The Commission supported nine successful events, including a candlelight vigil and interfaith service, the Alpha Phi Alpha Drum Major Awards luncheon, the Southwest Orlando Jaycees' MLK Parade, the Pappy Kennedy Prayer Breakfast, and three service projects held on the holiday: "Plant Seedlings for Civil Rights" at Clear Lake Park, a house painting, and a community clean up in Parramore. The final event of the Dr. Martin Luther King, Jr. holiday, entitled *Messages on the Wall*, will be held at the Northwest Community Center on January 29 at 9:30 a.m.

Black History Month - On January 28, the City will kickoff Black History Month with an event in the Rotunda at 5:30 p.m. This event will recognize the contributions and positive influence of African Americans in Orlando, among whom will be former county and city commissioner Mable Butler.

Mayor's City Academy Council Update - The City of Orlando is currently accepting applications for the 2014 session of the Mayor's City Academy. The Mayor's City Academy is a ten-week program that provides citizens a unique opportunity to gain knowledge about their City government. The City is hopeful that it can continue negotiations with Faith Deliverance Temple and come to an agreement that ensures the church can still be successful in moving forward, and also demonstrate a prudent use of taxpayer funds. However, if an agreement cannot be reached, the agenda item will allow staff to proceed with eminent domain.
