REPORTS

Joseph Caesar, Center Manager of the Dr. J.B. Callahan Neighborhood Center reported on behalf of Rodney Williams. Mr. Caesar reported that registration for the Junior Magic basketball league starts this weekend and is hosted at five locations within the City of Orlando serving an estimated six hundred (600) youth. Joe also reported that an NCAA basketball tournament will be held this weekend at the Orlando Downtown Recreation Complex.

John Perrone reported that all eight (8) See Art sculptures have been installed and will be lit each night for residents to enjoy while walking around Lake Eola Park. Other sculptures in the collection are located at the Orlando History Center and the corner of Orange Avenue and Church Street. John also reported that minor renovations are being made at Bill Frederick Park to improve its ADA accessibility, including making one of the cabins ADA accessible

John also informed the Board that park construction will commence at Park of Americas in approximately February, with an expected park opening in Winter of 2014. The site will house the City's first off-leash dog park. Nutter Park, located at the corner of McGuire Blvd. and Bennett Road, was recently renovated and is now being heavily utilized by the neighborhood. He reminded Board members that on February 15, 2014, the City will hold its annual Wetlands Festival in Christmas, Florida.
