

<u>LEGAL DESCRIPTION:</u>

THAT PART OF SECTION 17, TOWNSHIP 23 SOUTH, RANGE 29 EAST, ORANGE COUNTY, FLORIDA, BEING $^{1.}$ MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCE AT THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF SECTION 17, TOWNSHIP 23 SOUTH, RANGE 29 EAST; THENCE S89°12'54"W ALONG THE NORTH LINE OF SAID NORTHWEST QUARTER OF SECTIÓN 17, A DISTANCE OF 385.39 FEET TO THE WESTERLY RIGHT—OF—WAY LINE OF THE 1-4/CONROY ROAD INTERCHANGE AS RECORDED IN OFFICIAL RECORDS BOOK 5578, PAGE 2643 PUBLIC RECORDS OF ORANGE COUNTY, FLORIDA, BEING THE POINT OF BEGINNING; THENCE RUN ALONG SAID WESTERLY RIGHT-OF-WAY LINE THE FOLLOWING THREE (3) COURSES; S56°05'19"E, A DISTANCE OF 175.59 FEET; THENCE S08°41'06"E, A DISTANCE OF 169.28 FEET; THENCE S31°34'00"W, A DISTANCE OF 339.99 FEET; THENCE DEPARTING SAID WESTERLY RIGHT OF WAY LINE, RUN N56°05'19"W, A DISTANCE OF 547.29 FEET TO THE EASTERLY RIGHT—OF—WAY LINE OF ORLANDO—VINELAND ROAD AS RECORDED IN OFFICIAL RECORDS BOOK 5578, PAGE 2643, PUBLIC RECORDS OF ORANGE COUNTY, FLORIDA; THENCE RUN ALONG SAID EASTERLY RIGHT OF WAY THE FOLLOWING THREE (3) COURSES; N33°55'11"E, A DISTANCE OF 7.22 FEET; THENCE RUN N51°30'48"E, A DISTANCE OF 56.17 FEET; THENCE RUN N33°54'41"E, A DISTANCE OF 246.93 FEET TO THE AFOREMENTIONED NORTH LINE OF THE NORTHWEST QUARTER OF SECTION 17; THENCE RUN N89°12'54"E ALONG SAID NORTH LINE, A DISTANCE OF 275.16 FEET TO THE POINT OF BEGINNING.
