## **MINUTES**

A Public Test of Voting Tabulation Equipment was held on Thursday, March 27, 2014 at 10:00 a.m. at the Orange County Supervisor of Elections Office. Those present are listed below:

The Public Test of Voting Tabulation Equipment began at 10:05 a.m. with Orange County Supervisor of Elections staff members Michelle Torres, Sara Osborne and Tom Dougherty briefing those in attendance on the testing procedure for the machines scheduled to be used in the April 8, 2014 District 5 General Election. Eight machines were tested. Members of the Canvassing Board and City staff examined and reviewed the results of the tests and confirmed that in all cases the test results were consistent with the test deck ballots and the test voting on the touch screen voting machines. All types of voting equipment that will be used in the City's General Election were tested including the DS 200s that will be used in the four precincts and for early voting, the M650 High Speed absentee ballot counter which will be used for tabulation of the absentee ballots, and two of the touch screen machines. All machines tested as expected. The Canvassing Board members and staff reviewed the test result tapes and confirmed by their initials or signatures on the tape print-outs that the results were accurate. The Supervisor of Elections staff sealed the test deck into a storage case and the Canvassing Board members and Assistant City Clerk signed the seal. The same test deck will be used to perform the Logic and Accuracy tests on the absentee ballot tabulator on Election Day. The SOE will store the test deck storage case in its vault until then.

Chief Assistant City Attorney Amy lennaco briefly reviewed upcoming election related matters with the Canvassing Board.
