It was moved by Celeste Thomas and seconded by Latria Leek to approve the 20ft x 16x banner roadside along Mills Avenue for the upcoming "Florida Prize in Contemporary Art" show. The motion carried unanimously.

REPORTS

Lisa Early reported that a new City Commissioner, Regina Hill, will soon be representing District 5. Commissioner Hill's first City Council meeting will be on June 2, 2014, replacing Commissioner Daisy W. Lynum. Lisa also reported that budget planning has begun for next fiscal year. The City has struggled to balance its budget without further service cuts or a millage rate increase. City departments will present their budget challenges to City Council on June 9, 2014.

Lisa also reported that Dueling Dragons is a dragon boat team of police officers and youth, created by a community volunteer, Andrea Eliscu. Last night a fundraiser was held to raise funds for the team to travel to Chicago for an international dragon boat race. The team has operated for about three years; we expect to send fifty (50) police officers and youth to Chicago.

Oneka Burnett reported on behalf of Rodney Williams. Oneka stated that the Englewood Neighborhood Center is in the running to receive the Jefferson Award for Public Service. The Lead360 Project is a contest whereby young people present information on how they give back to the community. Highlights of what the Englewood Neighborhood Center girls have accomplished include: one of 27 finalists; completed 20 hours of community service; impacted 19 lives; and have raised close to \$200 to assist senior citizens with groceries by selling lemonade. Oneka also reported that the Children's Choir of Orlando under the direction of Delicia Egerton will perform at the House of Blues on June 8, 2014. The Choir consists of fifteen children from different City recreation sites. Lastly, Oneka reported that summer camps are about 80% filled to capacity and the centers are gearing up for their first day of camp in June.

Peter Effaldana reported on behalf of John Perrone. Peter reported that Bill Frederick Park continues to increase attendance and has become a popular site for 5K fundraising events. The park is cheaper and easier to accommodate 5K runs than streets which require street closures and police. Peter also informed the Board that Lake Eola will again host Lake Eola Movieola on May 30, 2014 on the East Lawn.

Peter also informed the board that Loch Haven Park is in the midst of 23rd Annual Fringe Festival. Loch Haven Park is sponsoring the "Growing up in Orlando before Disney" on May 24, 2014. The event is a reunion of citizens with shared childhood memories of Orlando that come together to dance, eat, drink and reminisces.
