A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, RELATING TO THE STATE OF FLORIDA SPORT DEVELOPMENT PROGRAM **CHAPTER** CREATED BY 2014-167, LAWS FLORIDA: PROVIDING CERTAIN FINDINGS RELATING TO THE CITY'S APPLICATION FOR STATE FUNDS UNDER THE SPORTS DEVELOPMENT PROGRAM; INCLUDING FINDING THAT THE CITY OF ORLANDO SUPPORTS THE APPLICATION FOR STATE FUNDS UNDER THE SPORTS DEVELOPMENT PROGRAM AND THAT THE PROPOSED CITY OF ORLANDO SOCCER STADIUM SERVES A PUBLIC PURPOSE; PROVIDING FOR SEVERABILITY, CORRECTION OF SCRIVENER'S ERRORS, REPEAL OF CONFLICTING RESOLUTIONS, AND AN EFFECTIVE DATE.

WHEREAS, on October 7, 2013, the City Council of the City of Orlando, Florida (the "Orlando City Council") and the governing body of the City of Orlando Community Redevelopment Agency (the "CRA") approved that certain Third Amendment to [the] Orlando/Orange County Interlocal Agreement [relating to the] Performing Arts Center, Events Center, Citrus Bowl, [and] Soccer Stadium, by and between the City of Orlando, Florida (the "City"), the CRA, and Orange County, Florida (the "Interlocal Agreement"); and

WHEREAS, on October 22, 2013, the Board of County Commissioners of Orange County, Florida (the "County Commission") approved the Interlocal Agreement and also adopted County Ordinance Number 2013-20 amending the County Tourist Development Plan to authorize the use of certain proceeds from the County tourist development taxes levied pursuant to section 125.0104, Florida Statutes, and Article IV, Chapter 25, Code of Orange County, Florida, to assist the City in the construction of a major league soccer stadium in Orlando; and

WHEREAS, also on October 7, 2013, the City and Orlando Sports Holdings, LLC, entered into that certain Memorandum of Understanding outlining the terms under which a new soccer stadium would be constructed in Orlando and operated by the City for the purpose of hosting a variety of sports and entertainment events, including home games for a then-proposed Major League Soccer team; and

WHEREAS, in 2013, Major League Soccer, the highest level of professional soccer in the United States, granted the league's 21st franchise to Orlando Sports Holdings, LLC (transacting business in this state and hereinafter known as "Orlando City Soccer Club"); and

WHEREAS, Orlando City Soccer Club is expected to begin play in Major League Soccer during the 2015 season; and

WHEREAS, the City and Orlando City Soccer Club are currently cooperating in the planning, financing, design, and eventual construction of a soccer-specific, but multiuse, public stadium (the "Soccer Stadium"); and

WHEREAS, to help finance the Soccer Stadium, the City is applying for a distribution of state sales taxes generated by sales at the Soccer Stadium pursuant to the Sports Development Program established under section 4, Chapter 2014-167, Laws of Florida (proposed for statutory codification at section 288.11625, Florida Statutes); and

WHEREAS, the purpose of this resolution is to support the City's application under the Sports Development Program by making the necessary findings and verifications required by section 4, Chapter 2014-167, Laws of Florida (specifically, as proposed for statutory codification at subparagraph 288.11625(5)(a)4., Florida Statutes; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, AS FOLLOWS:

SECTION 1. PREAMBLE. The "whereas clauses" contained hereinabove are true and correct and are hereby incorporated into this resolution as if fully set forth hereinafter.

SECTION 2. FINDINGS. We hereby find as follows:

- d. That the City of Orlando is the unit of local government in whose jurisdiction the facility will be located; and
- e. That the City of Orlando supports the application for state funds under the Sports Development Program as established by section 4, Chapter 2014-167, Laws of Florida (and proposed for statutory codification at section 288.11625, Florida Statutes; and

	f. That the proposed Soccer S	Stadium serves a public purpose.
