**STREET RIGHT-OF-WAY UTILIZATION AGREEMENT  
FOR AWNING**

THIS AGREEMENT, made and entered into this \_\_\_\_ day of \_\_\_\_\_, 2014, by and between Edgewater Alpha, LLC, a Florida limited liability company; hereinafter referred to as "EDGEWATER ALPHA", and the City of Orlando, a Florida municipal corporation, hereinafter referred to as "CITY".

**RECITALS:**

WHEREAS, EDGEWATER ALPHA is the owner of certain real estate located at 3005 Edgewater Drive, Orlando, Florida 32804 and within the corporate limits of the City of Orlando, Orange County, State of Florida; and

WHEREAS, EDGEWATER ALPHA desires to locate an overhead awning within the street right-of-way of Edgewater Drive; and

WHEREAS, the CITY will permit the location of the overhead awning within the street right-of-way area pursuant to the terms and conditions set forth herein; and

WHEREAS, EDGEWATER ALPHA is required to enter into this Agreement in order to allow the overhead awning to encroach into the street right-of-way area in compliance with Section 61.203 of the City's Land Development Code; and

NOW, THEREFORE, in consideration of the mutual covenants herein contained, and other good and valuable considerations each to the other, the parties agree as follows:

1. Preamble Incorporated. The foregoing recitals are true and correct and are incorporated herein as part of this Agreement.

2. Encroachment. The CITY hereby grants permission as described in this Agreement for the encroachment of the overhead awning within the right-of-way of Edgewater Drive as depicted on Exhibit "A", attached hereto and incorporated herein, by reference. The encroachment is for the perpetual use, location, operation, maintenance, and repair of the overhead awning within the right-of-way.

3. Reservation of Rights. The CITY reserves the right to utilize the right-of-way for the location, installation, maintenance, and repair of the roadways and any underground utilities located or to be located upon and under the rights-of-way, provided that such use shall not interfere with EDGEWATER ALPHA's right to locate, operate, maintain, and repair the overhead awning in the right-of-way granted herein.

4. Existing Utilities. The location, installation, operation, maintenance and repair of the overhead awning shall not interfere with any existing utilities located within, upon or under the right-of-way.

5. Maintenance and Repair. EDGEWATER ALPHA shall notify the CITY in writing prior to performing any maintenance or repair to the portion of the overhead awning located within the right-of-way. EDGEWATER ALPHA shall obtain approval of the CITY if the repair or maintenance of the overhead awning requires any portion of Edgewater Drive to be closed to pedestrian or vehicular traffic. Upon the repair, or maintenance of the overhead awning, EDGEWATER ALPHA shall restore the right-of-way to its prior condition. All costs for the operation, repair, and maintenance of the overhead awning and for the restoration of the right-of-way shall be paid by EDGEWATER ALPHA, except that EDGEWATER ALPHA shall not be responsible for any damage to the overhead awning or right-of-way caused by the City's negligent repair or maintenance of Edgewater Drive.

6. Indemnification. EDGEWATER ALPHA agrees that it shall indemnify, hold harmless and defend the CITY, its representatives, employees and elected and appointed officials from and against all claims, damages, loss and expenses of any sort including reasonable attorney's fees and costs including appeals, arising out of or resulting from any tort, intentional action, negligent act or omission of Owner, its agents or subcontractors or anyone for whose act or acts any of them may be liable, for actions or omissions occurring in that portion of the street right-of-way area on which the overhead awning is located.

7. Recording. EDGEWATER ALPHA will record this Agreement, at its expense, in the Public Records of Orange County, Florida, where it shall be a covenant running with the land and encumber the property hereinabove described.

8. Controlling Laws

a. This Agreement and the provisions contained herein shall be construed, controlled, and interpreted according to the laws of the State of Florida, and all duly adopted ordinances, regulations, and policies of the CITY now in effect and those hereinafter adopted.

b. The location for settlement of any and all claims, controversies, disputes, arising out of or relating to any part of this Agreement, or any breach hereof, shall be in Orange County, Florida.

c. EDGEWATER ALPHA shall comply with all applicable federal, state, and local laws, ordinances, rules and regulations pertaining to the installation, operation, maintenance, and repair of the overhead awning in the right-of-way.

9. Entire Agreement. This Agreement constitutes the entire Agreement between the parties with respect to the specific matters contained herein and supersedes all previous discussions, understandings, and agreements. Any Amendments to or waivers of the provisions herein shall be made by the parties in writing. No other agreements, oral or otherwise, regarding the subject matter of this Agreement shall be deemed to exist or to bind either party hereto.

10. Severability. If any sentence, phrase, paragraph, provision or portion of this Agreement is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed an independent provision and such holding shall not affect the validity of the remaining portions hereto.

11. Effective Date. The effective date of this Agreement is the date of its execution by the last person to execute it.

12. **Legal Counsel.** EDGEWATER ALPHA acknowledges that it has had ample opportunity to seek and consult with independent legal counsel prior to executing this Agreement, and that either EDGEWATER ALPHA represents and warrants that he has sought such independent legal advice and counsel or has knowingly and voluntarily waived such right.

13. **Attorney's Fees.** EDGEWATER ALPHA agrees that he shall be liable for reasonable attorney's fees incurred by CITY, if CITY is required to take any actions, through litigation or otherwise, to enforce this Agreement.

14. **Negotiation.** The parties to this Agreement acknowledge that all terms of this Agreement were negotiated at arms length and that this Agreement and all documents executed in connection herewith were prepared and executed without undue influence exerted by any party or on any party. Further, this Agreement was drafted jointly by all parties, and no parties are entitled to the benefit of any rules of construction with respect to the interpretation of any terms, conditions or provisions of this Agreement in favor of or against any person or party who drafted this Agreement.

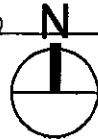
