



**2014-2015 FUNDING AGREEMENT BETWEEN THE CITY OF ORLANDO AND THE  
UNIVERSITY OF CENTRAL FLORIDA RESEARCH FOUNDATION, INC. FOR THE  
BENEFIT OF THE NATIONAL ENTREPRENEUR CENTER**

**THIS AGREEMENT** is entered into this \_\_\_\_\_ day of \_\_\_\_\_ 2014, by and between the **CITY OF ORLANDO**, a Florida municipal corporation established under the laws of the State of Florida (hereinafter referred to as "the City") with a principal address of 400 South Orange Avenue, Orlando, Florida 32801, and the **University of Central Florida Research Foundation, Inc.** (hereinafter referred to as "the Agency"), a Florida 501(c)3 not for profit corporation, direct support organization and instrumentality of the University of Central Florida ("UCF"), for the benefit of **The National Entrepreneur Center** (hereinafter referred to as "NEC"), with a principal address of 12201 Research Pkwy, Ste. 501, Orlando, Florida 32826.

**WITNESSETH**

**WHEREAS**, the Agency has applied to the City for funds in order to provide such services and/or programs as are set forth in Exhibit "A" attached hereto (hereinafter "Services") and incorporated herein by this reference; and

**WHEREAS**, the City has determined that there is a public need for such Services in order to promote the general health, welfare and/or safety of the community and that the provision of such Services is in the best interests of the City, and, to that end, the City has appropriated funds to be donated to the Agency for such Services; and

**WHEREAS**, the Agency has available the necessary qualified and trained personnel, facilities, materials and supplies to perform such Services as set forth in this Agreement; and

**WHEREAS**, the City desires to enter into an agreement with the Agency whereby the Agency will receive and disburse said funds of the City for the purpose of providing the Services in accordance with the terms and conditions set forth herein;

**NOW, THEREFORE**, in consideration of the premises, the mutual covenants, and agreements herein contained, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. **INCORPORATION OF RECITALS.** The recitals set forth above are true and correct and are incorporated herein and made a part of this Agreement.

2. **FUNDING.** The City has appropriated for the period commencing October 1, 2014, and ending September 30, 2015, the total sum of One Hundred Thousand Dollars and No/100 (\$100,000.00) to be administered and disbursed by the Agency solely for the purposes set forth herein (hereinafter "Funds").

3. **PAYMENTS.** Under the terms and conditions of this Agreement, the City agrees to contribute the Funds to the Agency in four (4) equal installments of \$25,000.00 on a quarterly basis for one (1) year, beginning on November 30, 2014, unless otherwise approved and authorized in writing by the Chief Administrative Officer and the Chief Financial Officer of the City. Payments by the City shall be contingent upon the following:

(a) receipt and approval by the City of the reports specified in Paragraph 4 of this Agreement;

(b) inclusion of the audit provisions in sub-recipient agreements as set forth in Paragraph 8 of this Agreement;

(c) compliance with such other reporting and administrative requirements specifically set forth in Exhibit "B" of this Agreement; and

(d) continuing faithful performance of all of the provisions of this Agreement by the Agency and NEC.

4. **PERFORMANCE MEASURES; PROGRESS AND FINANCIAL REPORTS.** The City shall use the Performance Measures listed in Exhibit "C" to determine the effectiveness of the Services provided by the Agency. The Agency agrees to submit progress and financial reports on a quarterly basis in accordance with the schedule in Exhibit "B", which shall be consistent with the Services and Performance Measures, and shall detail the expenditure of the Funds. Failure to comply with the requirement for submission of such reports shall constitute grounds for termination of this Agreement and may result in the ineligibility of the Agency to receive contributions from the City. Completion of reporting requirements and submission of audited financial statements for the prior year are a prerequisite to receipt of funding under this Agreement.

5. **BOARD MEMBER.** The NEC shall provide one (1) voting membership on its board of directors for a City-appointed representative for the duration of this Agreement. The City representative shall be a member of City staff and shall enjoy the same rights and privileges with regard to discussion and voting on issues before the board as other general members of the NEC board.

6. **NONPROFIT STATUS.** The Agency shall maintain its corporate, non-profit status in the State of Florida throughout the term of this Agreement. If the Agency should, during the term of this Agreement, lose its corporate or non-profit status, it shall immediately notify the City within ten (10) days of the event. Upon such an event, the City reserves the right to immediately terminate this Agreement and discontinue distribution of Funds to the Agency.

7. **NONDISCRIMINATION.** The Agency agrees to provide the Services without regard to race, color, creed, sex, age, national origin, disability, sexual orientation or marital status and in compliance with Chapter 57 of the Code of the City of Orlando, Title VII of the Civil Rights

act of 1964 as amended, and any and all other applicable federal, state or local laws, rules or regulations, whether presently existing or hereafter promulgated. The Agency agrees that compliance with this provision constitutes a condition to continued receipt of Funds.

The Agency agrees that all contractors, subcontractors, or others with whom it arranges to provide services to participants or employees in connection with any of its programs and activities are not discriminating against those participants or employees in violation of this provision. Upon receipt of evidence of such discrimination, the City reserves the right to immediately terminate this Agreement.

8. **ACCOUNTING AND AUDIT.** The Agency shall utilize and maintain such records and practices regarding receipts and disbursements of the Funds as to be in accordance with generally accepted accounting principles. All such records shall be open to inspection and audit by the City or by the City's designee during normal business hours during the term hereof and for a period of three (3) years after the termination of this Agreement. Any cost incurred by the Agency as a result of a City audit shall be the sole responsibility of and shall be borne by the Agency. In addition, should the Agency provide any or all of the Funds to sub-recipients, then and in that event the Agency shall include in written agreements with such sub-recipients a requirement that records of the sub-recipient be open to inspection and audit by the City or the City's designee to the same extent as those of the Agency.

9. **MONITORING.** The Agency and NEC shall permit the City to monitor the Services and the Agency's records and facilities, and/or interview the Agency's clients or employees in order to ensure compliance with the terms of this Agreement. The Agency and NEC shall, to assist monitoring of its program, provide to the City or the City's designee access to all client records and such other information as the City may deem necessary.

10. **TERM.** Unless earlier terminated, this Agreement shall remain in effect for the period commencing October 1, 2014 and terminating September 30, 2015.

11. **TERMINATION.** This Agreement may be terminated by either party at any time, with or without cause, upon no less than fifteen (15) days notice in writing to the other party. Said notice shall be delivered by certified mail or in person to the business address of the party upon whom such notice is served. In the event of termination by either party, Agency shall be reimbursed for all costs and all non-cancelable obligations properly incurred that are related to this Agreement through the date of termination.

12. **LIABILITY.** All employees engaged to perform under this Agreement for UCFRF will be UCF employees and therefore, UCF assumes any and all risks of personal injury and property damage attributable to the negligent acts or omissions of UCF and its employees, agents, officers and servants thereof, while acting within the scope and course of their employment by UCF. The City assumes any and all risks of personal injury and property damage attributable to the negligent acts or omissions of the City's officers, employees, servants, and agent thereof, while acting within the scope and course of their employment by the City. UCFRF and the City further agree that nothing in this Agreement shall be construed or interpreted to (1) deny to either Party any remedy or defense available to the Party under the laws of the State of Florida, and (2) comprising the consent of the State of Florida or its agents and agencies to be sued, and (3) a waiver of sovereign immunity of the State of Florida beyond the waiver provided in section 768.28, Florida Statutes.

13. **DEFAULT.** The following shall constitute an Event of Default under this Agreement:

- (a) Agency's or NEC's failure to provide the Services in accordance with the terms and conditions of this Agreement;
- (b) Agency or NEC makes a material representation in any certification or communication submitted by the Agency to the City in an effort to induce the contribution of the Funds or the administration thereof that is later determined by the City to be false, misleading, or incorrect in any material manner; or
- (c) Agency's or NEC's failure to comply with any of the terms and conditions in this Agreement.

Upon the occurrence of any Event of Default, or any other breach of this Agreement, the City shall have the authority to terminate this Agreement and discontinue the Funds and/or exercise all rights and remedies available to it under the terms of this Agreement under statutory law, or under common law. Upon the occurrence of subsection (b), in addition to termination of the Agreement and discontinuation of the Funds, the City may require the Agency to refund all Funds that the City disbursed to the Agency pursuant to this Agreement.

14. **NO WAIVER.** The continued performance by either party hereto, pursuant to the terms of this Agreement, after an Event of Default shall not be deemed a waiver of any rights by the City. Furthermore, the waiver of any default by the City shall in no event be construed as a waiver of rights with respect to any other default, past or present.

15. **CONSTRUCTION; SEVERABILITY.** This Agreement shall be construed in accordance with the laws of the State of Florida. It is agreed by and between the parties that if any covenant, condition or provision contained in this Agreement is held to be invalid by any court of competent jurisdiction, such invalidity shall not affect the validity of any other covenants, conditions or provisions herein contained.

16. **NONASSIGNABILITY.** The Agency may not assign its rights hereunder without the prior written consent of the City. Failure to comply with this section may result in immediate termination of this Agreement.

17. **NO JOINT VENTURE.** It is mutually understood and agreed that nothing contained in this Agreement is intended, or shall be construed, as in any way creating or establishing the relationship as partner or joint ventures between the parties hereto or as constituting the Agency as the agent or representative of the City for any purpose or in any manner whatsoever.

18. **VENUE.** Any litigation occurring as a result of this Agreement shall be held in the courts of Orange County, Florida and shall be governed by the laws of the State of Florida. The Agency agrees to notify the City of an occurrence of any incident or action filed against the agency, such as but not limited to, lawsuits, injuries, or allegations of abuse or neglect.

19. **CORPORATE TABLES.** The NEC agrees that, if it holds any fund raising events during the term of this Agreement at which "corporate tables" are sold, the City shall receive a table

without cost in consideration of the contribution provided to the Agency under this Agreement.

20. **USE OF FACILITIES.** The NEC shall permit the City to use NEC's training rooms and conference rooms on occasion at a date and time acceptable to both parties and at no cost to the City during the term of this Agreement.

21. **INSURANCE.** The NEC shall have in force the following insurance coverage, and shall provide Certificates of Insurance to the Manager of the Economic Development Department, or his/her designee, within ten (10) days of the effective date of this Agreement to verify such coverage. The insurance coverage shall contain a provision which forbids any cancellation, changes or material alterations in the coverage without providing 30 days written notice to the City:

- (a) Commercial General Liability -- The NEC shall provide commercial general liability coverage for all operations including, but not limited to, Contractual, Products and Completed Operations, and Personal Injury. The limits will not be less than \$500,000 Combined Single Limit (CSL) bodily injury and property damage, or its equivalent. The City of Orlando shall be named as an additional insured.
- (b) Commercial Automobile Liability -- The NEC shall provide coverage for all owned, non-owned and hired vehicles utilized in the performance of this Agreement for limits of not less than \$500,000 Combined Single Limit (CSL) bodily injury and property damage, or its equivalent.
- (c) Workers' Compensation -- The NEC shall provide Workers' Compensation coverage for all employees at the site location and, in case any work is subcontracted, will require the subcontractor to provide Workers' Compensation for all its employees. The limits will be statutory for Workers' Compensation and \$100,000 for Employer's Liability.

22. **ENTIRE AGREEMENT.** This Agreement constitutes the entire agreement between the parties hereto with respect to the subject matter hereof; any representations or statement heretofore made with respect to such subject matter, whether verbal or written, are merged herein. No other agreement, whether verbal or written, with regard to the subject matter hereof shall be deemed to exist. This Agreement may only be modified in writing, signed by both parties.

23. **COMMUNITY VENUES SUPPORT.** The Community Venues development and construction projects that the City of Orlando has undertaken, presents the opportunity to make a significant and long-term positive impact in the minority community at large. To accomplish this vision the City created five goals in its "Blueprint." The first and perhaps the most important goal, is to "assist the development and support of local, small and historically disadvantaged businesses as an important aspect of the continuing growth and development of the community."

To support this goal and as part of the core mission, the Agency is required to provide tailored technical assistance and business development/support services to local MWBE businesses that are competing as a short list candidate or have been awarded a Community Venue (CV) contract. These services should be consistent with the Agency's core competency and should be provided without additional fees charged to the client. Businesses preparing for (CV) work or have been awarded (CV) work shall receive priority consideration by the Agency for technical support and

services. The Agency is required to provide information within the quarterly reports that are submitted to the City detailing the technical assistance that has been provided to MWBE businesses.

It is the intent of the City that all future financial support will be predicated on supporting the goals of the Blueprint. Funding will be dependent on how well these services are provided and our ability to receive reports outlining the Agency's success at achieving benchmarks.

23. **MEBA SUPPORT.** The Agency shall give priority consideration for technical support and services to businesses that receive funding under the City's Minority/Women Entrepreneur Business Assistance (MEBA) Program. The NEC shall document the MEBA businesses it provides technical assistance to as part of its reporting requirement set forth in Paragraph 4 of this Agreement.

24. **MEBA ADVISORY BOARD.** The NEC shall designate one representative to serve and participate as a voting member on the City's MEBA Advisory Board for the duration of this Agreement. Once a representative is chosen, the NEC cannot substitute one representative for another without first obtaining approval from the City. The NEC's Board representative must attend any and all scheduled Board meetings and workshops.

25. **NOTICE.** Any notices to be delivered hereunder shall be in writing and be deemed to be delivered when (i) hand delivered to the person hereinafter designated, or (ii) deposited in the United States Mail, addressed to a party at the addresses set forth opposite the party's name below, or at such other address as the applicable party shall have specified, from time to time, by written notice to the other party delivered in accordance herewith:

### **Request for Renewed Funding Of The National Entrepreneur Center**

This request for renewed financial support from *The City of Orlando* is presented by the *National Entrepreneur Center* (NEC) with the assistance of its fiscal agent, *The University of Central Florida Research Foundation* (501c3). The purpose of this request is to renew funding support for the operational management of the National Entrepreneur Center located in Orlando.

As part of a balanced approach to economic development, Central Florida has embraced the collaborative model of small business development and assistance offered by The National Entrepreneur Center. The NEC provides a shared facility that houses a multitude of local non-profit business organization which lowers the operating cost of each resident organization, leverages scarce sponsorship funding, while providing local small businesses with an efficient means of accessing free business coaching and low cost business education at the center. This initiative, now in its 11<sup>th</sup> year of operation, accelerates business capacity and supports a stronger and more diverse economy for our region. The National Entrepreneur Center has established a track record of success in increasing engagement of local entrepreneurs and has attracted national attention for building a model of collaboration that effectively serves the needs of the small business community. We respectfully request the City of Orlando to continue financial support of the operations of our center and our community's collective mission to build a strong and vibrant small business community.

#### **Small Business Support in Orlando**

- Over 90% of the small businesses headquartered in Florida have fewer than 10 employees. (source: Edward Lowe Foundation) It is vital for our region to continue providing an efficient and effective method for serving this massive number of businesses within our region.
- Inc. magazine highlighted Orlando as a hot spot for job growth in companies with less than 100 employees, according to a report by Sure Payroll.
- Techie.com ranked Orlando among its list of the "Most Promising Tech Hubs to Watch in 2014." The article cites Orlando's Creative Village as evidence of a booming digital media industry, low overhead costs compared to other-known tech hubs and its pipeline of talented and creative young professionals.
- Small businesses require continual access to practical education, relevant resources and personal coaching during the critical start up and the growth stages of their businesses. - Partnership opportunities continue to emerge at the NEC due to the synergy and cooperation that exists between the 12 resident organizations. The “shared facility” approach allows for rapid development of programming to serve the diverse and changing needs of our community.
- The Center has assisted in highlighting the opportunities presented by minority certification, and government contracting at the City of Orlando. Ongoing programs are offered to assist businesses in preparing responses to RFPs and competing for local contracting opportunities.
- There is an ongoing need to increase awareness of the variety and depth of support is available at the National Entrepreneur Center, and to increase the number of companies who engage these resources.

### **The National Entrepreneur Center**

By visiting The National Entrepreneur Center, a small businesses owner has a single location to access numerous non-profit business support organizations, which provide free individual coaching, low cost business training, and a variety of business development resources that may otherwise be unaffordable or inaccessible. The guidance, knowledge and connections obtained through a visit to the center provides a small business with practical and timely input that can be applied immediately to address specific needs that may accelerate progress.

### **2013-2014 NEC Highlights**

- The NEC launched a new pilot international trade program and established the “Central Florida International Trade Office”. This office provides local companies with access to an international database containing Exports and Importers within the region, opportunities to network and free business education as it relates to international commerce.
- The NEC in conjunction with a variety of community partners hosted a “Veterans Empowerment Summit” which helped connected over 120 veterans to a variety of community resources including job opportunities, educational assistance, entrepreneurship, medical & housing assistance.
- In 2013-14, the NEC hosted The US Secretary of Commerce, The Assistant Secretary of Homeland Security, The SBA Administrator, Gray Swope, CEO of Department of Economic Opportunity for the State of Florida and Governor Rick Scott.
- Media outreach continues to promote Central Florida, including local radio, television, national speaking engagements, and ongoing local and regional print media appearances.
- In 2013-14 the NEC conducted targeted programming for the City of Orlando’s Main Street Managers and assisted in securing funding for SCORE Orlando to conduct various workshops for main street businesses within the various commission districts of the City.

This cooperative approach enables each service organization to reduce expenses by sharing resources, and reduces duplication, while providing clients with the efficiency of a one-stop center for business support for those who wish to visit the center or from the comfort of their own homes if they choose to view programs via the internet. The NEC provides an efficient model for local organizations to provide relevant support to small businesses across the entire region, while conserving funds and sharing resources.

### **Use of Funds**

Providing a professional “shared facility” in Orlando presents a budget challenge for a non-profit organization, yet a centralized location is essential for serving the entire region efficiently. In addition to the synergy of co-locating the resource partners, each resident organization benefits from a reduced costs by sharing the facility, technology, and overall operational costs. The majority of the NEC budget is dedicated to maintaining the operation of the center which provides training rooms, conference rooms, computers, telephone, and technology, and shared office equipment. The center also provides a marketing platform and outreach that is second to none in promoting Central Florida as a great place to do business.

- The National Entrepreneur Center (NEC) will provide and maintain a single shared facility for the non-profit business support organizations who reside at the center. The center will coordinate scheduling and programming among resident organizations to reduce duplication, insure efficiency, and to leverage shared technology and educational resources.
