RECITALS

- A. City and Tenant entered into Lease Agreement Between City of Orlando and the Health Care Center for the Homeless, Inc. dated November 1, 2004 (the "Lease") for the land and improvements located at 1518 37th Street, Orlando, Florida 32805 (the "Leased Premises").
- B. The Lease provides for a term expiration date of October 31, 2014, having been extended by renewal options all of which have been exercised.
- C. The parties desire to extend the term of the Lease and create additional options to renew, all as set forth in this lease amendment.
- NOW, THEREFORE, in consideration of the premises, mutual promises and covenants contained herein, and other valuable consideration, the receipt and sufficiency of which are acknowledged by each party to the other, the parties hereby agree as follows:
- 1. <u>Recitals</u>. The foregoing Recitals are true and correct and are incorporated herein by reference.
- 2. <u>Lease Extension</u>. The City hereby extends the term of the Lease to and including October 31, 2019, on the same terms and conditions as set forth in the Lease, except to the extent of the modifications provided herein. Additionally, the term of this Lease may be extended upon the mutual agreement of the parties, which may be granted or withheld by either party in that party's sole and absolute discretion for any or no reason, on an annual basis for five (5) individual one (1)-vear terms.
- 3. <u>Representations and Warranties</u>. Each person signing this document on behalf of a party to this agreement represents to the other that he/she has full power and authority to enter into this Lease amendment on such party's behalf, without notice to or consent of any third party.
- 4. <u>Incorporation of Original Lease Terms</u>. All terms and conditions of the Lease not in conflict herewith are incorporated herein by reference and made a part hereof. To the extent there is an express or implied conflict between the terms and conditions of this Amendment and

the original Lease, the terms and conditions hereof shall control.
