# COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM AGREEMENT BETWEEN THE CITY OF ORLANDO, FLORIDA AND PRIMROSE CENTER, INC.

This **CDBG Agreement** (hereinafter the "**Agreement**") is made and entered into by and between the **City of Orlando**, a Florida municipal corporation, with a principal address of 400 South Orange Avenue, Orlando, Florida 32801, (hereinafter referred to as the "City"), and **Primrose Center, Inc.**, a Florida non-profit corporation, with a principal address of 2733 S. Ferncreek Ave., Orlando, FL 32806 (hereinafter referred to as "CENTER" or "Subrecipient").

### WITNESSETH:

**WHEREAS**, the Community Development Block Grant Program ("CDBG") is administered by the United States Department of Housing and Urban Development ("HUD");

**WHEREAS**, the City is an entitlement community that receives CDBG funds awarded under the Housing and Community Development Act of 1974, in furtherance of its goal of promoting community development and improvement of public facilities, as further detailed in the Consolidated Plan for Housing and Community Development Programs 2011-2016;

**WHEREAS**, CENTER is a private non-profit corporation that provides employment training for people with severe disabilities;

WHEREAS, CENTER has requested Forty Seven Thousand Seven Hundred Fifty Dollars (\$47,750.00) in FY 2014-2015 CDBG funds to provide employment training services for fifteen (15) severely disabled individuals (hereinafter referred to as the "Program");

**WHEREAS**, services for adults who meet the Bureau of Census Current Population Reports definition of "severely disabled" are presumed to be low- and moderate- income;

WHEREAS, these services for the "severely disabled" are an eligible activity under the CDBG program in accordance with 24 CFR §570.201(e). It is a limited clientele activity and meets the national objectives of benefitting a limited clientele presumed to be low- and moderate- income as required under 24 CFR §570.200 (a) (2) and 24 CFR §570.208 (a) (2)(A);

WHEREAS, the City has determined that there is a public need to provide these employment training services to benefit these severely disabled citizens, so as to promote the general health, welfare and/or safety of the community, and to that end, the City has allocated CDBG funds to CENTER; and

**WHEREAS**, CENTER has available the necessary qualified personnel, facilities, materials and supplies to perform such services and/or carry out such programs for these severely disabled residents, who are presumed to be low- and moderate- income persons, as defined under the standards of eligibility established by HUD and adjusted annually, a copy of which current 2014 eligibility income levels are attached hereto as **Exhibit "A"** and incorporated herein by reference.

**NOW THEREFORE**, in consideration of the mutual covenants and agreements contained herein, and for other good and valuable consideration, the sufficiency and receipt whereof being hereby acknowledged, the City and CENTER agree as follows:

#### SECTION 1: SCOPE OF SERVICES AND USE OF FUNDS

- 1. **Recitals.** The recitals set forth above are true and correct and are incorporated herein and made a part of this Agreement.
- 2. <u>The Grant.</u> Under the terms and conditions of this Agreement, the City has allocated Forty Seven Thousand Seven Hundred Fifty Dollars (\$47,750.00) in FY 2014-2015 CDBG funds to CENTER towards the project, as defined below. CENTER is required to provide a 25% leverage to these funds. Any funds remaining unexpended or not disbursed to CENTER by the City as of the termination date of this Agreement may be deobligated from this Agreement and made available for other City projects as determined by the City.
- 3. Statement of Work/Program and Project Description. CENTER administers and operates a program known as the "Employment Training for People with Disabilities Program", which is a program that provides employment training focusing on job acquisition, job retention, and enhancement of employment skills, through support and counseling to severely disabled adults. Under this Program, CENTER shall serve approximately 15 adults, who are City of Orlando residents and who are presumed to be low- and moderate-income due to their "severe disability" (hereinafter referred to as the "Project"). Additional CDBG program requirements for the Project are attached as Exhibit "B" and made a part hereof by this reference. The Budget for this Project is attached as Exhibit "C" and made a part hereof by this reference. During the term of this Agreement, CENTER agrees to work diligently towards the completion of the Project and complete the Project by September 30, 2015. If it is determined that CENTER will be unable to provide these services for the term of this Agreement, CENTER must submit a request for an extension to the City for consideration. This request must identify the reasons for the extension and must be accompanied by a proposed project timeline that can be reasonably accomplished. CENTER's failure to work diligently toward completing the Project and incidents of non-performance may result in conditions being placed on the grant funds, suspension of grant funds, or the City may cease disbursing any other funds pursuant to this Agreement so that the City can reallocate the funds for other uses or projects.
- 4. <u>National Objectives and Use.</u> CENTER certifies that the activities carried out with funds provided under this Agreement will meet the CDBG program national objective of benefitting low and moderate- income persons as required under 24 CFR 570.200(a)(2).
- 5. <u>Goals and Performance Measures; Implementation Schedule</u>. CENTER will perform job training services for a total of fifteen (15) severely disabled adults. CENTER's ability to meet a 50% grant expenditure rate after six (6) months of service delivery will be considered as a performance indicator and reflect on the City's determination of non-compliance.
- 6. **Staffing.** CENTER shall assign the following key personnel and staff to this Project:
  - (1) Placement Specialist/Manager.

- 7. **Performance Monitoring**. The City will monitor the performance of CENTER against goal and performance standards required herein. Substandard performance as determined by the City will constitute non-compliance with this Agreement. If action to correct such substandard performance is not taken by CENTER within thirty (30) days after being notified by the City, the City will terminate this Agreement and all funding will end. CENTER must return any unused funds within 5 days of the Housing and Community Development Department Director's written request.
- 8. Expenditure of Funds/ Budget. CENTER shall use the grant proceeds for eligible expenses permitted under the CDBG regulations as set forth in 24 CFR Part 570 and in accordance with the Budget attached hereto as Exhibit "C" and made a part hereof by this reference. Expenditures shall be directly attributable to the provision of the programs and services under the Project. Any changes in budget line items, including additions, must be requested in writing and must be approved by the City's Director of the Housing and Community Development Department before related expenditures can be undertaken. CENTER shall be responsible for any cost overruns above the grant amount of \$47,750.00. CENTER shall not use any CDBG funds for prohibited activities as set forth in 24 CFR \$570.207. CENTER acknowledges and agrees that any funds not used in accordance with permitted CDBG regulations and the Budget must be repaid to the City.
- 9. <u>Term.</u> This Agreement shall be in effect for the period commencing October 1, 2014 and terminating September 30, 2015. Costs may not be incurred after September 30, 2015 without a written amendment to this Agreement. Notwithstanding anything herein to the contrary, CENTER's obligations to the City shall not end until all close-out requirements are completed, including, but not limited to, such things as making final payments, disposing of program assets, and retention of records. Also, notwithstanding the foregoing, the term of this Agreement and the provisions herein shall be extended to cover any additional time period during which CENTER remains in control of CDBG funds or other assets, including Program Income or for any HUD audits requiring repayment of any funds unlawfully spent under this Agreement.

### **SECTION 2: ADMINISTRATIVE REQUIREMENTS**

- 1. <u>Applicable Laws and Regulations</u>. CENTER shall comply with the requirements of the Housing and Community Development Act of 1974, as amended, all CDBG program requirements, 24 CFR Part 570, and other laws and regulations governing the use of these funds, whether set forth herein or not, and any amendments or policy revisions thereto which shall become effective during the term of this Agreement. It is CENTER's responsibility to read, understand, and comply with these laws and regulations. In addition, CENTER shall abide by any and all other applicable federal or state laws, rules, regulations, and policies governing the funds provided under this Agreement, whether presently existing or hereafter promulgated. CENTER shall also comply with all other applicable federal, state or local statutes, ordinances, rules and regulations, including, but not limited to, all applicable provisions of the City's Land Development Code and Building Code.
- 2. <u>Uniform Administrative Requirements and Cost Principles.</u> CENTER shall comply with the uniform administrative requirements specified at 24 CFR §570.502 and §570.610. CENTER also agrees to comply with the provisions of OMB A-110 (implemented at 24 CFR Part 84) or the related CDBG provision, as specified in 24 CFR §570.502(b). CENTER shall comply with the requirements and standards as set forth in Office of Management and Budget ("OMB") Circulars A-122, "Cost Principles for Non-Profit Organizations". These principles shall be applied for all costs incurred

whether charged on a direct or indirect basis. CENTER also agrees to adhere to the accounting principles and procedures required therein, utilize adequate internal controls, maintain necessary source documentation for all costs incurred, and submit an indirect cost allocation plan, if such plan is required. CENTER also agrees to comply with the Program Requirements set forth in **Exhibit "D"** which is attached hereto and made a part hereof by this reference.

- Subcontracting/Third Party Contracts. If CENTER hires contractors, CENTER shall procure all material, property, or services in accordance with the requirements of 24 CFR Part 84, as described in 24 CFR §570.502(b). Third parties may be procured for a variety of services, including but not limited to, construction and rehabilitation services. CENTER shall insure that all subcontracts let in the performance of the Agreement shall be awarded on a fair and open competition basis in accordance with applicable procurement requirements and secure at least three price quotes from qualified contractors. CENTER shall not enter into any subcontract with any entity, agency or individual in the performance of this Agreement without the written consent and approval of the City's Housing and Community Development Director (or designee) prior to execution of the agreement or contract. CENTER agrees to furnish to the City a copy of each third party contract it enters into an agreement with for the performance of work to be undertaken within the scope of this Agreement along with documentation concerning the selection process. Furthermore, CENTER shall incorporate in any and all such contracts with third parties provisions which will obligate each of its subcontractors or partners to comply with all applicable federal, state, and local laws, rules and regulations to be adhered to in accordance with all parts of this Agreement and comply with all affirmative action laws, nondiscrimination requirements, anti-kickback requirements, federal labor standard provisions, and lobbying prohibitions issued by various federal agencies applicable to this CDBG program. CENTER shall require and monitor compliance by all contractors, subcontractors and other third parties. CENTER will monitor all subcontracted services on a regular basis to assure contract compliance. Results of monitoring efforts shall be summarized in the monthly report. The City shall not be obligated or liable hereunder to any party CENTER enters into agreements with for the Project.
- 4. **Records to be Maintained.** CENTER shall maintain all records required by 24 CFR §570.506 and 24 CFR §84.53, as modified by 24 CFR §570.502 regarding records that must be maintained for the Project. Such records shall include but are not limited to:
  - a.) Records providing a full description of each activity undertaken and its CDBG eligibility, including its location; and the amount of CDBG funds budgeted, obligated and expended for the activity;
  - b.) Records demonstrating that each activity undertaken meets one of the national objectives of the CDBG program (i.e. the criteria set forth in 24 CFR §570.208);
  - c.) Records required to determine the eligibility of activities;
  - d.) Records for each activity carried out for the purpose of providing or improving services and programs which is determined to benefit presumed low- and moderate-income severely disabled persons including the total cost of the activity, including both CDBG and non-CDBG funds and the size and income and eligibility of each person or household;

- e.) Records required to document the acquisition, improvement, use or disposition of real property acquired or improved with CDBG assistance;
- f.) Records which demonstrate compliance with the requirements in 24 CFR §570.505 regarding any change of use of real property acquired or improved with CDBG assistance;
- g.) Records that demonstrate compliance with citizen participation requirements;
- h.) Records which demonstrate compliance with requirements in 24 CFR §570.606 regarding acquisition, displacement, relocation, and replacement housing;
- i.) Records documenting compliance with all Fair Housing and Equal Opportunity regulations;
- j.) Financial records that document all transactions and that can be properly documented and audited, as required by 24 CFR Part 570.502 and 24 CFR 84.21 28 and OMB Circular A-110;
- k.) Records and agreements related to lump sum disbursements to private financial institutions for financing rehabilitation as prescribed in 24 CFR §570.513;
- 1.) Other records necessary to document compliance with Subpart K of 24 CFR part 570;
- m.) Copies of all bid documents, bids received, RFPS, RFQs and any other procurement documents;
- n.) Copies of all third party or subcontracts; and
- o.) Detailed records of CENTER's organization, financial and administrative systems, and the specific CDBG-funded project or activities.

Please note that the above descriptions are brief and provide only a summary of the records CENTER is required to maintain, as applicable to the Project. CENTER agrees to consult 24 CFR §570.506 for a detailed description of the required records.

5. Retention of Records. All records must be accurate, complete and orderly. CENTER shall retain all accounting records, financial records, statistical records, supporting documents, source documents to support how CDBG funds were expended and all other documents pertinent to the Project and this Agreement in accordance with the requirements of 24 CFR §84.53 as modified by 24 CFR§570.502, plus a five (5) year retention period. This retention period begins on the date of the submission of the City's Annual Performance and Evaluation Report (CAPER) to HUD in which the activities assisted under the Agreement are reported on for the final time. Notwithstanding the above, if any records are the subject of litigation, a claim or audit, that started before the expiration of the five year period, then such records must be kept until such litigation, claims or audit findings have been resolved or completion and resolution of all of the issues, for a period of five (5) years thereafter. Records for any displaced person must be kept for five (5) years after he/she has received final payment. Records for any real property and equipment acquired with these CDBG funds shall be retained for five (5) years after final disposition.

6. Monitoring and Inspections/Access to Records. All files and records shall be made available for review to the City's Housing and Community Development Department, the City's Office of Internal Audit and Evaluation, Comptroller General, HUD, the Inspector General and/or any of their authorized representatives, who shall have access to and the right to examine any of the said records, documents or papers related to the Project during normal business hours and any other reasonable time requested by the City or HUD. This right also includes timely and reasonable access to CENTER's personnel for the purpose of interviewing and discussion related to said documents. This same right to review and access will be imposed upon any third party or subcontractor and it is CENTER's responsibility to ensure that any contract entered into with third parties contain all necessary clauses and language required by the City and/or HUD to ensure compliance with this Agreement and with all federal, state, and local laws and regulations.

CENTER shall monitor the progress of the Project covered by this Agreement and shall submit appropriate reports to the City. The City shall monitor CENTER's performance and financial and programmatic compliance. CENTER shall allow on-site monitoring of the CENTER facility and this Project on as frequent a basis as the City deems necessary and at any other time that may be required by HUD to determine compliance with CDBG regulations and this Agreement. CENTER shall also furnish and cause each of its own subcontractors, if any, to furnish all information and reports required hereunder and will permit access to its books, records and accounts by the City, HUD, or any other authorized official or designee for purposes of investigation to ascertain compliance with the rules, regulations, and provisions stated herein. This section shall survive termination of this Agreement.

### 7. Audits and Financial Statements.

- (a) CENTER shall provide the City with its annual financial statement within ninety (90) days of the end of its operating year. This financial statement shall be prepared by an actively licensed public accountant.
- (b) In addition, if expending more than \$500,000 of Federal awards during an operating year, CENTER shall comply with the audit provisions contained in OMB Circular A-133, 24 CFR \$84.26 and the Single Audit Act Amendments of 1996 (31 U.S.C. §§7501-7507). Audits shall be conducted annually. CENTER shall submit its annual audit to the City and within one hundred twenty (120) days of the end of CENTER's fiscal year. CENTER must clear any deficiencies noted in the audit reports within 30 days after receipt of any noted deficiencies. In the event the audit shows that the entire funds disbursed hereunder, or any portion thereof, were not expended in accordance with the conditions of this Agreement, CENTER shall be held liable for reimbursement to the City of all funds not expended in accordance with those regulations and Agreement provisions within thirty (30) days after City has notified CENTER of such non-compliance. Any reimbursement by CENTER shall not preclude the City from taking any other action or pursuing other remedies. Failure to comply with these audit requirements constitutes a violation of the Agreement and may result in the withholding of future payments.
- (c) CENTER also agrees to allow the City's Internal Audit and Evaluation Department to conduct any audits or financial monitoring the City feels necessary at any time during the term of this Agreement or pursuant to any HUD request.

- 8. **Program Income.** CENTER shall report all Program Income, as defined at 24 CFR §570.500, in a monthly report to the City's Housing and Community Development Department. Documentation of the receipt of Program Income, such as supporting schedules identifying the project and the source of income, must be submitted to the City within five (5) days of its receipt. Upon expiration or earlier termination of this Agreement, CENTER shall transfer all CDBG Program Income to the City within five (5) days of the expiration or termination. If CENTER receives any Program Income after this Agreement expires or is terminated, CENTER shall immediately remit said Program Income balances to the City as required in 24 CFR §570.503(c) within five (5) days of receipt. If applicable, CENTER shall file reports of Program Income as set forth in the below section entitled "Reports".
- 9. Reports. CENTER shall file reports in accordance with the Reporting Schedule attached as Exhibit "E". CENTER shall provide the City's Housing and Community Development Department with monthly, quarterly, and annual reports concerning the progress of the Project, in the form attached as Exhibit "F". The report shall include the following information: (1) name and address of each client served; (2) narrative statement of the services provided to each client; and (3) such other information as may be considered appropriate by the City, such as client data demonstrating client eligibility including, but not limited to, client name, address, ethnicity, race, gender, age, head of household, income level, or other basis for determining eligibility. CENTER shall also submit the demographic information as to gender and race and income on the Report attached as Exhibit "F". CENTER shall also file a Personnel Activity Report for personnel activities including but not limited to duties performed and time allocated in the form attached hereto as **Exhibit "F-1"**, or on such forms provided by the City. CENTER shall also file and report on such other information as may be considered appropriate by the City. The monthly status reports shall be due on the 10<sup>th</sup> of each month for activities conducted during the preceding month. The quarterly reports are due the 10<sup>th</sup> day of the month following the end of the quarter for March, July, September and December. Annual reports are due by October 31, 2015 for activities conducted during the preceding year - (October 1, 2014 -September 30, 2015).
- 10. **Reversion of Assets.** The use and disposition of property and equipment under this Agreement shall be in compliance with the requirements of 24 CFR Part 84 and 24 CFR 570.502, 570.503, 570.504 and 570.505, as applicable, which include but is not limited to the following:
  - 1. CENTER shall transfer to the City any CDBG funds or Program Income on hand at the time of expiration or termination of this Agreement and any accounts receivable attributable to the use of CDBG funds as required by 24 CFR §570.503 (b)(7); and
  - 2. If this Agreement involves any real property under CENTER's control that was acquired or improved, in whole or in part, with CDBG funds in excess of \$25,000; then the real property:
    - a) shall continue for a period of not less than five years following the expiration of this Agreement to be used to meet one of the CDBG national objectives cited in 24 CFR §570.208; or
    - b) if CENTER fails to use the property in accordance with paragraph a) above, CENTER shall pay the City an amount equal to the current fair market value of the property less any portion of the value attributable to expenditures of non-CDBG

funds for the acquisition or improvement to the property. The payment shall be considered Program Income to the City.

- 11. <u>Indirect Costs</u>. If applicable and requested by the City, CENTER shall develop an indirect cost allocation plan for determining the appropriate allocation of administrative costs and shall submit such plan to the City for approval in a form specified by the City. This indirect cost allocation plan must be submitted before any funds will be disbursed under this Agreement.
- 12. Payment Procedures/Reimbursement of Funds. This is a cost reimbursement agreement. Disbursement of funds under this Agreement may be requested only for necessary, reasonable, and allowable costs described in the Budget, attached hereto as Exhibit "C" and for which CENTER has made payment. The City will disburse funds only after completion of the work and after receipt and approval by appropriate City personnel of a "Request for Reimbursement" which shall be in accordance with the Budget specifying the services performed and expenses incurred. Reimbursements shall be requested no more frequently than once a month and shall be submitted in form and content satisfactory to the City. All requests for reimbursement must be accompanied by adequate billing documentation of payment for eligible expenses (i.e. invoices, receipts, bills from vendors, copies of checks, lien waivers, affidavits, applications, certifications, time sheets, etc...) and other supporting documentation. Requests for reimbursement shall include adequate documentation of expenditures and all other information described in Exhibit "D", attached hereto and incorporated herein by reference. No interest shall be earned on grant proceeds. All requests for reimbursement to the City must be signed by an authorized signatory of CENTER.

Notwithstanding anything herein to the contrary, CENTER shall not request reimbursement from the City under this Agreement for any portion which has been paid from another source of revenue and further agrees to utilize funds available under this Agreement to supplement rather than supplant funds otherwise available

13. <u>Withholding Payments</u>. The City's obligation to reimburse CENTER is conditioned on CENTER's full compliance with this Agreement. A breach of this Agreement is grounds for non-payment by the City.

## SECTION 3: DISPLACEMENT, RELOCATION, ACQUISITION, AND REPLACEMENT OF HOUSING

1. **Displacement, Relocation, Acquisition and Replacement of Housing**. In accordance with 24 CFR §570.606, CENTER shall take all reasonable steps to minimize the displacement of persons as a result of activities funded under this Agreement. Any persons displaced shall be provided with relocation assistance to the extent permitted and required under applicable regulations. CENTER shall comply with 1) the Uniform Relocation Assistance and Real Property Acquisitions Policies Act of 1970, as amended (URA), and the implementing regulations at 49 CFR Part 24 and 24 CFR §570.606(b); 2) the requirements of 24 CFR §570.606(c) governing the Residential Anti-displacement and Relocation Assistance Plan under section 104(d) of the Housing and Community Development Act; and 3) the requirements in 24 CFR §570.606(d) governing relocation policies established by the City. CENTER shall provide all notices, advisory assistance, relocation benefits, and replacement dwelling units as required by said regulations, rules, and documents. CENTER shall provided relocation assistance to persons (families, individuals, businesses nonprofit organizations

and farms) that are displaced as a direct result of acquisition, rehabilitation, demolition or conversion of a CDBG assisted project. CENTER shall comply with 24 CFR §570.606 and shall keep all records demonstrating compliance with these requirements including, but not limited to, those records required in 24 CFR §570.506.

### SECTION 4: PERSONNEL AND PARTICIPANT CONDITIONS

1. <u>Non-Discrimination</u>. In accordance with Section 109 of the Housing and Community Development Act of 1974, no person in the United States shall on the ground of race, color, religion, natural origin, or sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under, any program or activity funded in whole or in part with CDBG funds. CENTER shall comply with 42 U.S.C. §5309, 24 CFR §570.602 and 24 CFR Part 6. CENTER shall at all times comply with sections 104(b), 107 and 109 of the Housing and Community Development Act of 1974, as amended; Title VI of the Civil Rights Act of 1964 (42 U.S.C. §2000d, et seq.) (Non-discrimination in federally –assisted programs); and implementing regulations in 24 CFR Part 1.

CENTER shall also not discriminate on the basis of age under the Age Discrimination Act of 1975 (42 U.S.C. §6101, et. seq.) and the implementing regulations contained in 24 CFR Part 146, or on the basis of disability as provided in Section 504 of the Rehabilitation Act of 1973, and the implementing regulations contained in 24 CFR Part 8. Any contracts entered into by CENTER shall include a provision for compliance with these regulations. CENTER shall keep records and documentation demonstrating compliance with these regulations.

- 2. **Equal Employment Opportunity**. CENTER shall comply with 24 CFR §570.607, Executive Order 11246, as amended by Executive Orders 11375, 11478, 12086, and 12107 (Equal Employment Opportunity), and Executive Order 13279 (Equal Protection of the Laws for Faith Based Community Organizations) and the implementing regulations in 41 CFR Part 60, and the provisions of the Equal Employment Opportunity Clause attached hereto as **Exhibit "G"**, and made a part hereof by this reference. Any contracts entered into by CENTER shall include a provision for requiring compliance with these regulations and will, in all solicitations or advertisements for employees state that is an Equal Opportunity/ Affirmative Action employer. CENTER shall keep records and documentation demonstrating compliance with these regulations.
- 3. <u>Handicapped Accessibility Requirements</u>. CENTER shall comply with the Architectural Barriers Act of 1968 (42 U.S.C. §§ 4151-4157), the Uniform Federal Accessibility Standards, as set forth in 24 CFR §570.614, the Americans with Disabilities Act of 1990 (42 U.S.C. §12131), Section 504 of the Rehabilitation Act of 1973 and the implementing regulations in 24 CFR Part 8, and all state and local laws requiring physical and program accessibility to people with disabilities. Any contracts entered into by CENTER shall include a provision for compliance with these regulations. CENTER shall keep records demonstrating compliance with these regulations.
- 4. <u>Utilization of Minority/Women's Business Enterprises</u>. CENTER will use its best efforts to ensure that minority/women's business enterprises are afforded the opportunity and included for consideration for participation in all construction, supply or service contracts or in the performance of this Agreement. CENTER shall comply with Executive Order 11625, as amended by Executive Order 12007 (Minority Business Enterprises); Executive Order 12432 (Minority Business Enterprise Development); and Executive Order 12138, as amended by Executive Order 12608 (Women's

Business Enterprise). Any contracts entered into by CENTER shall include a provision for compliance with these regulations. CENTER shall keep records demonstrating compliance with this provision.

- 5. <u>Political Activities.</u> CENTER shall comply with 24 CFR §570.207(a)(3) regarding political activities. CDBG funds shall not be used for lobbying or political patronage activities. CENTER further agrees that no funds provided, nor personnel employed under this Agreement, shall be in any way or to any extent be engaged in the conduct of political activities in violation of Chapter 15 of Title V, United States Code (Hatch Act).
- 6. Anti-Lobbying Provision. CENTER shall comply with the requirements set forth in 31 U.S.C. §1352 and implementing regulations at 24 CFR Part 87. CENTER and any contractors who apply or bid for an award of \$100,000 or more shall execute and comply with the "Certification Regarding Lobbying" attached hereto as Exhibit "H" and made a part hereof by this reference. CENTER shall execute the "Certification Regarding Lobbying" and a copy shall be kept in the files of each of the parties of this Agreement.
- 7. <u>Conflict of Interest.</u> In the procurement of supplies, equipment, construction, and services, CENTER shall comply with the conflict of interest rules in 24 CFR §84.42. CENTER shall comply with the conflict of interest provisions contained in 24 CFR §570.611 for those cases not governed by §84.42. Such cases include the acquisition and disposition of real property and the provision of assistance by CENTER to individuals, businesses, and other private entities under eligible activities that authorize such assistance.

The general rule states that no "person" described in §570.611( c) who exercise or have exercised any functions or responsibilities with respect to activities assisted with CDBG funds or who is in a position to participate in a decision making process or gain inside information with regard to these activities, may obtain a financial interest or benefit from a CDBG assisted activity, or have a financial interest in any contract, subcontract or agreement with respect thereto, or the proceeds thereunder, either for themselves or those with whom they have family or business ties, during their tenure of for one year thereafter. The "persons" covered in 24 CFR §570.611(c) include employees, agents, consultants, officers, or elected officials or appointed officials of the recipient, or of any designated public agencies, or of subrecipients (CENTER) that are receiving CDBG funds. CENTER agrees and warrants that it will establish and adopt safeguards to prohibit members, officers, employees and the like from using positions for a purpose that is or gives the appearance of being motivated for private gain for themselves or others with whom they have family, business, or other ties. CENTER shall also keep records supporting requests for waivers of conflicts.

8. Section 3 of the Housing and Urban Development Act of 1968/Equal Opportunity. CENTER shall comply with the provisions of Section 3 of the Housing and Urban Development Act of 1968 (12 U.S.C. §1701u) and its implementing regulations contained in 24 CFR Part 135 regarding economic opportunities for low income persons and the use of local businesses, if applicable. CENTER shall comply with the provisions of the "Section 3 Clause", attached hereto as Exhibit "I" and made a part hereof by this reference, and require all subcontracts to contain a copy of the Section 3 clause. CENTER shall also keep records demonstrating compliance with these regulations, including 24 CFR §570.506(g)(5).

### 9. Faith-based activities.

- (a) Equal treatment of program participants and program beneficiaries. (1) Program participants. Organizations that are religious or faith-based are eligible, on the same basis as any other organization, to participate in the CDBG program. Neither the Federal Government or a State or local government receiving funds under the CDBG program shall discriminate against an organization on the basis of the organization's religious character or affiliation.
- (b) <u>Separation of inherently religious activities</u>. Organizations that are directly funded under the CDBG program may not engage in inherently religious activities, such as worship, religious instruction, or proselytization, as part of the programs or services funded. If an organization conducts such activities, the activities must be offered separately, in time or location, from the programs or services funded under this part, and participation must be voluntary for the program beneficiaries of the HUD-funded programs or services provided.
- (c) Religious Identity. A faith-based organization that is a recipient or subrecipient of CDBG program funds will retain its independence, autonomy, expression of religious beliefs, or religious character. Such organization will retain its independence from federal, state, and local governments, and may continue to carry out its mission, including the definition, practice, and expression of its religious beliefs, provided that it does not use direct CDBG funds to support any inherently religious activities, such as worship, religious instruction, or proselytization. Among other things, faith-based organizations may use space in their facilities to provide CDBG-funded services, without removing or altering religious art, icons, scriptures, or other religious symbols. In addition, a CDBG -funded religious organization retains its authority over its internal governance, and it may retain religious terms in its organization's name, select its board members on a religious basis, and include religious references in its organization's mission statements and other governing documents.
- (d) <u>Beneficiaries</u>. An organization that participates in the CDBG program shall not in providing program assistance discriminate against a program beneficiary or prospective program beneficiary on the basis of religious belief.
- (e) Structures. CDBG funds may not be used for the acquisition, construction, or rehabilitation of structures to the extent that those structures are used for explicitly religious activities. CDBG funds may be used for the acquisition, construction, or rehabilitation of structures only to the extent that those structures are used for conducting eligible activities under this part. Where a structure is used for both eligible and inherently religious activities, CDBG funds may not exceed the cost of those portions of the acquisition, new construction, or rehabilitation that are attributable to eligible activities in accordance with the cost accounting requirements applicable to CDBG funds. Sanctuaries, chapels, or other rooms that a CDBG-funded religious congregation uses as its principal place of worship, however, are ineligible for CDBG-funded improvements. Disposition of the real property after the term of the loan or grant, or any change in use of the property during the term of the grant or loan, is subject to government wide regulations governing real property disposition (24 CFR parts 84 and 85).
- 10. <u>Drug Free Workplace</u>. CENTER will provide a drug-free workplace. CENTER shall comply with the Drug-Free Workplace Act of 1988 and implementing regulations in 2 CFR Part 2429 regarding maintenance of a drug-free workplace. CENTER shall complete and comply with the

"Certification Regarding Drug-Free Workplace Requirements" attached hereto as **Exhibit "J"** and made a part hereof by this reference. CENTER shall ensure that the provisions of the clauses in **Exhibit "J"** are included in all third party contracts, subcontracts, and purchase orders that exceed ten thousand dollars (\$10,000), so that the provisions will be binding upon each subcontractor or vendor. CENTER will complete this certification and a copy shall be kept in the files of each of the parties of this Agreement.

- 11. **Program Requirements.** CENTER agrees to comply and carry out all of its activities in accordance with the program requirements set forth in 24 CFR 570, subpart K.
- 12. Fair Housing Act and Nondiscrimination and Equal Opportunity in Housing under E.O. 11063. CENTER shall comply with the Fair Housing Act (42 U.S.C. §§3601-3620) and implementing regulations at 24 CFR Part 100, Executive Order 11063, as amended by Executive Order 12259 (Equal Opportunity in Housing) and their implementing regulations in 24 CFR Part 107 and shall keep records demonstrating compliance with this provision.
- 13. **Resident Aliens.** CENTER shall comply with the requirements set forth in 24 CFR §570.613 regarding eligibility restrictions for certain resident aliens.
- 14. <u>Debarment and Suspension</u>. CENTER shall comply with the debarment and suspension requirements set forth in 24 CFR §570.609 which requires compliance with 24 CFR Part 5 and 2 CFR Part 2424. CENTER shall not enter into a contract with any person, agency or entity that is debarred, suspended or otherwise excluded from or ineligible for participation in federal assistance programs under Executive Order 12549 or 12689, "Debarment and Suspension," which is made a part of this Agreement by reference. In the event that CENTER has entered into a contract or subcontract with a debarred or suspended party, no CDBG funds will be provided as reimbursement for the work done by that debarred or suspended contractor or subcontractor. CENTER shall keep copies of the debarment and suspension certifications required by 2 CFR Parts 2424 and a copy of the sheet documenting that the federal debarment list was checked.
- 15. <u>Building, Zoning, Orlando City Code, and Permits.</u> CENTER agrees to comply with all laws of the State of Florida and the Orlando City Code. In particular, CENTER shall comply with all applicable building and zoning laws and regulations and obtain all necessary permits for intended improvements or activities for the Project.
- 16. <u>Agreement between City and HUD.</u> CENTER agrees that it shall be bound by the standard terms and conditions used in the CDBG Agreement between the City and HUD, and such other rules, regulations or requirements as HUD may reasonably impose in addition to the conditions of this Agreement or subsequent to the execution of this Agreement by the parties hereto.
- 17. <u>Fees for Use of Facilities.</u> Reasonable fees may be charged for the use of the facilities assisted with CDBG funds, but charges such as excessive membership fees, which have the effect of precluding low- and moderate-income persons for using the facilities, are not permitted.
- 18. <u>Registration</u>. CENTER agrees to maintain a current registration in the federal System for Award Management ("SAM") database (<a href="http://www.sam.gov">http://www.sam.gov</a>) pursuant to the Federal Funding Accountability and Transparency Act, P.L. 109-282, as amended by section 6202(a) of P.L. 110-252.

If CENTER is not currently registered, it must do so within ten (10) days of the date CENTER executes this Agreement. A Dun and Bradstreet Data Universal Numbering System (DUNS) Number (<a href="http://www.dnb.com">http://www.dnb.com</a>) is required for registration. CENTER shall also complete and sign the Affidavit attached hereto as **Exhibit "K"** in conjunction with its execution of this Agreement and provide any supporting documentation, if required.

### **SECTION 5: ENVIRONMENTAL**

- 1. Environmental Review Requirements. In accordance with 24 CFR §570.604 and 24 CFR Part 58, the activities under this Agreement are subject to environmental review requirements. CDBG regulations require the preparation of an Environmental Review Record (ERR) and environmental clearance before funds are expended or costs incurred. City staff will prepare the ERR. CENTER is not required to assume responsibility for an environmental review or assessment of this program pursuant to 24 CFR Part 58, nor responsibility for initiation of an intergovernmental review of this program and its activities (24 CFR §570.604). However, CENTER is required to provide information about its activities in order for the City to comply with its responsibility under 24 CFR Part 58. CENTER shall submit to the City the names and addresses of each person assisted, the proposed activity, and an estimate of cost of the work to be undertaken at least forty-five (45) days prior to commencement of work, if applicable. CENTER also agrees to assist the City in addressing environmental issues that may arise during the City's review process.
- 2. <u>Environmental Protection</u>. CENTER shall comply with all applicable standards, orders or regulations of the Clean Air Act (42 U.S.C. §7401 et. seq.); Section 306 of the Clean Air Act (42 U.S.C. 1857 (h)); Section 508 of the Clean Water Act (33 U.S.C. Section 1368); Executive Order 11738; the Federal Water Pollution Control Act, as amended (33 U.S.C. §1251, et. seq.); EPA regulations pursuant to 40 CFR Part 50; National Environmental Policy Act of 1969; standards and policies relating to energy efficiency contained in the State Energy Conservation Plan issued in compliance with the Energy Policy and Conservation Act; and HUD Environmental Review Procedures at 24 CFR Part 58. Violations shall be reported to the City, HUD and EPA.
- 3. <u>Flood Disaster Protection.</u> CENTER shall comply with the requirements of the Flood Disaster Protection Act of 1973 (42 U.S.C. §4106) and implementing regulations in 44 CFR Parts 59 through 79 in regard to the sale, lease or other transfer of land acquired, cleared or improved under the terms of this Agreement, as it may apply to the provisions of this Agreement.
- 4. **Flood Insurance Program.** Should any construction or rehabilitation of existing structures with assistance provided under this Agreement occur in an area identified as having special flood hazards by the Director of Federal Emergency Management, CENTER agrees to comply with all relevant and applicable provisions of 24 CFR §570.605 concerning the National Flood Insurance Program. CENTER agrees that if any portion of the any property improved in connection with this Project is located in a special flood hazard area that flood insurance will be required by the City and must be provided by the homeowner.
- 5. <u>Lead-Based Paint</u>. Lead-based paint is prohibited in the construction or rehabilitation of any properties assisted under this Agreement. CENTER agrees that any construction or rehabilitation of residential structures with assistance provided under this Agreement shall be subject to HUD Lead-Based Paint Regulations at 24 CFR §570.608, which requires compliance with the Lead-Based Paint

Poisoning Prevention Act (42 U.S.C. §§4821-4846), the Residential Lead-Based Paint Hazard Reduction Act of 1992 (42 U.S.C. §§4851-4856), and implementing regulations at 24 CFR Part 35, of which subparts A, B, J, K, and R apply to the CDBG Program. Such regulations pertain to all HUD-assisted housing and require that all owners, prospective owners, and tenants of properties constructed prior to 1978 be properly notified that such properties may include lead-based paint. Such notification shall point out the hazards of lead-based paint and explain the symptoms, treatment and precautions that should be taken when dealing with lead-based paint poisoning and the advisability and availability of blood lead level screening for children under seven. The notice shall also point out that if lead-based paint is found on the property, abatement measures may be undertaken. The regulations further require that, depending on the amount of Federal funds applied to a property, paint testing, risk assessment, treatment and-or abatement may be conducted. CENTER shall maintain records documenting compliance with these requirements.

6. <u>Historic Preservation</u>. CENTER agrees to comply with the Historic Preservation requirements set forth in the National Historic Preservation Act of 1966, as amended (16 U.S.C. §470) and the procedures set forth in 36 CFR §800, Advisory Council on Historic Preservation Procedures for Protection of Historic Properties, insofar as they apply to the performance of this Agreement. In general, this requires concurrence from the State Historic Preservation Officer for all rehabilitation and demolition of historic properties that are fifty (50) years old or older or that are included on a federal, state, or local historic property list. CENTER shall notify the City CDBG representative immediately upon determining that a property may fall into this category.

### **SECTION 6: DEFAULTS AND REMEDIES**

- 1. **Events of Default.** It shall constitute an Event of Default under this Agreement if CENTER fails to comply with any term of this Agreement or any of the following:
  - a.) failure to comply with any of the rules, regulations or provisions referred to herein or governing CDBG awards, including, but not limited to, 24 CFR Parts 570 or such statutes, laws, regulations, executive orders, and HUD guidelines, policies or directives as may become applicable at any time;
  - b.) fails to comply with any of the terms contained in this Agreement and such failure continues for a period of thirty (30) days following notice thereof given by the City to CENTER;
  - c.) failure to fulfill in a timely and proper manner its obligations under this Agreement:
  - d.) ineffective or improper use of funds provided under this Agreement;
  - e.) submission by CENTER at any time of any material representation in any certification, report or communication the City that is determined by the City to be false, incomplete, misleading, or incorrect in any material manner;
  - f.) if CENTER does not disclose to the City, upon demand, the name of all persons with who CENTER has contracted or intends to contract with for the construction or management of any portion of the Project, including contracts for services and/or labor; or

g.) if any other default occurs under any of the grant documents executed by CENTER in connection with this grant by the City (herein the "Grant Documents") which is not elsewhere specifically addressed herein and such default is not cured within the applicable cure period set forth in the grant documents, or if there is no cure period set forth, then within five (5) days following the date of notice to CENTER thereof.

Notwithstanding any of the forgoing provisions to the contrary, if CENTER has failed to cure any default within (5) days prior to the expiration of any applicable cure period, the City may, at its sole option, cure such default, provided, however, that the City shall be under no duty or obligation to do so.

- 2. <u>No Waiver.</u> Failure of the City to declare a default shall not constitute a waiver of any rights by the City. Furthermore, the waiver of any default by the City shall in no event be construed as a waiver of rights with respect to any other default, past or present.
- 3. Remedies/ Suspension and Termination. If CENTER fails to comply with any term of this Agreement or upon the occurrence of any Event of Default or any other breach of this Agreement, the City may suspend or terminate this Agreement, in whole or part, without notice, and withhold all funding, terminate all payments, and/or exercise all rights and remedies available to it under the terms of this Agreement, the Grant Documents, under statutory law, equity or under common law. If the City terminates this Agreement due to CENTER's breach of this Agreement, CENTER shall forfeit to the City all unexpended monies provided under the Agreement. At the City's discretion, CENTER may also be required to refund all CDBG funds awarded by the City. The City may also exercise any one or more of the actions contained in 24 CFR §85.43 (a)(1-5). The City may also terminate this Agreement for convenience in accordance with 24 CFR §85.44.

All remedies shall be deemed cumulative and, to the extent permitted by law, the election of one or more remedies shall not be construed as a waiver of any other remedy the City may have available to it.

### **SECTION 7: INDEMNIFICATION AND INSURANCE**

- 1. <u>Indemnification</u>. CENTER shall defend, indemnify and hold harmless the City from and against any and all liability, claims, demands, damages, expenses, fees, fines, penalties, suits, proceedings, actions and costs of actions, including attorney's fees, whether or not suit is filed and if suit is filed, attorney fees and costs at all trial and appellate levels, of any kind and nature arising or growing out of or in any way connected with CENTER's performance or non-performance of this Agreement or because of or due to the existence of the Agreement itself.
- 2. <u>Environmental Indemnification.</u> CENTER shall indemnify and hold the City harmless from any claim arising from, or in any way related to, the environmental condition of the Project, including, but not limited to, the cost of investigating, defending, and/or negotiating to a satisfactory conclusion claims made by environmental regulatory agencies, as well as all cleanup and property maintenance requirements imposed by any agency with lawful jurisdiction over the Project. This indemnification shall run from the time of initial discovery of any such adverse environmental condition and shall not be construed to commence only upon realization by the City of an actual

pecuniary loss as a result of such adverse environmental condition. The existence of this indemnification agreement shall not be construed as an indicia of ownership, management or control of the Project by the City and CENTER hereby recognizes and acknowledges that the City is not an owner or manager of the Project and does not exert any control thereupon. Notwithstanding anything herein to the contrary, this indemnification provision shall survive the termination of this Agreement

- 3. <u>Insurance</u>. Without limiting CENTER's indemnification, CENTER shall maintain in force at all times during the performance of this Agreement all appropriate policies of insurance hereinafter described, concerning its operations. Certificates with valid and authorized endorsements, evidencing the maintenance and renewal of such insurance coverage shall be delivered to the City prior to execution of this Agreement. The City shall be given notice in writing at least thirty (30) calendar days in advance of cancellation or modification of any policy of insurance. The City, its officers and employees shall be named as an additional named insured on all policies of liability insurance.
  - a.) All policies of insurance shall be in a company or companies authorized by law to transact insurance business in the State of Florida. In addition, such policy shall provide that the coverage shall be primary for losses arising out of CENTER's performance of the Agreement. Neither the City nor any of its insurers shall be required to contribute to any such loss. The required certificate shall be furnished prior to execution of this Agreement.
  - b.) At least thirty (30) calendar days prior to the expiration of any of the above referenced insurance policies, CENTER shall provide the City with evidence of the renewal of said insurance policies in a form satisfactory to the City.
  - c.) The policies and insurance which may be required by the City include:
    - 1. <u>Commercial General Liability Insurance.</u> Commercial general liability insurance to include, but not be limited to bodily injury and property damage coverage. The policy's limit liability amount shall not be less than Five Hundred Thousand Dollars (\$500,000) per person/per occurrence for bodily injury to, or death to one or more than one person and not less than One Hundred Thousand Dollars (\$100,000) per occurrence for property damage.
    - 2. <u>Workers' Compensation Coverage.</u> Workers' Compensation insurance for all of its employees in an amount and with coverage to meet all requirements of the laws of the State of Florida.
    - 3. <u>Flood Insurance</u>. Flood insurance as required under applicable HUD regulations.
    - 4. <u>Business Automobile Liability Insurance.</u> Automobile liability insurance coverage in the minimum amount of Five Hundred Thousand Dollars (\$500,000) per occurrence for BI/PD, including owned, hired and non-owned vehicles regardless of number of passengers transported.

- 5. <u>Employee Fraud Insurance</u>. Sufficient insurance to protect from loss due to fraud, theft, and physical damage and shall purchase a bond or insurance covering all employees for theft or fraud.
- 6. <u>Bonding and Insurance requirements.</u> Bonding and insurance requirements of 24 CFR 84.31 and 84.48.

### **SECTION 8: MISCELLANEOUS PROVISIONS**

- 1. **Assignment.** CENTER shall not assign or transfer any interest in this Agreement without the prior written consent of the City.
- 2. <u>No Grant of Vested Rights.</u> This Agreement shall not be construed as granting or assuring or vesting any land use, zoning, development approvals, permission or rights with respect to property owned by CENTER.
- 3. <u>Independent Contractor</u>. Nothing in this Agreement is intended to, or shall be construed in any manner, as creating or establishing the relationship of master/servant, principal/agent, employer/employee or joint venture partner between the City and CENTER. The City shall be exempt from payment of all Unemployment Compensation, FICA, retirement, life and/or medical insurance and Worker's Compensation Insurance as CENTER is an independent contractor. CENTER agrees and acknowledges that it shall be responsible for and shall pay any and all applicable compensation, insurance and taxes, including but not limited to federal income taxes and Social Security on the salary of any positions funded in whole or in part with CDBG funds.
- 4. <u>Severability.</u> This Agreement shall be construed in accordance with the laws of the State of Florida. It is agreed by and between the parties that if any covenant, condition, provision contained in this Agreement is held to be invalid by any court of competent jurisdiction, such invalidity shall not affect the validity of any other covenants, conditions or provisions herein contained and all other parts shall nevertheless be in full force and effect.
- 5. <u>Entire Agreement/Modification</u>. This Agreement constitutes the entire Agreement between the parties hereto with respect to the subject matter hereof. Any representations or statements heretofore made with respect to such subject matter, whether written or verbal, are merged herein. This Agreement may only be modified in writing, signed by both of the parties hereto.
- 6. <u>Notices.</u> Whenever by the terms of this Agreement, notice is to be given to either party, such notice shall be in writing and shall be hand delivered or sent by certified mail, return receipt requested, postage prepaid to:

### **EXHIBIT "B"**

### **Additional Program Requirements**

- 1. Center shall administer an employment training program known as the "Employment Training for People with Disabilities" for severely disabled adults who are City residents as described in this Agreement. Center shall provide services under this Agreement for approximately 15 eligible persons as set forth by HUD and the CDBG Program.
- 2. Center shall at all times maintain facilities in conformance with all applicable codes, licensing, and other requirements for the operation of a community facility.
- 3. Center will accept applications and perform eligibility determinations. Only adults whos are severely disabled as defined by the Bureau of Census Current Population Reports and who are City residents will be eligible to receive these services.
- 4. Center shall ensure that the numbers, background, and qualifications of the Center staff are appropriate for the services provided and at least meet the minimum standards established by the pertinent licensing bodies.
- 5. All costs eligible for CDBG reimbursement offered by Center under the Program shall only include costs directly related to the provision of the service under this Project as described in this Agreement.
- 6. The City's CDBG funds shall be expended only for the items indicated in **Exhibit "C"** provided such expenditures are directly attributable to the services under the Program and provided to eligible residents, residing within the City limits and income eligible as defined by HUD.
- 7. Center shall complete detailed work write-ups of the services to be performed, including estimated costs and material to be used, if applicable. Center will monitor the work to ascertain that services are proceeding properly and satisfactory. Center will ensure that the expenses are reasonable, and the services are completed properly. In addition, Center shall maintain case files, including applications and all documentation of eligibility, work write-ups, the assistance agreement between the client and Center, documentation on all necessary licenses and permits, site visits and final reports, invoices and checks. Center shall maintain these records in accordance with general record-keeping requirements set forth in this Agreement.

## EXHIBIT "D" PROGRAM REQUIREMENTS

Subrecipient, in addition to the terms set forth in the Agreement, shall operate the Project funded through the City's Community Development Block Grant Program according to the following guidelines:

- 1. Any equipment, furnishings and any other usable item purchased with the City's CDBG Program contribution to Subrecipient for use in the Project shall be kept on an inventory and shall be made available to the City's Housing and Community Development Department for disposition upon termination of the City's CDBG assistance to Subrecipient.
- 2. Subrecipient hereby agrees to maintain accounting systems with internal controls to safeguard the U.S. Department of Housing and Urban Development (HUD) Community Development Block Grant (CDBG) funds and assets, provide for accurate financial data, promote operational efficiency, and foster compliance with generally accepted accounting principles (GAAP) in accordance with 24 CFR Part 84 Administrative Requirements for Grants and Cooperative agreements with Institutions of Higher Education, Hospitals, and other non-profit organizations, and Federal OMB Circular A-110, Uniform Administrative Requirements-Grants and Agreements with Institutions of Higher Education, Hospitals and Other Nonprofit Organizations.
- 3. Subrecipient's accounting records must adequately identify the receipt and expenditure of all CDBG funds for each budget line item. There must be a separate accounting for each budgetary allocation as approved by the City's Housing and Community Development Department. Cash receipts and expenditures from other sources must be accounted for separately from CDBG funds; therefore, if Subrecipient maintains a common account for both CDBG and other funds, the accounting system must provide for the clear and easy identification of CDBG funds.
- 4. Accounting and related records of Subrecipient shall comprise the following as a minimum:
  - a. <u>Voucher system</u> All supporting documentation, such as purchase orders, invoices, receiving reports, requisitions.
  - b. <u>Books of Original Entry</u> Cash receipts and disbursements journal, general ledger. Chart of Accounts – Listing of accounts must be maintained in the accounting system.
  - c. <u>Personnel Records</u> A separate personnel file shall be maintained for each CDBG project employee. As a minimum, the file shall contain a resume of the employee, a description of duties assigned, and a record of the date employed, rate of pay at time of employment, subsequent pay adjustments, and documentation supporting leave taken by the employee.
  - d. <u>Attendance Records</u> Attendance records (individual time sheets) shall be maintained for all personnel paid with CDBG funds that are involved in operating the Project. This applies to part-time as well as full-time personnel. In addition to the accounting for daily attendance, the type of leave taken (annual, sick or other), shall be disclosed. Daily attendance records must support budgetary charges for payroll purposes.
  - e. <u>Payroll Records</u> Formal payroll records supporting cash disbursements to employees shall be maintained. All time sheets or personal activity reports must be signed by the employee and the employee's supervisor. Such records shall disclose each employee's

name, job, title, social security number, date hired, rate of pay, and all required deductions for tax purposes. Timely payments must be made of FICA taxes, including the required employer matching costs, and of income tax withheld from employees. All charges for payroll purposes shall be in accordance with the Budget submitted to the City's Housing and Community Development Department. In addition, salaries and wages of employees chargeable with more than one (1) grant program and/or other funding sources will be supported by appropriate time distribution records. Actual time distribution records shall be available for review by the Housing and Community Development Department at monitoring visits.

- f. <u>Checking Accounts</u> A monthly bank reconciliation shall be conducted by Subrecipient. All checks, stubs, etc. shall be pre-numbered and accounted for, including all voided checks. Check stubs, canceled checks, and deposit slips must be readily available for audit purposes.
- g. <u>Purchasing Practices</u> Purchasing practices shall be at the very least in accordance with 24 CFR §84. Subrecipient must provide documentation indicating how all vendors, contractors, minority and/or women owned businesses are given an opportunity to participate.
- h. <u>Inventories</u> Subrecipient, as are all CDBG program sub-grantees, is advised to maintain adequate safeguards against loss by theft or physical deterioration of any inventories of office supplies, equipment, or other items purchased with CDBG funds.
- Property Records Subrecipient is required to maintain formal subsidiary records to control all CDBG program project property and equipment. Such records shall disclose the acquisition and subsequent disposition of all property. An annual inventory should be conducted and the books should reflect the actual value of property on hand at the end of the year.
- 5. Subrecipient should maintain records in an orderly manner, with separate identification for different Federal fiscal periods. Records must be protected from fire or other perils, and if stored in a location other than the project site, shall be readily accessible to the City's Housing and Community Development Department staff, the Inspector General, and HUD officials and others who may be authorized to examine such records. Failure to do so may constitute a default of this agreement resulting in suspension of reimbursement until said documentation is submitted.

## **EXHIBIT "E" Reporting Schedule**

- A. Subrecipient shall submit a monthly status report to the City's Housing and Community Development Department no later than ten (10) days after the last day of any month in which services assisted through the Community Development Block Grant Program have been provided. Failure to provide the monthly status report within the ten (10) day period will trigger a withholding of payment of subsequent reimbursements.
- B. Subrecipient shall maintain client data demonstrating client eligibility for services provided. Such data shall include client name, address, number of persons in the household and household income. Such information shall be made available to City and/or HUD monitors or their designees for review upon request. Subrecipient understands that client information collected under this contract is private and the use or disclosure of such information, when not directly connected with the administration of the City's or Subrecipient responsibilities with respect to services provided under this contract, is prohibited by the U.S. Privacy Act of 1974 unless written consent is obtained from such person receiving services, and in the case of a minor, that of a responsible parent/guardian. Income qualification information is not required for presumed benefit/limited clientele projects.
- C. Upon fifteen (15) days notice by the City's Housing and Community Development Department, Subrecipient shall provide the information requested by the City for submission of performance or other reports to HUD.
- D. Between the required monthly status reporting dates, events may occur which have significant impact upon the project or program. In such cases, Subrecipient shall inform the City's Housing and Community Development Department as soon as the following types of conditions become known:
  - 1. Problems, delays or adverse conditions, which may materially affect the ability to attain program objectives, prevent the meeting of time schedules and goals, or preclude the attainment of project work units by established term periods. This disclosure shall be accompanied by a statement of the assistance needed to resolve the situation.
  - 2. Favorable development or events, which will enable meeting time schedules and goals sooner than anticipated or producing more work units than originally projected.

### Method of Payment:

Payments shall be made on the basis of completed services and submission of documentation as outlined in this Agreement between the City and Subrecipient. Subrecipient shall submit monthly requests for reimbursement to the City's Housing and Community Development Department in accordance with the following:

1. The City's Housing and Community Development Department shall authorize the reimbursement of Subrecipient for actual expenditures outlined in the budget as expressed in **Exhibit "C"** of this Agreement, except that the Housing and Community Development Director, or her designee, may approve a variance with regard to variable costs. CENTER's ability to meet a 50% grant

- expenditure rate after six (6) months of service delivery will be considered as a performance indicator and reflect on the City's determination of non-compliance.
- 2. Expenses incurred by Subrecipient will not be authorized for reimbursement by the City's Housing and Community Development Department if such expenses cannot be documented by receipts, invoices or other appropriate documentation and information. Furthermore, all requests for reimbursement submitted by Subrecipient to the City's Housing and Community Development Department shall not be reimbursable by the City if such expenditures were not expended directly for the provision of services and activity delivery costs to benefit the persons in accordance with this Agreement.
- 3. Provided that the reimbursement requests are complete and undisputed, the City's Housing and Community Development Department shall authorize reimbursement of approved expenditure requests within thirty (30) days of receipt of such requests.
- 4. The monthly reimbursement requests shall include:
  - a. Name and address of each client receiving services.
  - b. CDBG costs to be reimbursed, shown as labor, materials, other costs, including copies of invoices, and checks in payment.
  - c. Brief description of services undertaken during the month for which reimbursements are being requested.
  - d. Total cost of services
  - e. Timesheets showing tenths of hours where work has been done by Subrecipient and staff detailing daily total hours worked as requested and described for reimbursement under this Agreement.
  - f. If applicable, if outside contractors have done the work, submit the contractor's invoices for reimbursement. These should include an itemization of the work done, the total cost for labor and materials, the number of hours on the job, and the rate per hour agreed to on the project.

# EQUAL EMPLOYMENT OPPORTUNITY CLAUSE FOR SUBRECIPIENTS AND THEIR CONTRACTORS AND SUBCONTRACTORS STANDARD SOLICITATION FOR BID AND CONTRACT LANGUAGE

### A. <u>Equal Opportunity Clause</u>:

Subrecipient agrees that it will incorporate or cause to be incorporated into any contract for construction work, or modification thereof, as defined in the regulation of the Secretary of Labor 41 CFR Chapter 60, which is paid for in whole or in part with funds obtained from the Federal Government or borrowed on the credit of the Federal Government pursuant to a grant, contract, loan insurance, or guarantee or undertaken pursuant to any Federal Program involving such grant, contract, loan insurance, or guarantee, the following equal opportunity clause:

- 1. The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, or national origin. The contractor will take affirmative action to ensure that applicants are employed, and that employees are treated during employment without regard to their race, color, religion, sex, or national origin. Such action shall include, but not be limited to, the following: employment, upgrading, demotion or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided setting forth the provisions of this nondiscrimination clause.
- 2. The contractor will, in all solicitations or advertisements for employees placed by on or behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, or national origin.
- 3. The contractor will send to each labor union or representative of workers with which the contractor has a collective bargaining agreement or other contract or understanding, a notice to be provided advising the said labor union or workers' representatives of the contractor's commitments under this section, and shall post copies of the notice in conspicuous places available to employees and applicants for employment.
- 4. The contractor will comply with all provisions of Executive Order 11246 of September 24, 1965, and of the rules, regulations, and relevant orders of the Secretary of Labor.
- 5. The contractor will furnish all information and reports required by Executive Order 11246 of September 24, 1965, and by rules, regulations, and orders of the Secretary of Labor, or pursuant thereto, and will permit access to its books, records, and accounts by the administering agency and the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.
- 6. In the event of the contractor's noncompliance with the discrimination clauses of this contract or with any of the said rules, regulations, or orders, this contract may be canceled, terminated, or suspended in whole or in part and the contractor may be declared ineligible for further government contracts or Federally assisted construction contracts in accordance with procedures authorized in

Executive Order 11246 of September 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rules, regulations, or orders of the Secretary of Labor, or as otherwise provided by law.

7. The contractor will include the portion of the sentence immediately preceding paragraph (1) and the provisions of paragraphs (1) through (7) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Secretary of Labor issued pursuant to Section 504 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each subcontractor or vendor. The contractor will take such action with respect to any subcontract or purchase order as the administering agency may direct as a means of enforcing such provisions, including sanctions for noncompliance; provided, however, that in the event a contractor becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction by the administering agency, the contractor may request the United States to enter into such litigation to protect the interests of the United States.

The applicant further agrees that it will be bound by the above equal opportunity clause with respect to its own employment practices when it participates in Federally assisted construction work; <u>provided</u>, that if the applicant so participating is a State or local government, the above equal opportunity clause is not applicable to any agency, instrumentality, or subdivision of such government which does not participate in work on or under the contract.

The applicant agrees that it will assist and cooperate actively with the administering agency and the Secretary of Labor in obtaining the compliance of contractors and subcontractors with the equal opportunity clause and the rules, regulations, and relevant orders of the Secretary of Labor, that it will furnish the administering agency and the Secretary of Labor such information as they may require for the supervision of such compliance, and that it will otherwise assist the administering agency in the discharge of the agency's primary responsibility for securing compliance.

The applicant further agrees that it will refrain from entering into any contract or contract modification subject to Executive Order 11246 of September 24, 1965, with a contractor debarred from, or who has not demonstrated eligibility for, government contracts and Federally assisted construction contracts, pursuant to the Executive Order and will carry out such sanctions and penalties for violation of the equal opportunity clause as may be imposed upon contractors and subcontractors by the administering agency of the Secretary of Labor pursuant to Part II, Subpart D of the Executive Order. In addition, the appliance agrees that if it fails or refuses to comply with these undertakings, the administering agency may take any or all of the following actions: cancel, terminate, or suspend in whole or in part this grant (contract, loan, insurance, guarantee); refrain from extending any further assistance to the applicant under the program with respect to which the failure or refund occurred until satisfactory assurance of future compliance has been received from such applicant; and refer the case to the Department of Justice for appropriate legal proceedings.

### **EXHIBIT "I"**

### **SECTION 3 ECONOMIC OPPORTUNITY**

#### **SECTION 3 CLAUSE**

- A. The work to be performed under this contract is on a project assisted under a program providing direct Federal financial assistance from the Department of Housing and Urban Development ("HUD") and is subject to the requirements of Section 3 of the Housing and Urban Development Act of 1968, as amended, 12 U.S.C. §1701u. The purpose of section 3 is to ensure that to the greatest extent feasible, opportunities for training and employment be given to low income residents of the Project area and contracts for work in connection with the Project be awarded to business concerns which are located in or owned in substantial part by persons residing in the area of the Project.
- B. The parties to this contract will comply with the provisions of said Section 3 and the regulations issued pursuant thereto by the Secretary of HUD set forth in 24 CFR Part 135, and all applicable rules and orders of the Department issued thereunder as evidenced by the execution of this contract. The parties to this contract certify and agree that they are under no contractual agreement or other disability which would prevent them from complying with these requirements.
- C. Subrecipient will send to each labor organization or representative of workers with which it has a collective bargaining agreement or other contract or understanding, if any, a notice advising the said labor organization or workers' representative of his commitments under this Section 3 Clause and shall post copies of the notice in conspicuous places available to employees and applicants for employment or training. The notice shall describe the Section 3 preference, shall set forth minimum number and job titles subject to hire, availability of apprenticeship, and training positions, the qualifications for each, the name and location of the persons taking applications for each of the positions, and the anticipated date the work shall begin.
- D. Subrecipient will include this Section 3 Clause in every subcontract for work in connection with the Project and will, at the direction of the applicant for or recipient of Federal financial assistance, take appropriate action pursuant to the subcontract upon a finding that Subrecipient is in violation of the regulations issued by the Secretary of Housing and Urban Development, 24 CFR Part 135. Subrecipient will not subcontract with any agency where it has notice or knowledge that the latter has been found in violation of regulations under 24 CFR Part 135, and will not let any subcontract unless the agency has first provided it with a preliminary statement of ability to comply with the requirements of these regulations.
- E. Subrecipient will certify that any vacant employment positions, including training positions, that are filled (1) after the contractor is selected but before the contract is executed, and (2) with persons other than those to whom the regulations of 25 CFR part 135 require employment opportunities to be directed, were not filled to circumvent the contractor's obligations under 24 CFR part 135.

    - 2. Subrecipient's policy of maintaining a drug-free workplace;
    - 3. any available drug counseling, rehabilitation, and employee assistance programs; and
    - 4. the penalties that may be imposed upon employees for drug abuse violations occurring in the workplace;
  - C. Making it a requirement that each employee to be engaged in the performance of this grant be given a copy of the statement required by paragraph (A);
  - D. Notifying the employee in the statement required by paragraph (A) that, as a condition of employment, the employee will:
    - 1. Abide by the terms of the statement; and
    - 2. Notify the employer in writing of his or her conviction for a violation of a criminal drug statute occurring in the workplace no later than five calendar days after such conviction;
  - E. Notify the City's Housing and Community Development Department and/or the U.S. Department of Housing and Urban Development in writing within ten (10) calendar days after receiving notice under subparagraph (D) (2) from an employee or otherwise receiving actual notice of such conviction. Employers of convicted employees must provide notice, including position title, to every grant officer or other designee on whose grant activity the convicted

- employee was working, unless the Federal agency has designated a central point for the receipt of such notices. Notice shall include the identification number(s) of each affected grant;
- F. Taking one of the following actions, within 30 calendar days of receiving notice under subparagraph (D) (2), with respect to any employee who is so convicted:
  - 1. Taking appropriate personnel action against such an employee, up to and including termination, consistent with the requirements of the Rehabilitation Act of 1973, as amended; or
  - 2. Requiring such employee to participate satisfactorily in a drug abuse assistance or rehabilitation program approved for such purposes by a federal, state, or local health, law enforcement, or other appropriate agency;
- G. Making a good faith effort to continue to maintain a drug-free workplace through implementation of paragraphs (A), (B), (C), (D), (E), and (F).
- 2. Subrecipient shall insert in the space provided on the attached "Place of Performance" form the site(s) for the performance of work to be carried out with the grant funds (including street address, city, county, state, zip code and total estimated number of employees).
