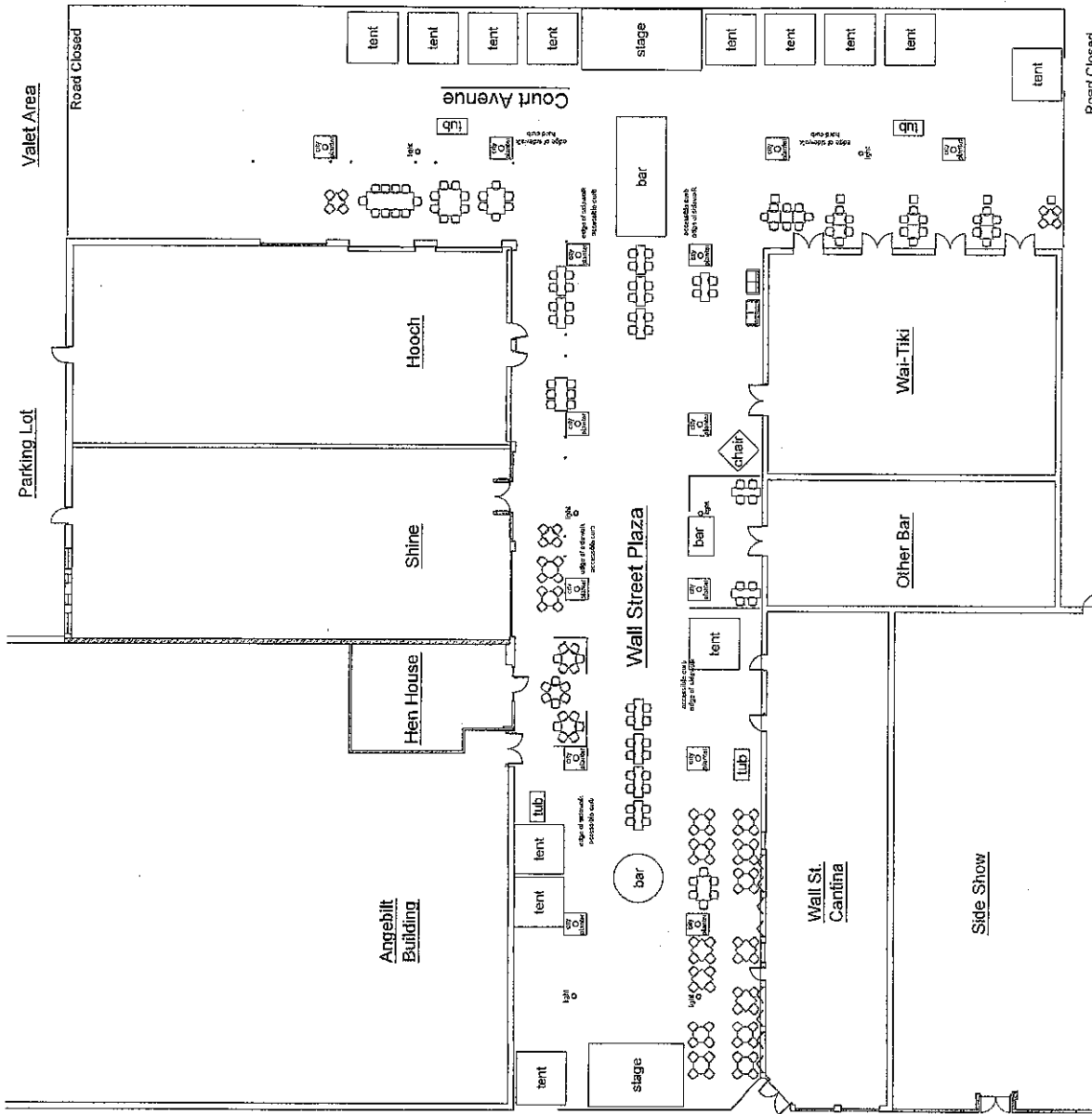

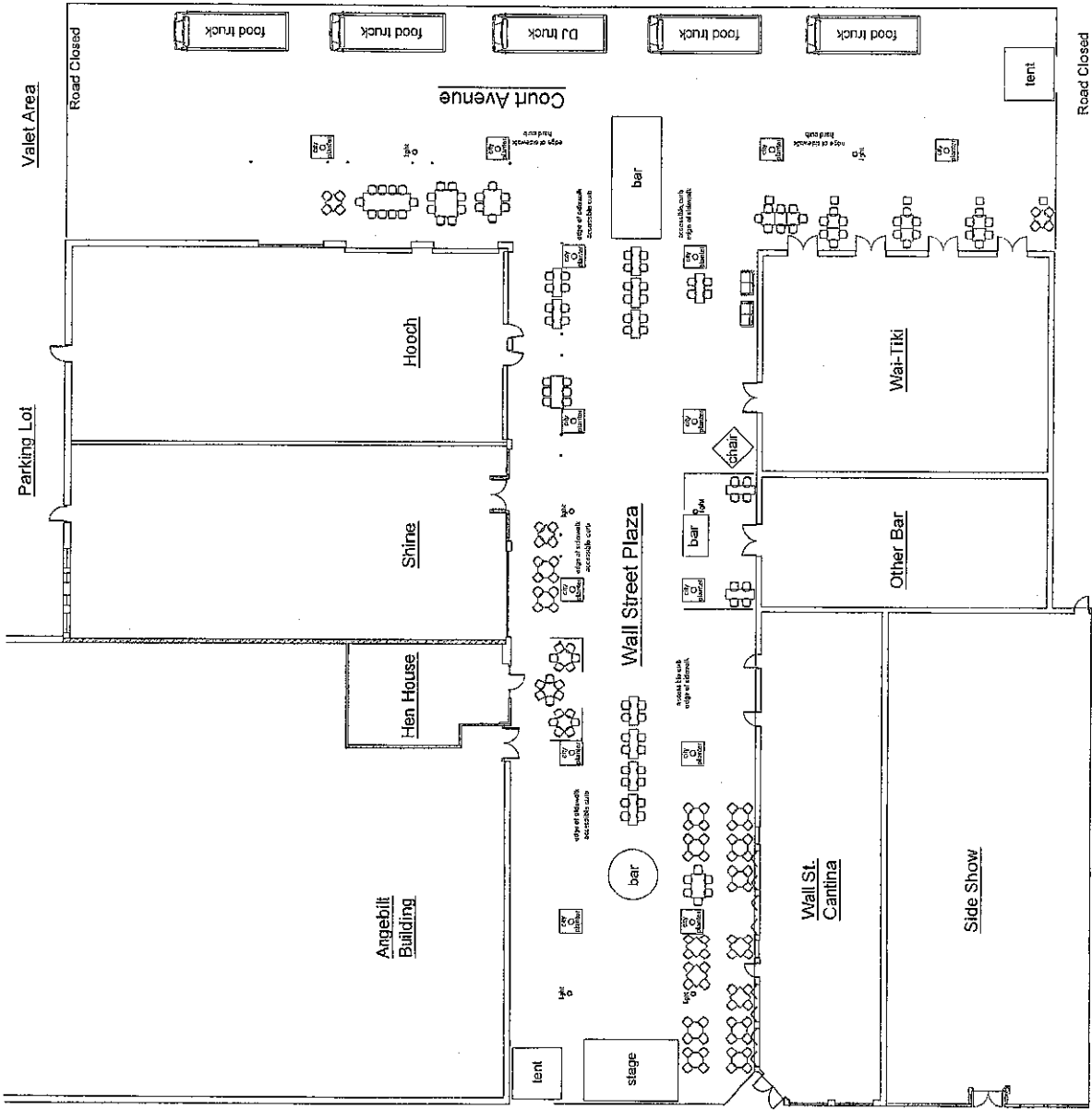

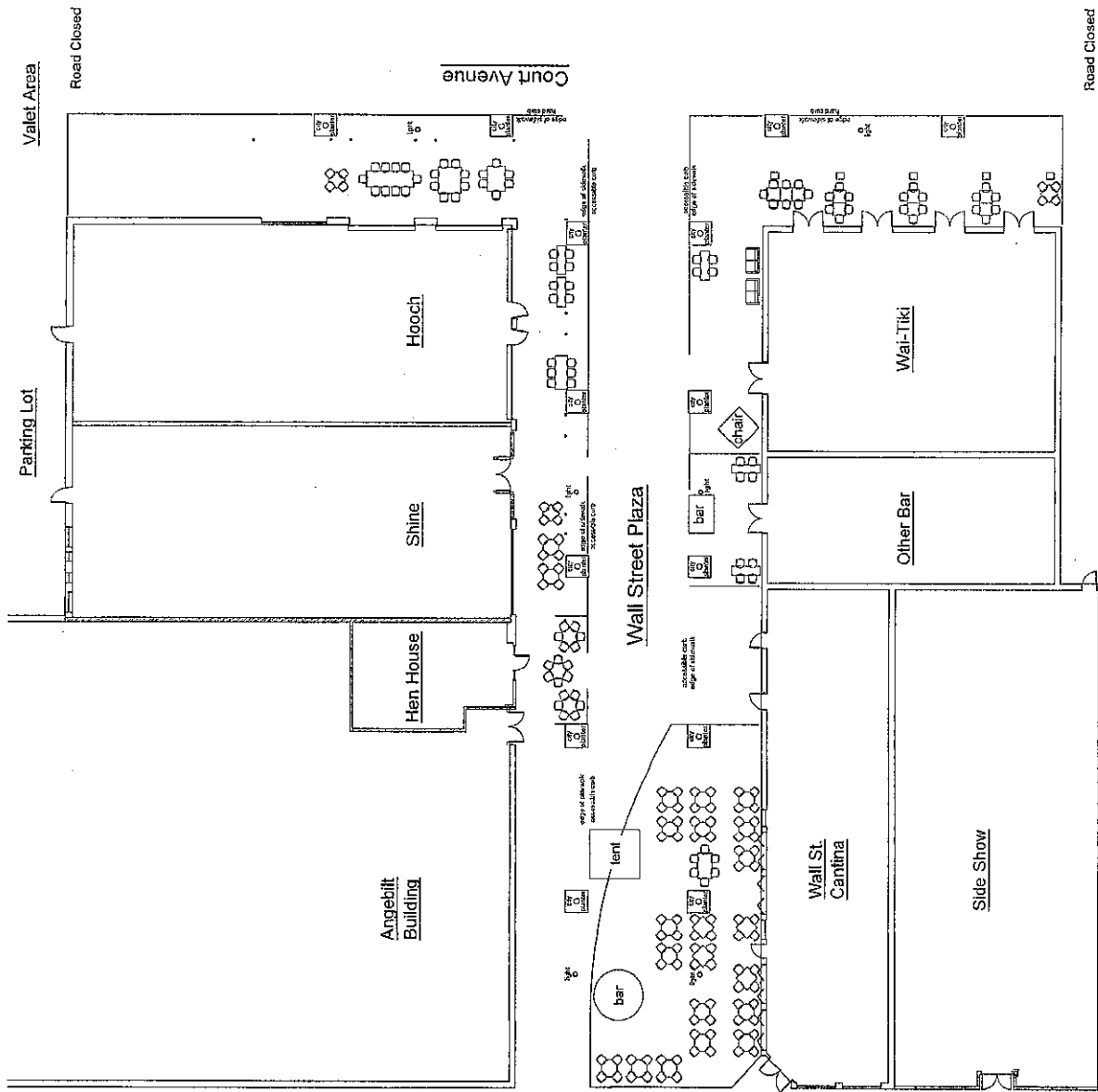

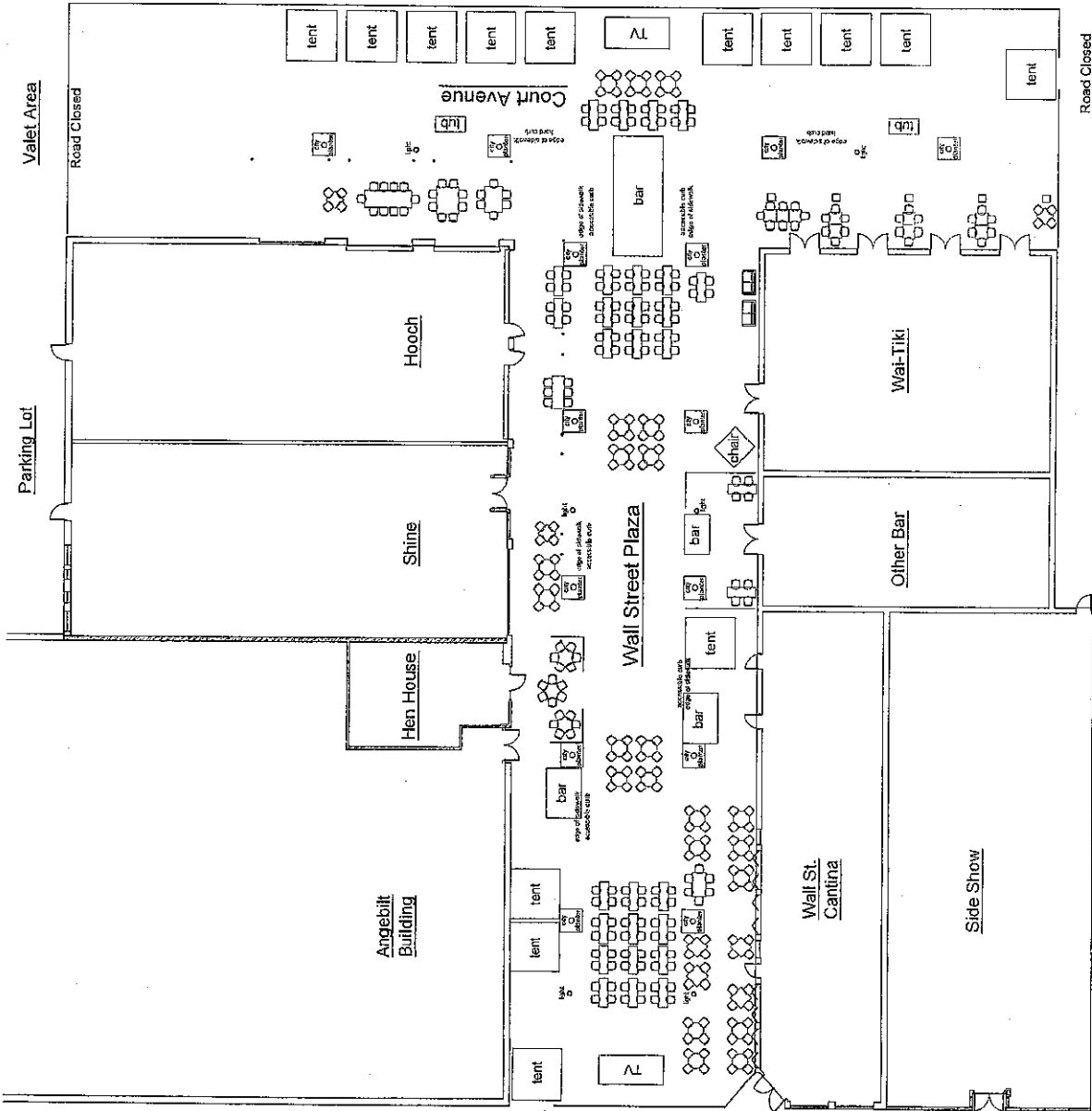


**B** Weekend Setup with Food Trucks

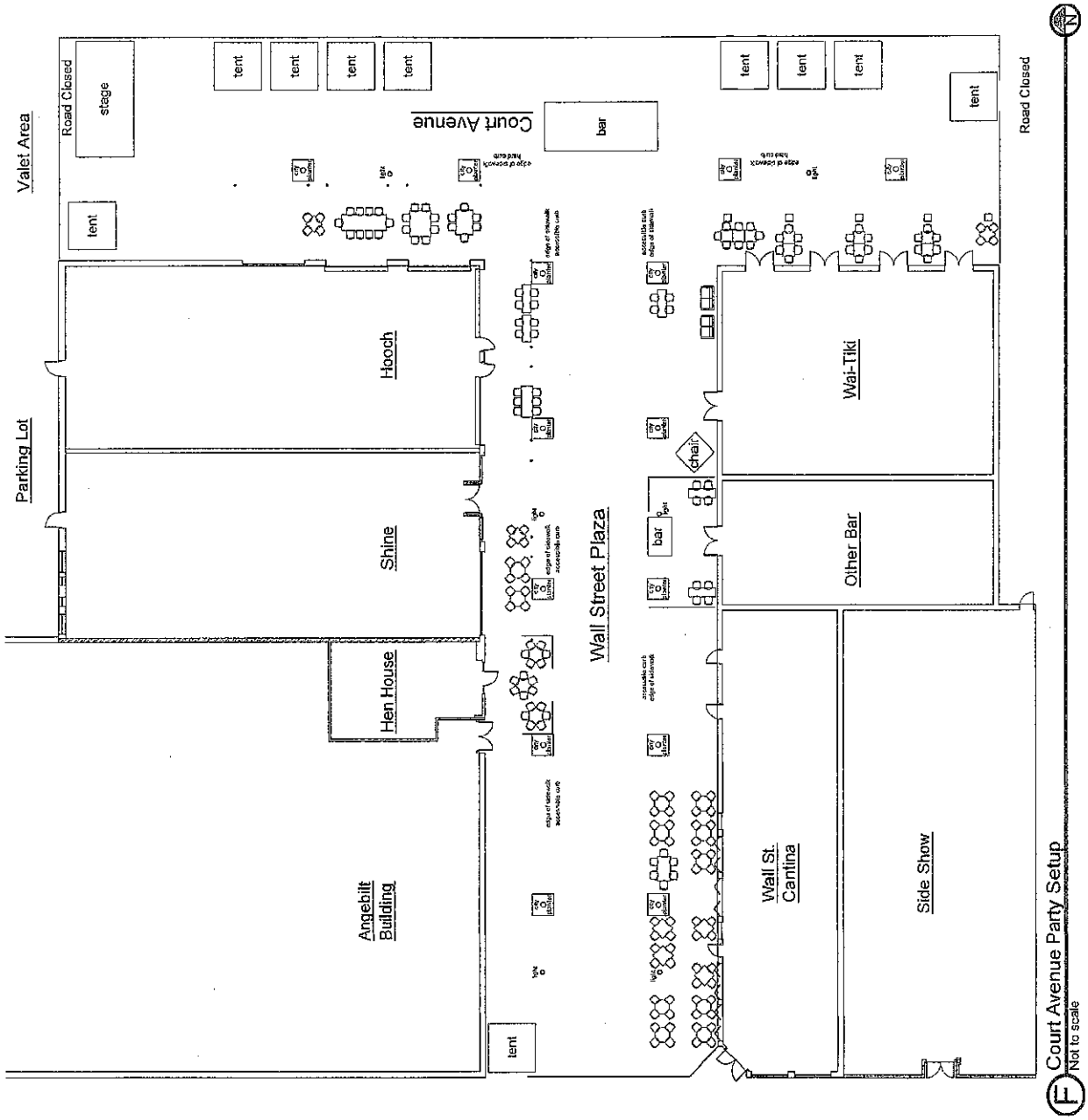
