The meeting called to order by David Medley at 10:07 a.m.

Craig Cook from Attain, Inc. presented a summary of their proposal to request \$133,531 from the City of Orlando's State Housing Initiatives Partnership (SHIP) Program FY 2014-2015. The funds would be used as follows: (1) add two bedrooms and one bath to their existing residential home at 514 Ventura Ave.; (2) add one bedroom and one bath to their existing residential home at 4635 Carmel St.; and (3) add two bedrooms and one bath to their existing residential home at 5114 Barnegat Point Rd. Committee members had received a copy of the complete application prior to the meeting.

A question and answer session was conducted by the Committee members and Mr. Cook regarding the proposed development projects. Tonie Lawson McNealy will schedule a meeting with Craig, Jim Burnett and herself to further review and discuss any potential impact resulting from the substantial improvement threshold at the Ventura property.

Mr. Burrell Motioned to approve the project of adding bedrooms and bathrooms to three existing residential homes as presented and Mr. Forbes seconded the Motion. Motion carried 7-0.

Mr. Medley advised that the minutes and recommendation to accept the project of adding bedrooms and bathrooms to three existing residential homes would be presented to the City Commission for approval in January or February 2015.

Mr. Medley coordinated with the present committee members that future Housing Committee meetings will be held on the first Monday of each month at 11:00 a.m. if there is a project to discuss. A schedule will be distributed to all members. Also, an Executive Summary and the applicant's Proposal will be provided to the committee members at least two weeks prior to the meeting for their review.

The meeting was adjourned at approximately 10:35 a.m.
