

Dear Lee, We at Tampa Crane and Body are your single source distributor for Heil original equipment sales, parts, warranties and repairs for the City of Orlando. We are offering you a discount of 6% off of factory fleet pricing for Heil parts. We also will deliver parts once a week at no additional charge.

Our labor rate for the City of Orlando is \$90.00 per normal labor hour and \$135.00 for overtime repairs, both at our Facility or the City's. Service calls are charged \$1.60 per mile travelled to the City, and on return. Labor charge starts at time of technicians departure from Tampa Crane and Body, and return to our facility.
