

BEGIN AT THE NORTHWEST CORNER OF LOT 1, NARCOOSSEE COMMERCENTER, AS RECORDED IN PLAT BOOK 73, PAGE 1, PUBLIC RECORDS OF ORANGE COUNTY, FLORIDA; RUN THENCE S89°55'33"E ALONG THE NORTH LINE OF SAID LOT 1, NARCOOSSEE COMMERCENTER, A DISTANCE OF 1481.83 FEET TO THE NORTHEAST CORNER OF SAID LOT 1, NARCOOSSEE COMMERCENTER, SAID POINT BEING A POINT ON THE WESTERLY LINE OF TRACT "F", VISTA LAKES VILLAGES N-16 & N-17 (WINDSOR) AS RECORDED IN PLAT BOOK 57, PAGES 77 THROUGH 85, PUBLIC RECORDS OF ORANGE COUNTY, FLORIDA; THENCE S30°16'24"E ALONG THE EAST LINE OF SAID LOT 1, NARCOOSSEE COMMERCENTER AND ALONG SAID WESTERLY LINE OF TRACT "F", A DISTANCE OF 330.00 FEET TO THE SOUTHEAST CORNER OF SAID LOT 1, NARCOOSSEE COMMERCENTER; THENCE N89°55'33"W ALONG THE SOUTH LINE OF SAID LOT 1, NARCOOSSEE COMMERCENTER, A DISTANCE OF 1481.83 FEET TO THE SOUTHWEST CORNER OF SAID LOT 1, NARCOOSSEE COMMERCENTER, SAID POINT BEING A POINT ON THE EASTERLY RIGHT OF WAY LINE OF NARCOOSSEE ROAD; THENCE N30°16'24"W ALONG THE WEST LINE OF SAID LOT 1, NARCOOSSEE COMMERCENTER AND ALONG SAID EASTERLY RIGHT-OF-WAY LINE OF NARCOOSSEE ROAD A DISTANCE OF 330.00 FEET TO THE POINT OF BEGINNING.
