

BEGIN at the Southwest corner of said Lot 1; thence run N29°08'15"W along the West line of said Lot 1, for a distance of 565.30 feet to the South line of Lot D1, said UNIVERSAL CITY FLORIDA LOT 2A REPLAT; thence N77°25'12"E along said South line, for a distance of 193.24 feet to the Southeast corner of said Lot D1; thence run the following courses and distances along the East line of said Lot D1: N12°34'48"W, 340.66 feet to the point of curvature of a curve concave Westerly having a radius of 612.00 feet and a chord bearing of N14°10'01"W; thence Northerly along the arc of said curve through a central angle of 03°10'26" for a distance of 33.90 feet to the point of tangency; N15°45'14"W, 66.09 feet; N14°16'08"W, 178.03 feet to a point on a non-tangent curve concave Easterly having a radius of 750.00 feet and a chord bearing of N11°41'27"W; thence Northerly along the arc of said curve through a central angle of 05°27'02" for a distance of 71.35 feet to a point of compound curvature of a curve concave Easterly having a radius of 2520.00 feet and a chord bearing of N08°07'13"W; thence Northerly along the arc of said curve through a central angle of 01°41'26" for a distance of 74.35 feet to the point of reverse curvature of a curve concave Westerly having a radius of 2494.00 feet and a chord bearing of N08°15'30"W; thence Northerly along the arc of said curve through a central angle of 01°58'00" for a distance of 85.61 feet to the point of reverse curvature of a curve concave Easterly having a radius of 1970.00 feet and a chord bearing of N06°43'59"W; thence Northerly along the arc of said curve through a central angle of 05°01'03" for a distance of 172.52 feet to the point of tangency; N04°13'27"W, 243.83 feet to the point of curvature of a curve concave Westerly having a radius of 180.00 feet and a chord bearing of N14°15'03"W; thence Northerly along the arc of said curve through a central angle of 20°03'11" for a distance of 63.00 feet to the point of tangency; N24°16'38"W, 38.80 feet to the Northeast corner of said Lot D1 and a point on a non-tangent curve concave Northwesterly having a radius of 2080.00 feet and a chord bearing of N49°28'25"E; thence run the following courses and distances along the Northerly, Easterly and Southeast lines of said Lot 1 of ROYAL PACIFIC RESORT FIRST ADDITION: Northeasterly along the arc of said curve through a central angle of 22°08'02" for a distance of 803.52 feet to the point of reverse curvature of a curve concave Southeasterly having a radius of 1020.00 feet and a chord bearing of N64°42'33"E; thence Northeasterly along the arc of said curve through a central angle of 52°36'17" for a distance of 936.49 feet to the point of compound curvature of a curve concave Southwesterly having a radius of 40.00 feet and a chord bearing of S40°48'16"E; thence Southeasterly along the arc of said curve through a central angle of 96°22'07" for a distance of 67.28 feet to the point of reverse curvature of a curve concave Easterly having a radius of 2663.00 feet and a chord bearing of SO4°24'29"W; thence Southerly along the arc of said curve through a central angle of 05°56'38" for a distance of 276.26 feet to the point of tangency; S01°26'10"W, 398.87 feet; S38°17'48"W, 54.65 feet to a point on a non-tangent curve concave Northwesterly having a radius of 425.00 feet and a chord bearing of S23°22'10"W; thence Southwesterly along the arc of said curve through a central angle of 44°20'24" for a distance of 328.90 feet to the point of tangency; S45°32'22"W, 400.68 feet to the point of curvature of a curve concave Northeasterly having a radius of 315.00 feet and a chord bearing of S28°11'38"E; thence Southeasterly along the arc of said curve through a central angle of 147°28'01" for a distance of 810.74 feet to a non-tangent line; thence S11°54'32"E, 65.22 feet; S48°10'00"W, 1270.11 feet to the POINT OF BEGINNING.






