Discussion and Motions:

Brian Ferrier took the following actions:

- 1) Introduced himself.
- 2) Advised the Advisory Committee the meeting would be recorded.
- 3) Announced the date, time and purpose of the Committee meeting.

- 5) Asked all attendees to sign the sign-in sheet.

- 1) Introduced herself as chairperson for the Proposal Selection Committee.
- 2) Called the meeting to order at 11:10 a.m.
- 3) Advised the Committee that a quorum is established.
- 4) Asked all Committee members and others introduced themselves.
- 5) Explained to the Committee an overview of Sunshine Law, Public Records Act and City Policy and Procedure, as related to the Advisory Committee Meetings.
- 6) Turned meeting over to Procurement & Contracts Division representative.

Brian Ferrier took the following actions:

- 1) Announced all attendees signed the sign-in sheet.
- 2) Announced that the meeting was publicly posted more than 48 hours in advance.
- 3) Briefly discussed City Policy & Procedure 121.1 Organization & Policy / Meetings, City Policy & Procedure 133.1

- 4) Explained to the Committee an overview of Sunshine Law, Public Records Act and City Policy and Procedure, as related to the Advisory Committee Meetings. Advised Committee Members must keep proposals confidential and protected for 30 days after opening.
- 5) Advised the Committee that their proposal copies are to be returned once the Committee adjourns the final Committee meeting. Any marks, comments, etc. on the proposal copies will become public record.
- 6) Advised all discussion in Committee Meetings must be factual and information based on submittals.
- 7) Presented the Committee with an overview of the rules of Committee.
- 8) Advised the Committee that the proposals were verified to be in compliance with minimum mandatory qualifications.
- 9) Advised the Committee to evaluate proposals according to evaluation factors published in the solicitation. Each member must independently evaluate each proposal using the evaluation criteria in the solicitation.
- 10) Advised the Committee will follow Robert's Rules of Order during the meeting.
- 11) He announced that Procurement had completed reference checks. He reported all references were satisfactory and available for review.
- 12) Advised that Proposer presentations would not be required.
- 13) Announced the names of the Proposers.
 - a. Arthur J. Gallagher
 - b. Brown & Brown of Florida, Inc
- 14) Turned the meeting over to the Committee Chair.

Karen Zito introduced Dawn Chin Shue and asked her to present the M/WBE Participation.

Dawn Chin Shue took the following actions:

- 1) Reported to the committee a recap of M/WBE participation and City goals.
- 2) Indicated Proposals which included a MWBE Participation Plan. (Attached is the MWBE Participation Summary)
- 3) Answered Committee members question regarding MWBE.

Brief discussion - No Proposers had Veteran participation in their submittals.

Discussion ensued regarding the proposals. The committee asked Raymond Scullian to present Risk Management technical expertise regarding Insurance Broker Services.

Discussion ensued regarding the evaluation process. Each voting Committee Member completes scoring sheet individually. Scoring must be based on proposal submitted, not potential services or products not originally covered in proposal. Any negotiations will only be for items such as terms and contract language, not additions or modifications of the proposal. Results will be totaled by Procurement and presented to the Committee.

A motion was made by Laurie Botts, seconded by Christopher McCullion, to start the scoring process. There was no discussion and the motion passed.

Brian Ferrier distributed the scoring sheet to each voting member to individually score and rank each proposer. Results were tabulated on a ranking form by Brian Ferrier. The ranking is as follows (ranking tally and scoring sheets are attached):
