AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, AMENDING THE ORLANDO HEALTH PLANNED DEVELOPMENT ORDINANCE TO ADD APPROXIMATELY 0.53 ACRES OF LAND TO THE PLANNED DEVELOPMENT ZONING DISTRICT. SUCH LAND BEING GENERALLY LOCATED NORTH OF W. UNDERWOOD ST., EAST OF S. LUCERNE TERRACE, SOUTH OF COLUMBIA ST., AND WEST OF S. KUHL AVE.; PROVIDING A CONFORMING LEGAL DESCRIPTION, PD PLANNING AREA MAP. AND PD LAND USE PLAN: PROVIDING FOR SEVERABILITY, CORRECTION OF SCRIVENER'S ERRORS, AND AN EFFECTIVE DATE.

WHEREAS, on March 31, 2014, the City Council of the City of Orlando, Florida (the "Orlando City Council"), adopted City Ordinance #2013-45, amending and restating the planned development zoning district ordinance for approximately 65 acres of land generally located north of Kaley Street, south of Gore Street, east of Atlanta Avenue, and west of Orange Avenue (hereinafter referred to as the "Orlando Health PD Ordinance"); and

WHEREAS, section 9 A. 6., of the Orlando Health PD Ordinance provides that "the City Council may amend the legal description of the PD Property to add or remove [properties] without Municipal Planning Board (MPB) review;" and

WHEREAS, the purpose of this ordinance is to amend the legal description of the Orlando Health PD Ordinance to add approximately 0.53 acres of land to the Orlando Health planned development zoning district; and

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, AS FOLLOWS:

SECTION 1. LEGAL DESCRIPTION AMENDED. Exhibit A to City of Orlando Ordinance #2013-45 is hereby deleted and replaced with **Exhibit A** to this ordinance.

SECTION 2. PD PLANNING AREA MAP AMENDED. Exhibit C to City of Orlando Ordinance #2013-45 is hereby deleted and replaced with Exhibit B to this ordinance.

**SECTION 3. PD LAND USE PLAN AMENDED.** Exhibit D to City of Orlando Ordinance #2013-45 is hereby deleted and replaced with **Exhibit C** to this ordinance.

SECTION 4. AMENDMENT OF OFFICIAL ZONING MAPS. The City zoning official, or designee, is hereby directed to amend the City's official zoning maps in accordance with this ordinance.
