Mayor's Matching Grants

Orlando Citrus Bowl National Team soccer matchup

With the major reconstruction of the Orlando Citrus Bowl last year, it became clear that updating and enhancing the stadium would not only allow Orlando to retain its signature annual events – the Florida Classic, Russell Athletic Bowl, Buffalo Wild Wings Citrus Bowl and Monster Jam – but it would also help attract more world-class, high-profile events. Mayor Dyer announced that the Orlando Citrus Bowl will host a soccer matchup between the Mexican Men's National Team against the Costa Rican Men's National Team on Saturday, June 27, 2015. The draw of the Mexican National Team is significant; the Mexican National Team was the inaugural event at the new Cowboys Stadium in Dallas and the inaugural event at the new MetLife Stadium in New Jersey. These are major sporting events which average 50,000 fans per game in the U.S. and here in Orlando it will only further the soccer fever that has consumed the region. Marquee events like this are obviously a thrill to experience in person but they also have a vital economic impact on the local economy. Between tourism, ticket sales, hotel accommodations, dining and entertainment, events like this continue to generate economic impact in the Orlando community.

Neighborhood Summit Recap

On Saturday, March 21 Mayor Dyer hosted the 10th annual Neighborhood and Community Summit. There were over 300 neighborhood, arts, cultural, civic, community and faith-based leaders and volunteers at this full day of learning and networking. Mayor Dyer presented the Neighborhood Champion and Community Builder Awards to recognize some of Orlando's unsung heroes in the community who work day in and day out, on their own time, to help us make the city stronger. Mayor Dyer congratulated Faye Henderson, member of the Lake Orlando Homeowners Association in the Rosemont neighborhood located in District 3 for receiving the Neighborhood Champion Award, and Harbor House of Central Florida for receiving the Community Builder Award. Mayor Dyer thanked all of the staff who planned and participated in the Summit, and thanked Commissioner Robert F. Stuart, Commissioner Regina I. Hill and Commissioner Samuel B. Ings for attending.

Item C-1 - Meeting Minutes and Approving the Actions of the Municipal Planning Board for the Meeting of February 17, 2015

On today's agenda is a vote to approve a three phase master plan for The Yard, a mixed use complex in Ivanhoe Village. The project will include a 630-unit apartment building, 57,000 square feet of retail, a multi-use trail for walking and biking that connects to the Lake Ivanhoe trail, and an outdoor amphitheater. This property has been identified as an area that can benefit from revitalization through quality development. Mayor Dyer thanked the City's transportation planning and engineering teams working with the developer to ensure that the proper transportation options are in place for not just vehicles but also pedestrians and bicyclists.

Hearings/Ordinances 2nd Read #2 - Proposed ordinance #2015-6, designating Tinker Field an Orlando historic landmark

Also on today's agenda is the second reading of the hearing for the historic landmark designation of Tinker Field. One important component to the historic designation is the plans for salvage and commemoration of the site. Commissioner Regina I. Hill will lead this effort, working closely with the Well's Built Museum to determine what the recognition should include and also to ensure community input. Mayor Dyer announced that prior to hearing public comment, there will be a brief presentation by Orlando Venues Director Allen Johnson of the salvage process and next steps in developing a commemorative recognition, preceded by an overview of the modifications to the ordinance given by Chief Assistant City Attorney Kyle Shepherd.
