MAYOR'S UPDATE

Hispanic Office for Local Assistance (HOLA) Celebrates 11th anniversary

Last week, Orlando celebrated the 11th anniversary of the City's Hispanic Office for Local Assistance (HOLA). The HOLA office provides valuable information and referral services to residents and newcomers to Central Florida, connecting them with more than 140 government and community organizations to find jobs, housing, healthcare services, educational opportunities and other resources. Since opening in 2004, the HOLA office has served more than 150,000 citizens through in-person visits,

calls and emails. Orlando is a diverse, multicultural community, and the office helps welcome newcomers to the City. New partnerships are being planned that will allow the HOLA office to work with representatives from Latin American governments to better help new residents get acclimated to living in Orlando. Item B-6 - Award to Schuller Contractors Incorporated for Citywide Sidewalks Phase 2, Project No. CIP0014-G, IFB15-0082

On today's agenda is the construction contract for the second phase of the ORLANDO WALKS sidewalk project to improve pedestrian safety and provide an alternate, environmentally friendly transportation option. Through the first phase, approximately 17 miles of new sidewalks were added. This second phase will add 22 more miles of new sidewalks. Construction will start in the spring of 2015 and is expected to be completed in late 2016.

Item C-2 – Second Amended and Restated Operations Agreement ("LYMMO") - North Quarter and Lime Updates

Also on today's agenda is an agreement with LYNX that will add new fare-free LYMMO service to the growing North Quarter in Downtown. The new North Quarter loop will add an additional five LYMMO stations to the current LYMMO Orange Line. The expanded route will better connect the North Quarter District to Downtown's Central Business District and provide greater mobility and accessibility for the community. This new service will start on Sunday, April 19. And coming this spring, LYMMO will break ground on a new route called the Line. The Line Line will provide another transportation option for the community that will provide convenient access to LYNX Central Station, SunRail, the Parramore neighborhood, FAMU College of Law and the Creative Village. The Line Line is expected to be complete by the first half of 2016.

Item C-6 – Right of Entry and Release Agreement for Installation of Street Trees on Private Property

As part of the Ultimate I-4 project, City staff and Downtown South Main Street have been working together with the Florida Department of Transportation to try to save and replant as many date palm trees as possible that will need to be relocated. The Families Parks and Recreation Division, Downtown Development Board and the Downtown South Neighborhood Improvement District will be repurposing some of the large date palms. On today's agenda are agreements with some private property owners to place the trees on private property along South Orange Avenue, which will allow the City to move forward with this great project.

Item C-8 - Economic Development Transportation Project Fund Agreement between City and Florida Department of Transportation

On Wednesday, April 8, 2015 the City of Orlando will join with Orange County Mayor Teresa Jacobs and executives from Tavistock Group to break ground on the United States Tennis Association's new home of American Tennis in Lake Nona. In addition to breaking ground, USTA will unveil the site's official name and new renderings of the 63-acre campus that will include more than 100 tennis courts, office facilities and a lodge for players to stay while training at the facility. The Lake Nona site will also serve as home to the University of Central Florida's varsity tennis program. On today's agenda is a grant to the City from the Florida Department of Transportation on behalf of USTA to construct the entry road needed to access the new facility from Lake Nona Boulevard. This new USTA project will create more than 150 new-to-Florida jobs with an average salary of nearly \$85,000. USTA's decision to open this state of the art facility in Orlando is yet another example of the ability of the community's public and private partners to collaborate together to build new projects in Orlando.

Item D-1 – Memorandum of Understanding with National Recreation and Park Association

During April's Earth Month, the National Recreation and Park Association and Disney, ABC Television Group and ESPN are collaborating to revitalize parks across the country, including a park right here in Orlando, through Parks Build Community. One of three local parks will receive a \$20,000 grant and Orlando residents get to choose which one. Projects include a shade structure for the Orlando Skate Park in District 4, sports equipment for Parramore Kidz Zone Football in District 5 and trail improvements at Bill Frederick Park in District 6. Orlando residents can vote now through April 30 at the National Recreation and Park Association website at http://www.parksbuildcommunity.org/.
