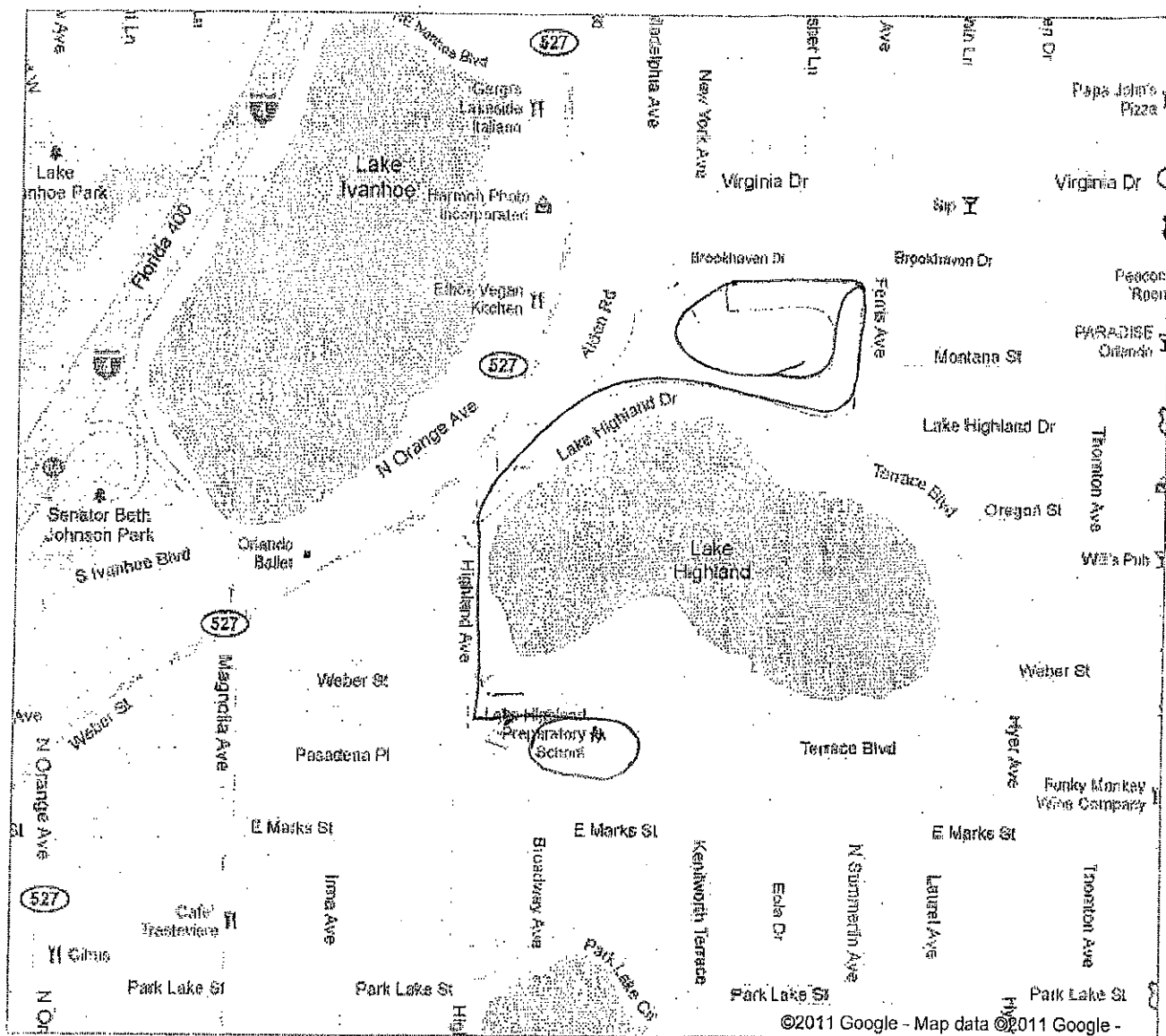

The GINA MARTIN RUN will STAGE AND START ON HIGHLAND AVE BETWEEN PASADENA PL AND WEBBER ST. RUN WILL MOVE NORTH TO LAKE HIGHLAND DRIVE INTERSECTION AND MOVE ONTO THE URBAN TRAIL. RUNNERS WILL FOLLOW THE TRAIL ONTO FERRIS AVE EXIT WEST ONTO LAKE HIGHLAND ATHLETIC COMPLEX. AFTER MAKING A LOOP ON THE COMPLEX RUNNERS WILL EXIT BACK ONTO THE URBAN TRAIL ON FERRIS AND FOLLOW IT BACK TO HIGHLAND AVE.
