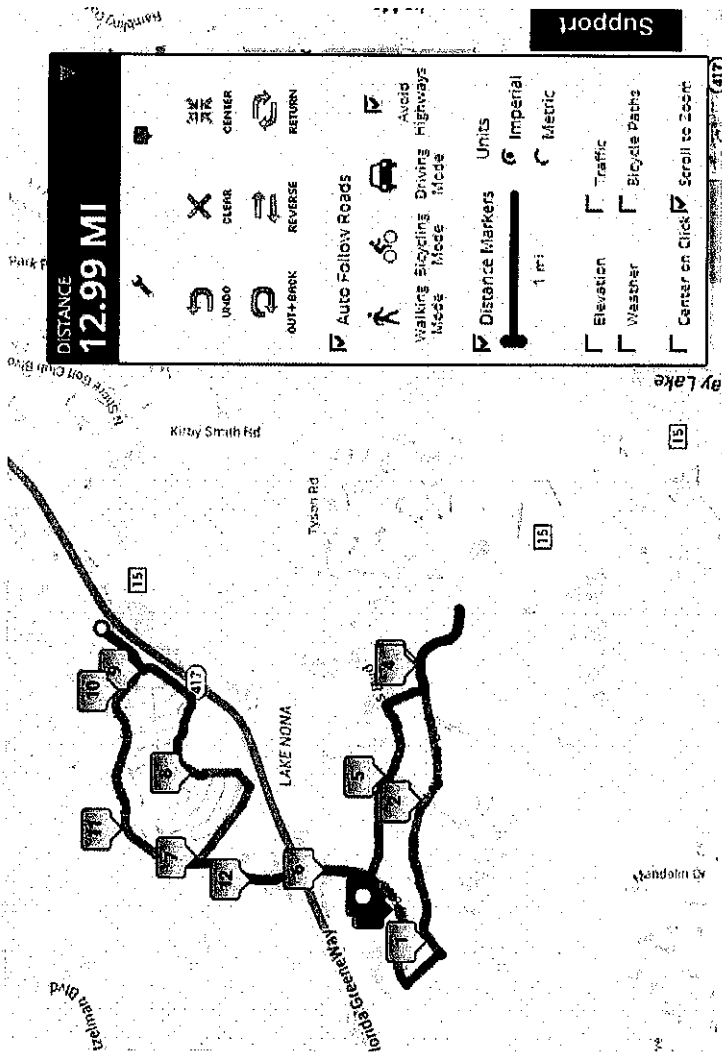

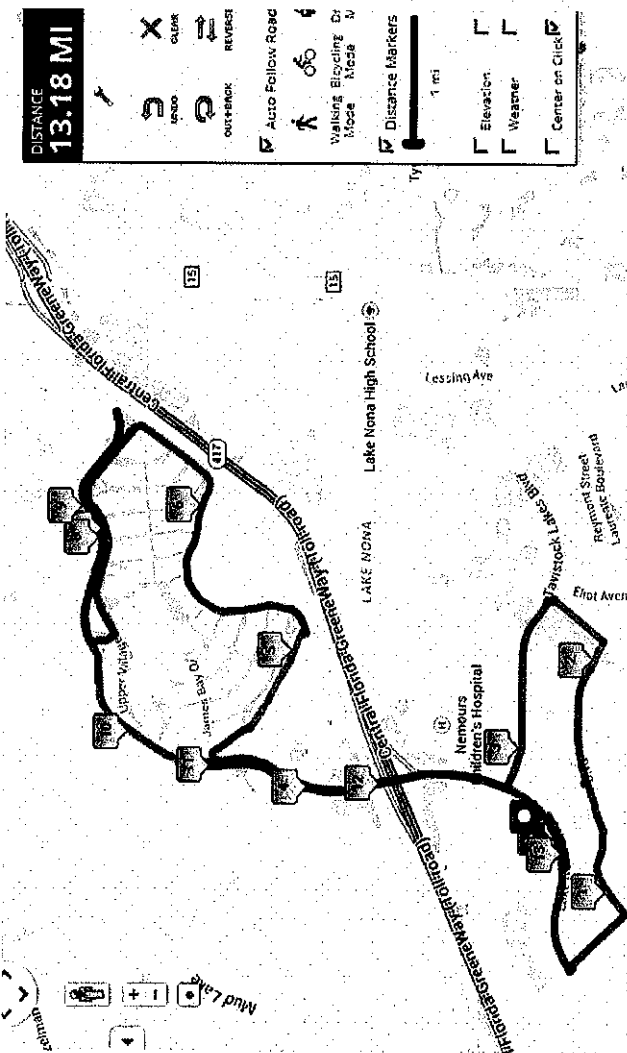

Option A

Start by UCF area heading towards Sanford Burnham to Laureate Park Blvd to where the towers near Publix are. Head back to the new road (before Briand Rd on LP) to Tavistock Lakes to Lake Nona Blvd to Village Walk. Enter Village Walk through gate closest to hill, come out on the far end gate. Head down to Lake Nona Blvd and turn around.



Option B

Same start. Head towards Laureate Blvd and make a left Right before the subdivision starts and heads towards Tavistock to Lake Nona Blvd to Village Walk, entering Through gate closest to hill. Exiting Village Walk through main entrance. Make a right on Lake Nona Blvd and the Next Village Walk gate should be the turn around point.
