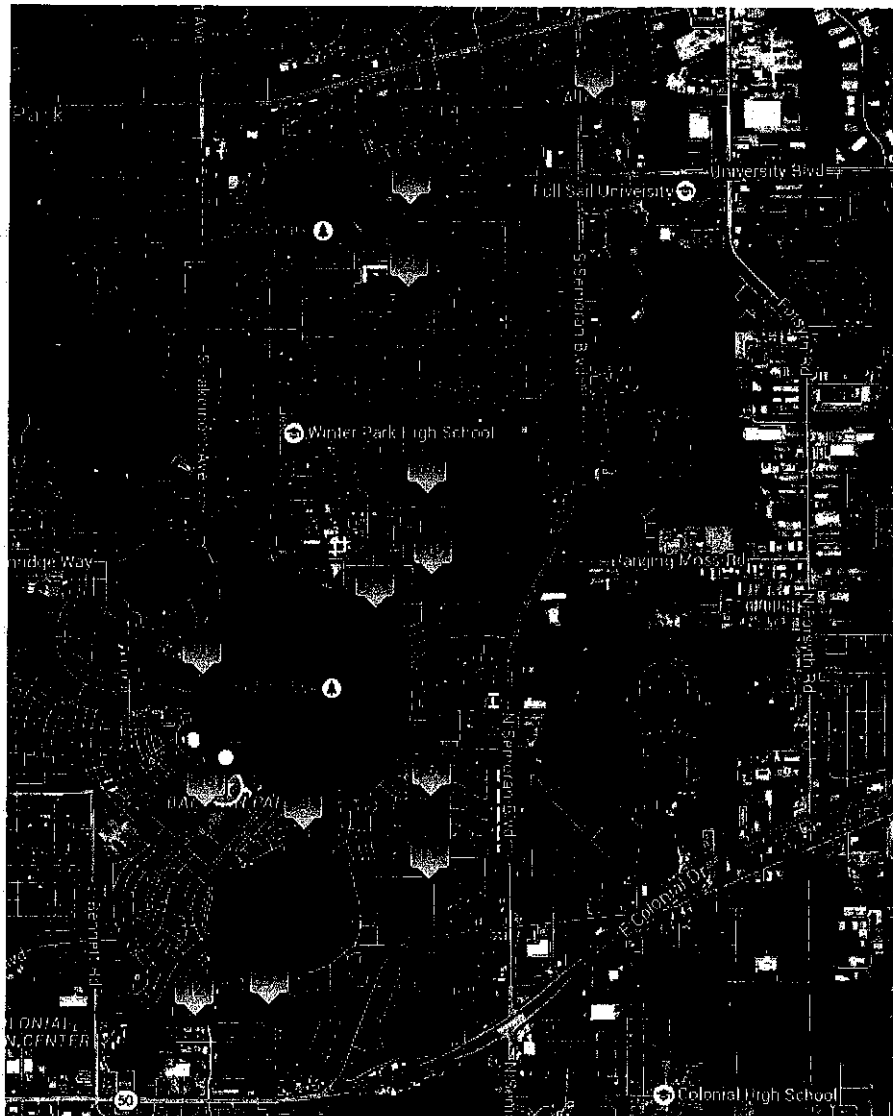

- Right on Lakemont Road to Roundabout and turn right onto Lake Baldwin Trail
  - Left onto Lake Baldwin Trail to Turn Around Point
- Turn around and return in reverse direction to Finish Line at New Broad and Jake Street
