## **AGREEMENT**

THIS AGREEMENT, made and entered into this day of, 2016,	by
and between the City of Orlando, a municipal corporation existing under the laws of the State	of
Florida (hereinafter "City") and Susan E. Johnson-Velez (hereinafter "Hearing Officer").	

## **WITNESSETH:**

WHEREAS, the City is desirous of retaining the services of Hearing Officer to serve as a hearing officer for the City pursuant to Chapter 2, Part XXXII, Orlando City Code; and

WHEREAS, the City and Hearing Officer are desirous of establishing and maintaining a contractual relationship for providing these services; and

WHEREAS, it is the purpose of this Agreement to set forth clearly the understanding and agreement of the parties with respect to the above matter.

NOW, THEREFORE, in consideration of the mutual promises contained herein, the City and Hearing Officer hereby agree as follows:

- 1. City hereby engages Hearing Officer to serve as a hearing officer for the City pursuant to Chapter 2, Part XXXII of the Orlando City Code, including, but not limited to, holding hearings, reviewing memoranda, drafting proposed orders and such other services as appropriate (hereinafter "Services").
- 2. In consideration of the Services to be rendered by Hearing Officer the City hereby agrees to pay Hearing Officer the hourly rate of One Hundred Forty Dollars (\$140.00) plus direct expenses (long distance telephone, postage, etc). The Hearing Officer shall submit itemized bills to the City at the end of each month in which Services were rendered for Services rendered and costs incurred.
- 3. The Hearing Officer shall bill only for the time utilized in providing Services. The Hearing Officer shall not bill for travel time. If the Hearing Officer's residence and principal office are located more than fifty (50) miles from City Hall, 400 S. Orange Avenue, Orlando, Florida, 32801-3302 (hereinafter "City Hall"), then the Hearing Officer may bill for mileage at the then

prevailing City rate. In no event shall the Hearing Officer bill for, nor the City pay for, mileage for travel to or from locations outside of the State of Florida. Also, if the Hearing Officer's principal residence and principal office are located more than fifty (50) miles from the City Hall, in the event of a multi-day hearing, the Hearing Officer may bill per diem at the then prevailing City rate and for hotel costs, subject to the City's prior approval of the hotel rate. In no event shall the Hearing Officer bill for, nor the City pay for, any hotel stays over a Friday or Saturday night.

- 4. The term of this Agreement shall commence upon the date of execution by all parties and shall automatically terminate 3 years from the date of execution. This Agreement may be terminated at any time after execution upon written notice from either party to the other party hereunder.
- 5. There shall be no obligation upon the City to request any Services of the Hearing Officer. Any work shall be procured on an as-needed basis.
- 6. Any notice permitted or required hereunder shall be in writing via First Class United States Mail, addressed as follows:

- 8. Any amendment to this Agreement shall be in writing and executed by the City and Hearing Officer.
- 9. The location for the settlement of any dispute arising out of this agreement shall be Orange County, Florida.
