i. Novus Discussion


1. Mr. Kyle Reynolds, Board Administrator, and the board members discussed the new Novus Boardview software.

8. Presentation of New Inquiries


- a. Mr. Dwain Rivers, Internal Affairs Manager, presented four (4) new cases to the board to be reviewed at the next CPRB meeting.
