## **Public Comment:**

1. Stephanie Rodriguez appeared to speak on the following item:

Item C-2 Accepting Meeting Minutes and Approving the Actions of the Historic Preservation Board – February 3, 2016 (Case No. HPB2016-0001, 722 E. Amelia Street). Mayor Dyer asked Dean Grandin, Planning Division Manager, to address her concern about the set back and the different conclusions from the Historic Preservation Board and Board of Zoning Adjustment. Commissioner Sheehan voiced her concern that the Code needs to be addressed and revised, rather than have these issues continue to come before Council. Kyle Shephard, Chief Assistant City Attorney, suggested this case be deferred until the next Council meeting. Mr. Shephard also made suggestions that address the issue and Mayor Dyer asked that it come before Council as a workshop on March 14.

Judge Road, east of Mercy Drive, south of W. New Hampshire Street and west of N. John Young Parkway (Princeton Oaks).
