Re: Revised Application for Temporary Use Permit For Orlando Magic Banners

Dear Karl:

Per our recent discussions, please find enclosed herewith our revised request for determination application (the "Application") for a temporary use permit ("Permit") that would allow the Orlando Magic, Ltd ("Magic") to temporarily display certain signage (the "Temporary Signage") on approximately twelve (12) buildings located in Orlando, Florida (the "Temporary Signage Locations"), which are depicted and described (in terms of their dimensions) on **Composite Exhibit "A"** attached hereto. While this Permit is in place, the Magic may substitute a Temporary Signage Location for review and administrative approval by the City Planning Division Manager.

The Magic would display the Temporary Signage for periods of approximately thirty (30) days at a time (the "Temporary Signage Utilization Period") and the Temporary Signage may be utilized by the Magic not more than two (2) times in a calendar year including: (i) the NBA Playoffs; and (ii) the start of the NBA basketball season. It is recognized that the total time frame for the NBA Playoffs in a given year extend approximately sixty (60) days. In the event that the Magic's participation in the NBA Playoffs should extend beyond the Temporary Signage Utilization Period, the City Planning Division Manager may grant an administrative extension of the Temporary Signage Utilization Period such that the Magic may maintain the Temporary Signage while they are competing in the NBA Playoffs. The Magic would be able to utilize a

maximum of ten (10) Temporary Signage Locations included in **Composite Exhibit** "A" attached hereto for the NBA Playoffs in a given year and the Magic would be able to utilize a maximum of six (6) Temporary Signage Locations included in **Composite Exhibit** "A" attached hereto for the start of the NBA basketball season in a given year.

In a given year while this Permit is in place, the Magic would provide the City with color renderings of the sign copy that would be utilized for the Temporary Signage together with the Temporary Signage Locations at least thirty (30) days in advance of the date scheduled for installation, which would be reviewed for administrative approval by the City Planning Division Manager. The Magic may include a maximum of twenty percent (20%) of the sign copy on the Temporary Signage for sponsorship purposes. Although the sponsorship may not exceed twenty percent (20%) of the sign copy, the sign copy and sponsorship may differ on the various Temporary Signage Locations.

The requested Permit would remain in place for a period of two (2) years with a one (1) year extension starting in April 2016. We request that the extension be approved on an administrative level by the City Planning Division Manager. The Magic would be required to obtain a permit from the City of Orlando to install the Temporary Signage, which will include, but shall not be limited to the following requirements: (i) authorization from any private entity that may own a Temporary Signage Location; and (ii) evidence of how the Temporary Signage will be affixed to the various buildings.




