sustainability, climate action and resilience through Green Works Orlando and the City Energy Project initiatives.

Proclaiming March 2016 as Women's History Month

Commissioner Regina I. Hill introduced Rachel Moalli from Align Public Strategies, representing the Florida Restaurant and Lodging Association, who spoke about Women's Empowerment Month in the hospitality industry. # MAYOR'S UPDATE

State of the City

Mayor Dyer invited everyone to attend the annual State of the City address on Tuesday, April 5, 2016 at 10:30 A.M. in City Council Chambers at City Hall.

#### **Cattle Drive**

Mayor Dyer explained that on Monday, April 4, 2016 he will join the City of Kissimmee and Osceola County to serve as Honorary Trail Boss for the 2016 Cattle Drive through downtown Kissimmee to kick off the Ram National Circuit Finals Rodeo.

**Education Equality Index** 

Mayor Dyer highlighted a success that the City has long been focused upon. According to the national Education Equality Index released last week, the achievement gap between Orlando students from low-income families and their more advantaged peers is narrowing faster than in 90 percent of major U.S. cities. Mayor Dyer thanked the Commissioners for their support of City programs and partnerships that made this possible.

# Agenda Items of Note

Mayor Dyer highlighted the following four agenda items.

Mayor-3 - Orlando's PACE Program

As part of the City's on-going efforts to be the most sustainable City, this item establishes a non-exclusive Property Assessed Clean Energy (PACE) financing program that will allow for three PACE administrators to operate in city limits and offer financing opportunities for property owners for such improvements.

Item C-4 – Business Assistance Program Agreement between TPH Church Street, LLC d/b/a Pi Pizza and the City of Orlando - 532 West Church Street

This item is further support for small businesses and continuing investment in the Parramore neighborhood. Through the City's Business Assistance Program, Council will fund Pi Pizza, an expanding local business that plans to occupy approximately 2,200 square feet of existing space, for completion of interior renovations and creation of up to ten new, full time jobs.

Item D-1 - Facility Use Agreement with USTA for the Orlando Tennis Centre

This item to allow the UTSA to rent ten courts at the Orlando Tennis Centre from June to November, providing a home for a player development program until the USTA campus in Lake Nona is complete. Residents will still have access to the Orlando Tennis Centre during this period.

Item D-2 - Memorandum of Understanding for NRPA Disney Parks Build Grant

Orlando is again joining the National Recreation and Park Association's Parks Build Community initiative, which helps make improvements to parks and community centers across the country. One of three City parks and community centers will receive a \$20,000 grant from the NRPA and Orlando residents get to choose which one: the Engelwood Neighborhood Center community garden, Poppy Park basketball court revitalization or fitness pods at Al Coith Park. Voting opens April 1 and runs through April 30 at the National Recreation and Park Association website at NRPA.org.
