Subject: AVIATION AUTHORITY SPECIFIC APPROVALS

Consent Agenda Item L - Recommendation of the Construction Committee to Approve an Addendum to the Professional Services Agreement with Avcon, Inc. for Bid and Award Phase A/E Services for Bid Package (BP) No. 455, Taxiway C - South End Rehabilitation, at the Orlando International Airport

BP No. 455, Taxiway C - South End Rehabilitation, provides for the rehabilitation of the existing pavement for the south end of Taxiway C (located between Taxiway F and Taxiway B10), Taxiway B9, and related areas to eliminate areas of distressed pavement and maintain the aircraft taxiing capacity. To restore and maintain the airfield pavement serviceability, the work includes milling of existing pavement, removing and replacing deteriorated pavement areas, bituminous pavement overlay and associated markings, lighting, and signage. The fiscal impact is \$21,012. Funding is from previously-approved Florida Department of Transportation (FDOT) grants and Discretionary Funds to be reimbursed by future Passenger Facility Charges and Federal Aviation Administration (FAA) AIP grants to the extent eligible. Request Orlando City Council approval (as required because of FAA funding)

Consent Agenda Item M - Recommendation of the Construction Committee to Approve an Addendum to the Professional Services Agreement with Prime Engineering Incorporated for Bid and Award Phase A/E Services for Bid Package (BP) No. 462, Taxiways G and H Safety Area Improvements and Related Work, at the Orlando International Airport

Several taxiways located near the Airsides 2 and 4 Terminals support Federal Aviation Administration (FAA) Airplane Design Group (ADG) V aircraft operations. Based on an engineering assessment completed in February 2015, areas adjacent to Taxiways G, H, H1 to H10, and portions of Taxiways E and F require grading, stormwater drainage piping extensions, drainage facility modifications, and other improvements to meet current FAA ADG V design standards. The fiscal impact is \$13,942. Funding is from previously-approved Florida Department of Transportation (FDOT) grants and Discretionary Funds to be reimbursed by future Passenger Facility Charges and Federal Aviation Administration (FAA) AIP grants to the extent eligible. Request Orlando City Council approval (as required because of FAA funding).

Consent Agenda Item S - Recommendation of the Construction Committee to Approve an Addendum to the Professional Services Agreement with Matern Professional Engineering, Inc. for Bid and Award Phase A/E Services for Bid Package (BP) No. 459, Secured Area Access Point CCTV Improvements, at the Orlando International Airport

BP No. 459, Secured Area Access Point CCTV Improvements, provides for the upgrade and enhancement of the Closed Circuit Television System (CCTV) at each of the secure area entry points at the Orlando International Airport. The scope includes upgrading and enhancing the CCTV coverage and video storage capability of all secure area entry points at the Orlando International Airport. The fiscal impact is \$10,727. Funding is from previously-approved Florida Department of Transportation (FDOT) grants, Capital Expenditure Funds and Passenger Facility Charges to be reimbursed by future Federal Aviation Administration (FAA) AIP grants to the extent eligible. Request Orlando City Council approval (as required because of FAA funding).

Consent Agenda Item Z - Recommendation to Approve the Use of Discretionary Funds for Support Services Related to the Negotiation of the Right-of-Way Agreements, Intermodal Terminal Facility (ITF) Space Agreements and Escrow Agreements with Globalvia Inversiones, S.A.

On December 9, 2015, the Aviation Authority Board authorized staff to proceed to negotiate Right-of-Way agreements, Intermodal Terminal Facility (ITF) space agreements and escrow agreements with Florida EMMI, LLC (EMMI) and to present the agreements, following satisfactory review by legal counsel, to the Aviation Authority Board for consideration and approval at a later date. We have been advised by EMMI's counsel, Gray Robinson, that Globalvia Inversiones, S.A. (Globalvia), will be assuming EMMI's responsibilities and entering into an agreement related to the Orlando Fixed Guideway Transit System (OFGTS). Support services are needed to assist Aviation Authority staff with the evaluation of proposed technologies, routes, terminal interfaces, and negotiations with regards to safety and operational requirements, as well as other support services related to the negotiation of the Right-of-Way agreements, Intermodal Terminal Facility (ITF) space agreements and escrow agreements with Globalvia. In addition financial consultants will be required to assist the Aviation Authority in evaluating the Globalvia ridership projections. Funding in the not-to-exceed amount of \$500,000 is needed from Discretionary Funds for the related support services, which requires approval by the Aviation Authority Board and Orlando City Council concurrence for this non-budgeted expenditure. Request Orlando City Council concurrence in this non-budgeted expenditure.
