12. JUSTIFICATION: Document justification for request. It is not unprecedented for museums and gardens to raise admission prices during special exhibits. Leu Gardens would like to keep garden admission prices the same while eliminating three free days. The Gardens and exhibit will be available to residents at no charge during Leu Gardens' Annual Plant Sale on March 11 and 12, 2017. We believe this suspension will increase memberships as visitors recognize the added value of annual exhibitions. Suspending 3 Free First Monday Admissions in 2017 on February 6, March 6, and April 3 will help defray marketing costs of the Dinosaurs Exhibit. Our 2016 Big Bugs exhibit increased admission revenues by \$7,600.00 due to the 3 suspended days.
