# EMERGENCY SOLUTIONS GRANTS (ESG-CV) PROGRAM AGREEMENT BETWEEN THE CITY OF ORLANDO AND S.A.L.T. OUTREACH, INC. (COVID-19)

**THIS AGREEMENT** is entered into by and between the **City of Orlando**, a Florida municipal corporation (hereinafter referred to as the "City") with a principal address of 400 South Orange Avenue, Orlando, Florida 32801, and the **S.A.L.T. Outreach, Inc.**, a nonprofit corporation organized under the laws of the State of Florida, with a principal address of 100 East Pine Street, Ste. 110, Orlando, Florida 32801-2211 (hereinafter referred to as "SALT" or "Subrecipient").

#### WITNESSETH:

WHEREAS, pursuant to the Homeless Emergency Assistance and Rapid Transition to Housing Act of 2009 ("HEARTH"), the United States Department of Housing and Urban Development ("HUD") has designated the City as a grantee of the revised Emergency Solutions Grants Program ("ESG") and has allocated ESG-CV funds to the City in furtherance of its goal to prevent, prepare for, and respond to the coronavirus among individuals and families who are homeless or receiving homeless assistance and homelessness prevention activities; and

WHEREAS, this Agreement will be governed by the following, and as amended: the Coronavirus Aid, Relief, and Economic Security Act, Public Law 116-136 [H.R. 748] March 27, 2020 (herein referred to as the "CARES Act"); the Memorandum for Availability of Waivers of Community Planning and Development (CPD) Grant Program and Consolidated Plan Requirements to Prevent the Spread of COVID-19 and Mitigate Economic Impacts Caused by COVID-19 (herein referred to as the "Waiver Memorandum"); 2 CFR Part 200 Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards ("Uniform Administrative Requirements"), Subpart E ("Cost Principles"); and Office of Management and Budget (herein referred to as "OMB") all of which are incorporated herein as a material part of this Agreement; and

WHEREAS, SALT wishes to provide services and assistance to individuals and families who are homeless or who are at-risk of becoming homeless, and if not for this assistance would be homeless; and

**WHEREAS**, the City has allocated to **SALT** the sum of <u>Four Hundred</u>, <u>Forty-Five Thousand</u>, and <u>Forty-Three Dollars and No Cents</u> (\$445,043.00) in ESG-CV funds for eligible activities in accordance with 24 CFR Part 576, Subpart B.

**NOW THEREFORE,** in consideration of the promises, the mutual covenants and agreements herein contained, and other good and valuable consideration, the sufficiency of which is hereby acknowledged, the City and **SALT** agree as follows:

**SECTION 1: USE OF ESG-CV FUNDS** 

- 1. <u>Incorporation of Recitals</u>: The recitals set forth above are true and correct and are incorporated herein and made a part of this Agreement.
- Scope of Services/Funding: Under the terms and conditions of this Agreement, the 2. City has allocated a subaward to SALT in the amount of Four Hundred, Forty-Five Thousand, and Forty-Three Dollars and No Cents (\$445,043.00) in FY 2021-2022 ESG-CV funds to carry out eligible activities as described in the CARES Act and 24 CFR Part 576, Subpart B and therefore continue to provide assistance and services to those individuals who are homeless or who are atrisk of becoming homeless, and if not for this assistance would be homeless, as defined in 24 CFR \$576.2. Pursuant to 2 CFR \$200.331, the required subaward information is attached hereto as Exhibit "H". SALT shall carry out those eligible activities according to the Budget, which is attached hereto and made a part hereof as Exhibit "A". No modification, amendment, alteration or change is to be made to the scope or intent of this Agreement, nor to the expenditure category indicated in Exhibit "A". The City may require a more detailed budget breakdown than the Budget attached hereto, and SALT shall provide such supplementary budget information in a timely fashion and in the form and content as may be prescribed by the City. The City may also require changes in line items, or approve other budgetary changes within the total award amount. Any supplementary budget information or budget changes must be approved in writing by the Housing Director and Housing and Community Development Manager, or designee. SALT shall use these ESG-CV funds for eligible expenses permitted under the Budget as permitted under the ESG regulations set forth in 24 CFR Part 576 and the CARES Act. SALT acknowledges that it is responsible for expenses that exceed the total award amount and agrees that any funds not used in accordance with permitted ESG regulations and the Budget must be repaid to the City.
- Payment Procedures/Reimbursement of Funds: This is a cost reimbursement agreement. Reimbursement of funds under this Agreement may be requested only for necessary, reasonable, and allowable costs described in the Budget, attached hereto as Exhibit "A" and for which **SALT** has made payment. Upon compliance with the terms of this Agreement, the City will reimburse funds to SALT only after completion of the work and after receipt and approval by appropriate City personnel of the invoices. Invoices shall be submitted in Zoomgrants no more frequently than once a month and shall be in accordance with the Budget attached hereto as **Exhibit** "A", specifying the services performed and expenses incurred. All invoices must be accompanied by adequate billing documentation of payment for eligible expenses which are to be uploaded in Zoomgrants (i.e. personnel activity reports, pay stubs, payroll records, copies of cancelled checks, and time sheets) and other supporting documentation the City may request. Failure by SALT to provide invoices in a timely, complete and error-free manner shall reflect on the administrative performance rating of SALT for subsequent funding awards. It is anticipated that the City will provide payment to SALT immediately upon approval of the invoices. Invoices that are incomplete or that fail to include the necessary supporting documentation may result in delay and or possible denial of payment.

No interest shall be earned on ESG-CV proceeds. All invoices submitted in Zoomgrants must be signed by an authorized signatory of SALT and certified in accordance with 2 CFR §200.415. Notwithstanding anything to the contrary in this Agreement, the City also reserves the right to request and approve documentation supporting any invoice to verify the reasonableness and validity of such costs. The absolute maximum amount that shall be paid to SALT under this Agreement is Four Hundred, Forty-Five Thousand, and Forty-Three Dollars and No Cents

(\$445,043.00). In the event that the City of Orlando or HUD determines that any ESG-CV monies have been wrongfully paid, **SALT** agrees to refund such money to the City so that the City may refund it to HUD.

- 5. <u>Return of Funds.</u> **SALT** shall return to the City any over payments due to unearned funds or activities disallowed pursuant to this Agreement. **SALT** shall return any overpayment to the City within thirty (30) days after discovery by **SALT** or within fifteen (15) days after notification by the City.
- 6. Term: Unless earlier terminated, this Agreement shall be in effect for the period commencing April 1, 2021 and terminate on March 1, 2022. Costs may not be incurred after March 1, 2022 without written amendment to this Agreement. Notwithstanding anything herein to the contrary, **SALT**'s obligations to the City shall not end until all closeout requirements are completed, including, but not limited to, such things as making final payments, disposing of program assets, retention of records, and use and maintenance requirements for the property. Also, notwithstanding the foregoing, the term of this Agreement and the provisions herein shall be extended to cover any additional time period during which **SALT** remains in control of ESG-CV funds or other assets, including Program Income or for any HUD audits requiring repayment of any funds unlawfully spent under this Agreement.

#### **SECTION 2: GENERAL TERMS AND CONDITIONS**

- 1. <u>Applicable Laws</u>: **SALT** agrees to abide by any and all applicable federal or state laws, statutes, local ordinances, rules and regulations, whether presently existing or hereafter promulgated. **SALT** agrees to comply with all applicable provisions and regulations of the ESG Program contained in 24 CFR Part 576, the CARES Act, and other HUD regulations, as amended from time to time, whether set forth herein or not and any amendments or policy revisions thereto which shall become effective during the term of this Agreement. **SALT** shall also comply with the ESG eligibility requirements, a copy of which is attached hereto and made a part hereof as **Exhibit "B"**.
  - 2. OMB Circulars: **SALT** shall comply with the requirements of 2 CFR Part 200.
- 3. Audits: SALT shall comply with the audit requirements contained in the Single Audit Act Amendments of 1996 (31 U.S.C. §§7501-7507) and 2 CFR Part 200, Subpart F as applicable. In accordance with 2 CFR §200.510, SALT shall prepare financial statements and schedule of expenditures of federal awards. SALT's annual financial statement shall be prepared by an actively licensed public accountant who is obtained in accordance with the procurement standards at 2 CFR §200.317-§200.326. This financial statement shall be provided to the City within ninety (90) days of the end of its operating year. SALT also agrees to allow the City's Internal Audit and Evaluation Department to conduct any audits the City feels necessary at any time during the term of this Agreement or while SALT is responsible for any ESG funds.
- 4. Records and Reports: In accordance with the requirements set forth in 2 CFR Part 200, 24 CFR §576.107, and 24 CFR §576.500, **SALT** shall maintain certain records that document compliance with ESG regulations, as well as separate and distinct financial records of its accounts, operations, and other documentation that adequately identify the source and application of the ESG

funds. **SALT** shall keep orderly and complete records of its accounts and operations and shall keep these records open to inspection by the City and HUD personnel at reasonable hours during the entire term of this Agreement, plus five (5) years after the date of the final request for payment in accordance with 2 CFR §200.333 and 24 CFR §576.500. However, if any litigation, claim, or audit is commenced prior to the expiration of said five (5) year period, the records shall be maintained until all litigation, claims, or audit findings involving the ESG records have been resolved. Any person duly authorized by the City or HUD shall have full access to and the right to examine any of the said records during said period.

**SALT** shall enter all client data describing demographics, eligibility and financial assistance, including the number of individuals and families that were served, into the Homeless Management Information System (HMIS). Data must be entered, at a minimum, on a weekly basis. This data will be collected by the HMIS Lead agency on a monthly basis via the HMIS monthly status report. **SALT** shall provide the City's Housing and Community Development Department with quarterly and annual reports concerning the progress made on the project in the form attached hereto as **Exhibit "C"** to the City by the fifteenth (15<sup>th</sup>) calendar day of the month following the end of the quarter for March, June, September, and December. The report shall include the following information:

- Households Verification of Homelessness
- Households by Gross Monthly Income
- Households by Gender and Age
- Households by Race/Ethnicity
- Households Housing Units
- Households Receiving Housing Assistance/Support Services
- Household Ending Destination
- Any Other Data Points as required by HUD

In addition, if ESG funds are being used for personnel, **SALT** shall submit a personnel activity report, for personnel activities including but not limited to duties performed and time allocated in such forms provided by the City.

**SALT** shall also submit an annual report on the form provided in **Exhibit "C".** Annual reports are due by March 15, 2022 for activities conducted during the preceding year (Example: April 1, 2021 – March 1, 2022). Additional reports may be requested by the City throughout the year. **SALT** must maintain records documenting the total number of clients and the unique identifier of clients to whom services were provided, the type of services and/or actual services performed and the date(s) on which such services were provided, so that an audit trail documenting services is available.

5. <u>Monitoring and Inspections/Access to Records</u>: In accordance with 2 CFR §200.336, all files, records, documents, including financial statements and data, shall be made available for review to the City's Housing and Community Development Department, any auditors, the City's Office of Internal Audit and Evaluation, Comptroller General, Inspector General, HUD and/or any of their authorized representatives, who shall have access to and the right to audit, examine, inspect, make transcripts or excerpts of any of the above said records, documents or papers related to the activity or to meet any HUD requirements during normal

business hours and any other reasonable time requested. This right also includes timely and reasonable access to SALT's personnel for the purpose of interviewing and discussion related to said documents. This same right to review and access will be imposed upon any third party or subcontractor and it is SALT's responsibility to ensure that any contract entered into with third parties contain all necessary clauses and language required by the City and/or HUD to ensure compliance with this Agreement and with all federal, state, and local laws and regulations.

SALT shall monitor the progress of the activity covered by this Agreement and shall submit appropriate reports to the City. The City shall monitor SALT's performance and financial and programmatic compliance. SALT shall allow on-site monitoring of the facility and its programs on as frequent a basis as the City deems necessary and at any other time that may be required by HUD to determine compliance with ESG regulations, the CARES Act, and this Agreement. SALT shall also furnish and cause each of its own subcontractors, if any, to furnish all information and reports required hereunder and will permit access to its books, records and accounts by the City, HUD, or any other authorized official or designee for purposes of investigation to ascertain compliance with the rules, regulations, and provisions stated herein. This section shall survive termination of this Agreement.

- 6. <u>Termination of Assistance:</u> **SALT** shall develop and maintain a formal process in accordance with 24 CFR §576.402, whereby if an individual or family who receive assistance from **SALT** violates program requirements, **SALT** may terminate assistance in accordance with the formal process established by **SALT**. The formal process shall recognize the rights of individuals affected which, at a minimum, must include written notice of the termination and a hearing.
- 7. <u>Uniform Administrative Requirements and Cost Principles.</u> SALT shall comply with the Uniform Administrative Requirements, Cost Principles, and Audit Requirements set forth in 2 CFR Part 200 and adopted by HUD at 2 CFR Part 2400. Although 2 CFR Part 200 addresses many requirements, some of the items it addresses includes, but is not limited to, standards for financial and program management, property and procurement standards, performance and financial monitoring and reporting, subrecipient monitoring and management, record retention and access, remedies for noncompliance, FFATA, and closeout. SALT is aware and acknowledges that 2 CFR Part 200 and 2 CFR Part 2400 are recent regulatory changes to the administrative requirements and HUD is in the process of developing guidance on their specific requirements. Although this may change the administrative requirements set forth herein, SALT shall comply with whatever guidance HUD requires. SALT also agrees to adhere to the accounting principles and procedures required therein, utilize adequate internal controls, maintain necessary source documentation for all costs incurred, and submit an indirect cost allocation plan in accordance with 2 CFR Part 200, if such plan is required.
- 8. Procurement/Subcontracting/Third Party Contracts. SALT acknowledges that the CARES Act allows deviation from regular procurement standards when procuring goods and services to prevent, prepare for, and respond to the coronavirus, and therefore shall comply with the requirements of this subsection to the extent they are applicable under the CARES Act. If SALT hires contractors, it shall have established written procurement procedures. It shall procure all material, property, or services in accordance with the CARES Act and any applicable state and local requirements, the requirements of 2 CFR §200.318-§200.326, including the procurement of recovered materials (Resource Conservation and Recovery Act) in compliance with 2 CFR

§200.322 regarding the use of specific products made or used with recovered materials. SALT shall insure that all subcontracts let in the performance of this Agreement shall be awarded on a fair and open competition basis in accordance with applicable procurement requirements and secure at least three (3) price quotes or bids, as applicable. SALT shall incorporate in any and all bid documents and contracts with third parties these same procurement requirements and the provisions required in 2 CFR §200.326 including, but not limited to, provisions which will obligate each of its subcontractors to comply with all notices pertaining to HUD guidelines such as bidding procedures, Equal Employment Opportunity requirements, Section 3 requirements, all affirmative action laws, nondiscrimination requirements, anti-kickback requirements, federal labor standard provisions, and lobbying prohibitions issued by various federal agencies applicable to the ESG program. SALT shall not enter into any subcontract with any entity, agency or individual in the performance of this Agreement without the written consent and approval of the City's Housing and Community Development Department prior to execution of the agreement or contract. SALT agrees to furnish to the Housing and Community Development Department a copy of each third party contract it enters into an agreement with for the performance of work to be undertaken within the scope of this Agreement along with documentation concerning the selection process. The lowest and most responsive bidder shall be recommended by SALT to the City's Housing and Community Development Department. SALT shall require and monitor compliance by all contractors, subcontractors and other third parties. SALT will monitor all subcontracted services on a regular basis to assure contract compliance. Results of monitoring efforts shall be summarized in the monthly report. The City shall not be obligated or liable hereunder to any party SALT enters into agreements with for the Program.

Non-Discrimination and Equal Opportunity: In accordance with 24 CFR §576.407 9. and §576.500, SALT shall maintain records showing compliance with all applicable fair housing and civil rights requirements in 24 CFR §5.105(a) and certifying that SALT will affirmatively further fair housing pursuant to 24 CFR §5.168. SALT shall not discriminate against any employee or person served on account of race, color, sex, age, religion, ancestry, national origin, actual or perceived sexual orientation, gender identity, disability, or familial or marital status in the performance of this Agreement. **SALT** shall comply with the following: a) the Fair Housing Act (42 U.S.C. §3601-3619) and implementing regulations at 24 CFR Part 100 et. seq.; b) Executive Order 11063, as amended by Executive Order 12259 (3 CFR, 1959-1963 Comp., p. 652 and 3 CFR, 1980 Comp., p. 307) and implementing regulations at 24 CFR Part 107 (Equal Opportunity in Housing Programs; c) Title VI of the Civil Rights of 1964 (42 U.S.C. §§2000d -2000d-4) and implementing regulations at 24 CFR Part 1 (Nondiscrimination in Federally Assisted Programs; d) the Age Discrimination Act of 1975 (42 U.S.C. §§6101 - 6107) and implementing regulations at 24 CFR Part 146; e) Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. §794) and implementing regulations at 24 CFR Part 8 for purposes of the ESG program, the term "dwelling units" in 24 CFR Part 8 shall include sleeping accommodations; f) Title II of the Americans With Disabilities Act (42 U.S.C. §12101), et. seq. and 28 CFR Parts 35 and 36; g) Section 3 of the Housing and Urban Development Act of 1968 (12 U.S.C. §1701u) and implementing regulations at 24 CFR Part 135, except homeless individuals have priority over other Section 3 residents in accordance with § 576.405(c); h) Executive Order 11246, as amended by Executive Orders 11375, 11478, 12086 and 12107, and implementing regulations at 41 CFR Part 60 (Equal Employment Opportunity Programs); i) Executive Order 11625, as amended by Executive Orders 12007 (Minority Business Enterprises); j) Executive Order 12432 (Minority

Business Enterprise Development); and k) Executive Order 12138, as amended by Executive Order 12608 (Women's Business Enterprise).

If applicable, **SALT** shall have a formal, written grievance procedure for resolution of complaints alleging discrimination based on disability pursuant to 24 CFR 8.53(b). In addition, it is expressly understood that, upon the event of discrimination based on any of the foregoing regulations, and upon the City's receipt of evidence of such discrimination, the City shall have the right to immediately terminate this Agreement.

- 10. <u>Equal Access</u>: **SALT** shall comply with access requirements set forth in 24 CFR §5.106 and shall maintain records showing compliance with this provision for a period of five (5) years in accordance with 24 CFR §5.106(d).
- 11. Affirmative Marketing/Outreach: SALT shall comply with the provisions set forth in 24 CFR §8.6, 24 CFR Part 5, 24 CFR §576.407(b), 24 CFR §576.500(s)(1), the Americans with Disabilities Act (42 U.S.C. §§12101-12213), and implementing regulations at 24 CFR part 35 and Part 36, as applicable. SALT shall adopt procedures to ensure that all persons who qualify for assistance, regardless of their race, color, religion, sex, age, national origin, familial status, or disability know of the availability of the ESG Program, and the existence and location of services, activities, and facilities, including facilities and services accessible to persons with a disability, and maintain evidence of implementation of the procedures. Also, in accordance with Title VI and Executive Order 13166 and 24 CFR §8.6, SALT shall take reasonable steps to ensure meaningful access to the ESG Program for limited English proficiency (LED) persons and for persons who have hearing, vision, or speech impairments. SALT shall also comply with the City's affirmative marketing procedures.
- 12. <u>Religious Organizations:</u> In accordance with 24 CFR §576.406, **SALT** shall comply with the requirements set forth in 24 CFR §5.109.
- Conflict of Interest: In the procurement of supplies, equipment, construction and 13. services, the SALT shall comply with the conflict of interest rules in 2 CFR Part 200. SALT agrees and warrants that it will establish and adopt written standards of conduct governing conflicts of interest and the performance of its officers, employees, or agents engaged in the selection, award and administration of contracts supported by these federal funds. At a minimum these safeguards must ensure that no employee, officer or agent must participate in the selection, award, or administration of a contract supported by a Federal award if he or she has a real or apparent conflict of interest. Such a conflict of interest would arise when the employee, officer, or agent, any member of his or her immediate family, his or her partner, or an organization which employs or is about to employ any of the parties indicated in 2 CFR §200.318, has a financial or other interest in or a tangible personal benefit from a firm considered for a contract. The officers, employees, and agents of SALT must neither solicit nor accept gratuities, favors, or anything of monetary value from contractors or parties to subcontracts. These standards of conduct must also provide for disciplinary actions to be applied for violations of such standards by officers, employees, or agents of SALT. If SALT has a parent, affiliate, or subsidiary organization, SALT must also maintain written standards of conduct covering organizational conflicts of interest.

In all cases not governed by 2 CFR Part 200, **SALT** shall comply with the conflict of interest provisions contained in 24 CFR §576.404. Although this summary does not intend to replace §576.404, essentially this rule states that no person who exercises or have exercised any functions or responsibilities with respect to activities assisted with ESG funds, or who is in a position to participate in a decision making process or gain inside information with regard to these activities, may obtain a financial interest or benefit from a ESG assisted activity, or have an interest in any contract, subcontract or agreement with respect thereto, or the proceeds thereunder, either for themselves or those with whom they have family or business ties, during their tenure or for one year thereafter. The "persons" covered in §576.404 include employees, agents, consultants officers, or elected officials or appointed officials of the recipient or of any designated public agencies, or of subrecipients (**SALT**) that are receiving ESG funds. **SALT** shall also keep records supporting requests for waivers of conflicts.

**SALT** will disclose in writing any potential conflict of interest to the City. By executing this Agreement, the Subrecipient covenants and certifies that none of its employees, officers, or agents described in these regulations have any interest in this Agreement or any other interest which would conflict in any manner with this Agreement or the performance of the this Agreement.

Also, in accordance with 24 CFR §576.404, the provision of ESG assistance may not be conditioned on an individual's or family's acceptance or occupancy of emergency shelter or housing owned by the City or **SALT**, or a parent or subsidiary thereof. **SALT** shall not, with regard to individuals or families occupying housing owned by **SALT**, or by any parent or subsidiary thereof, conduct the initial evaluation required under §576.401 or administer homelessness prevention assistance under §576.103.

- 14. <u>Displacement and Relocation:</u> **SALT** shall comply and assist the City in complying with the provisions of 24 CFR §576.408, "Displacement, relocation, and acquisition." **SALT** shall maintain records on households displaced as a result of ESG activities which include race and ethnicity, gender of single heads of households, and addresses and census tracts of the housing units to which each displaced household is relocated pursuant to 24 CFR §576.500(t).
- 15. <u>Disclosure and Lobbying:</u> **SALT** shall comply with the restrictions on disclosure and lobbying contained in 31 U.S.C. §1352 and implementing regulations at 24 CFR Part 87 and shall execute the Certificate Regarding Lobbying, as attached hereto and incorporated herein by reference as **Exhibit "D"**.
- 16. <u>Debarred, Suspended or Ineligible Contractors:</u> **SALT** shall comply with the debarment and suspension requirements set forth in 24 CFR §5 and 2 CFR §2424. **SALT** shall not enter into a contract with any person, **SALT** or entity that is debarred, suspended or otherwise excluded from or ineligible for participation in federal assistance programs under Executive Order 12549 or 12689, "Debarment and Suspension," which is made a part of this Agreement by reference. In the event that **SALT** has entered into a contract or subcontract with a debarred or suspended party, no ESG funds will be provided as reimbursement for the work done by that debarred or suspended contractor or subcontractor.

- 17. <u>Lead Based Paint:</u> The Lead-Based Paint Poisoning Prevention Act (42 U.S.C. 4821-4846), as amended by the Residential Lead-Based Paint Hazard Reduction Act of 1992 (42 U.S.C. 4851-4856) and implementing regulations at 24 CFR Part 35, subparts A, B, H, J, K, M, and R shall apply to all shelters assisted under the ESG program and all housing occupied by program participants. **SALT** shall document whether it is exempt from the Lead Disclosure Rule, the Lead Safe Housing Rule, and EPA's Renovation, Repair, and Painting Rule, and if it is not exempt, it shall document its compliance in accordance with 24 CFR Part 35.
- 18. <u>Habitability Standards:</u> **SALT** shall comply with the requirements set forth in 24 CFR §576.403. If **SALT** is providing rental assistance with ESG funds, **SALT** shall conduct initial and follow-up inspections of housing units into which a program participant will be moving. Units must be inspected on an annual basis and upon a change of tenancy in accordance with the minimum habitability standards attached hereto as **Exhibit "E"**.
- 19. <u>Drug Free Workplace:</u> **SALT** shall comply with the Drug Free Workplace Act of 1988 (41 U.S.C. §701, et. seq.) and HUD's implementing regulations at 2 CFR Part 2429, and agrees to complete and comply with the "Certification Regarding Drug-Free Workplace Requirements" attached hereto as **Exhibit "F"** and incorporated by reference herein and made a part of this Agreement. **SALT** will complete this Certification and a copy shall be kept in the files of each of the parties of this Agreement.
- 20. <u>Confidentiality:</u> **SALT** shall develop, implement, and maintain written procedures to ensure the confidentiality of records pertaining to any individual(s) assisted with ESG funds under this Agreement, and that the address or location of any assisted housing will not be made public in accordance with 24 CFR §576.500(x).
- 21. <u>Registration and Accountability:</u> **SALT** agrees to comply with 2 CFR Parts 25 and 170, and to maintain a current registration in the federal System for Award Management ("SAM") database (<a href="http://www.sam.gov">http://www.sam.gov</a>), formally known as the Central Contractor Registration under 2 CFR §176.50(c), and provide the City with its SAM registration number and legal name as entered into the SAM. A Dun and Bradstreet Data Universal Numbering System (DUNS) Number (<a href="http://www.dnb.com">http://www.dnb.com</a>) is required for registration in SAM. **SALT** shall also complete and sign the Federal Funding Accountability and Transparency Act ("FFATA") Affidavit attached hereto as **Exhibit "G"** in conjunction with its execution of this Agreement, and provide any supporting documentation if required.
- 22. <u>Training:</u> **SALT** shall attend any training sessions, including but not limited to, inperson seminars, webinars, etc...that the City requires.
- 23. <u>Housing Counseling</u>. **SALT** agrees that any housing counseling, as defined in 24 CFR §5.100, that is funded with or provided in connection with ESG funds must be carried out in accordance with 24 CFR §5.111.
- 24. <u>VAWA Protections</u>. **SALT** agrees that all eligibility and termination decisions that are made with respect to ESG rental assistance must comply with the requirements set forth in the Violence Against Women Act of 2013 as provided in 24 CFR Part 5, Subpart L and 24 CFR §576.409. **SALT** shall also document compliance with 24 CFR §500(s)(5) when applicable.

#### **SECTION 3: DEFAULTS AND REMEDIES**

- 1. <u>Events of Default:</u> The following shall constitute an Event of Default under this Agreement:
  - (a) If **SALT** fails to comply with any regulations governing ESG-CV awards, including, but not limited to, 24 CFR Part 576 or fails to comply with any of the terms contained in this Agreement or documents executed in connection therewith, and such failure continues for a period of fifteen (15) days following notice thereof given by the City;
  - (b) If **SALT** fails to provide services to the homeless as described herein or fails to file its report on serving the homeless in the manner set forth herein and the attached exhibits;
  - (c) If at any time any material representation made by **SALT**, or any service provider, in any certification or communication submitted by **SALT** to the City in an effort to induce the making of this grant or the administration thereof is determined by the City to be false, misleading, or incorrect in any material manner;
  - (d) If **SALT** does not disclose to the City upon demand the name of all persons with whom **SALT** has contracted or intends to contract with or provides services to, including contracts for services and/or labor and;
  - (e) If any other default occurs under any of the grant documents executed by **SALT** in connection with this grant by the City (herein the "Grant Documents") which is not elsewhere specifically addressed herein, and such default is not cured within the applicable cure period set forth in the Grant Documents, or if there is no cure period set forth, then within fifteen (15) days following the date of notice to **SALT** thereof; and

Notwithstanding any of the forgoing provisions to the contrary, if **SALT** has failed to cure any default within (5) days prior to the expiration of any applicable cure period, the City may, at its sole option, cure such default, provided, however, that the City shall be under no duty or obligation to do so.

- 2. <u>Remedies for Non-compliance</u>. If **SALT** fails to comply with Federal statutes, regulations, or the terms and conditions of this Agreement, the City may impose additional conditions as described in 2 CFR §200.207. If the City determines that noncompliance cannot be remedied by imposing additional conditions, the City may take one or more of the following actions, including but not limited to:
  - (a) Temporarily withhold cash payment pending correction of the deficiency or more severe enforcement action by the City;

- (b) Disallow both use of funds and any applicable matching credit for all or part of the cost of the activity or action not in compliance;
- (c) Wholly or partly suspend or terminate the award;
- (d) Initiate suspension or debarment proceedings as authorized under 2 CFR Part 180 and applicable regulations or recommend such proceedings be initiated by HUD;
- (e) Withhold further federal awards for the project or program;
- (f) Take other remedies that may be legally available including, but not limited to litigation, declaratory judgment, specific performance, damages, injunctions, enforcement of the Declaration of Restrictive Covenant, termination of the Agreement, or any other available remedies.
- 3. <u>Suspension and Termination:</u> **SALT** and the City will comply with the noncompliance and termination provisions in 2 CFR Part 200. In addition to the remedies for non-compliance in 2 CFR §200.338, in accordance with 2 CFR §\$200.338 and 339, the City may suspend or terminate this Agreement in whole or in part if **SALT** fails to comply with any terms and conditions of this Agreement or upon the occurrence of any Event of Default or any other breach of this Agreement. The City can withhold all funding and disbursements, demand repayment for amounts disbursed, terminate all payments, and/or exercise all rights and remedies available to it under the terms of this Agreement under statutory law, equity or under common law. If the City terminates this Agreement, **SALT** shall also forfeit to the City all unexpended monies awarded under the Agreement. **SALT** may also be required to refund all ESG funds awarded by the City.

In accordance with 2 CFR §200.339, the City can terminate the Agreement with the consent of **SALT** in which case **SALT** and the City must agree upon the termination conditions, including the effective date, and in the case of partial termination, the portion to be terminated.

In accordance with 2 CFR §200.339(a)(4), the Agreement may also be terminated by the **SALT** or the City with written notification setting forth the reason for such termination, the effective date and in the case of partial termination, the portion to be terminated. However, if the City determines in the case of partial termination that the reduced or modified portion of the award will not accomplish the purposes for which the award was made, the City may terminate the award in its entirety.

If this award is terminated or partially terminated, **SALT** remains responsible for compliance with the closeout requirements in 2 CFR §200.343 and post-closeout requirements set forth in 2 CFR §200.344.

All remedies shall be deemed cumulative and, to the extent permitted by law; the election of one or more remedies shall not be construed as a waiver of any other remedy the City may have available to it.

4. <u>No Waiver</u>: Failure of the City to declare a default shall not constitute a waiver of any rights by the City. Furthermore, the waiver of any default by the City shall in no event be construed as a waiver of rights with respect to any other default, past or present.

#### **SECTION 4: INDEMNIFICATION AND INSURANCE**

- 1. <u>Indemnification:</u> **SALT** shall indemnify and save the City harmless from any and all liability, claims, demands, damages, losses, expenses, fees, fines, penalties, suits, proceedings, actions and costs of actions, including attorneys' fees, original and on appeal, arising out of, or related in any way to, or in any way connected with the performance of the Agreement by **SALT** or because of or due to the existence of the Agreement itself.
- 2. <u>Insurance:</u> **SALT** shall have in force the following insurance coverage, if applicable, each of which shall contain a provision which forbids any cancellation, changes or material alterations without prior written notice to the City at least thirty (30) days in advance, and will provide Certificates of Insurance to the City prior to commencing operations under the Agreement to verify such coverage:
  - (a) Workers' Compensation **SALT** shall provide Workers' Compensation Coverage for all employees and, in case any work is subcontracted, will require the subcontractor to provide Workers' Compensation for all its employees. The limits will be statutory for Workers' Compensation and \$100,000.00 for Employer's Liability.
  - (b) Commercial General Liability **SALT** shall provide coverage for all operations including, but not limited to, Contractual, Products and Completed Operations, and Personal Injury. The limits will not be less than Five Hundred Thousand Dollars (\$500,000.00) combined single limit bodily injury and property damage, or its equivalent.
  - (c) Commercial Automobile Liability **SALT** shall provide coverage for all owned, non-owned and hired vehicles utilized in the performance of this Agreement for limits of not less than \$500,000.00 combined single limit bodily injury and property damage, or its equivalent.
  - (d) Employee Honesty Insurance **SALT** shall provide not less than Ten Thousand Dollars (\$10,000.00) coverage limit.

#### **SECTION 5: MISCELLANEOUS PROVISIONS**

- 1. <u>Entire Agreement:</u> This Agreement contains the entire agreement between the parties. Except as set forth herein, this Agreement may only be modified in writing, signed by both of the parties hereto.
- 2. <u>Severability:</u> It is agreed by and between the parties that if any covenant, condition, or provision contained in this Agreement is held to be invalid by any court of competent

jurisdiction, such invalidity shall not affect the validity of any other covenants, condition or provisions herein contained.

- 3. <u>Effective Date:</u> This Agreement shall be effective on April 1, 2021 (herein the "Effective Date") and **SALT** may begin providing services and goods hereunder on such date.
- 4. <u>Assignment</u>: **SALT** shall not assign or transfer any interest in this Agreement without the prior written consent of the City.
- 5. <u>Notices:</u> Whenever by the terms of this Agreement, notice shall or may be given to either party, such notice shall be in writing and shall be hand delivered or sent by certified mail, return receipt requested to:

#### **EXHIBIT "E"**

#### **HUD Habitability Standards for ESG**

Any building for which ESG funds are used for conversation, major rehabilitation, or other renovation must meet state or local government safety and sanitation standards, as applicable, and the following minimum safety, sanitation, and privacy standards. Any emergency shelter that receives ESG funds for shelter operations must also meet the following minimum safety, sanitation, and privacy standards:

- 1. **State and local requirements.** Each contractor must ensure that housing occupied by a family or individual receiving ESG assistance is in compliance with all applicable state and local housing codes, licensing requirements, and any other requirements in the jurisdiction in which the housing is located regarding the condition of the structure and the operation of the housing or services.
- 2. **Habitability standards**. Except for less stringent variations as are proposed by the grantee and approved by HUD, housing occupied by a family or an individual receiving ESG assistance must meet the following minimum requirements:
  - a. **Structure and materials.** The structures must be structurally sound to protect the residents from the elements and not pose any threat to the health and safety of the occupants. Any renovation (including major rehabilitation and conversion) carried out with ESG assistance must use Energy Star and WaterSense products and appliances.
  - b. **Access.** The housing must be accessible and capable of being utilized without unauthorized use of other private properties. Structures must provide alternate means of egress in case of fire.
  - c. **Space and security.** Each resident must be afforded adequate space and security for themselves and their belongings. Each resident must be provided an acceptable place to sleep.
  - d. **Interior air quality.** Every room or space must be provided with natural or mechanical means of ventilation. Structures must be free of pollutants in the air at levels that threaten or harm the health of residents.
  - e. Water supply. The water supply must be free from contamination.
  - f. **Sanitary facilities.** Residents must have access to sufficient sanitary facilities that are in proper operating condition, may be used in privacy, and are adequate for personal cleanliness and the disposal of human waste.
  - g. **Thermal environment.** The housing must have adequate heating and/or cooling facilities in proper operating condition.
  - h. **Illumination and electricity**. The housing must have adequate natural or artificial illumination to permit normal indoor activities and to support the health and safety of residents. Sufficient electrical sources must be provided to permit use of essential electrical appliances while ensuring safety from fire.
  - i. **Food preparation and refuse disposal**. All food preparation areas must contain suitable space and equipment to store, prepare, and serve food in a sanitary manner.
  - j. **Sanitary condition.** The housing and any equipment must be maintained in sanitary condition. **k. Fire safety.** 
    - a. Each unit must include at least one battery-operated or hard wired smoke detector, in property working condition, on each occupied level of the unit.
    - Smoke detectors must be located, to the extent practicable, in a hallway adjacent to a bedroom. If the unit is occupied by hearing impaired persons,
    - smoke detectors must have an alarm system designed for hearing-impaired persons in each bedroom occupied by a hearing-impaired person.
    - b. The public areas of all housing must be equipped with a sufficient number, but not less than one for each area, of battery-operated or hard-wired smoke detectors. Public areas include, but are not limited to, laundry rooms, community rooms, day care centers, hallways, stairwells, and other common areas.
