AN ORDINANCE OF THE CITY OF ORLANDO, FLORIDA, **AMENDING** THE **CITY'S ADOPTED GROWTH** MANAGEMENT PLAN BY AMENDING THE CITY'S FUTURE LAND USE MAP **DESIGNATION FROM** RESIDENTIAL MEDIUM INTENSITY TO OFFICE LOW **INTENSITY CERTAIN REAL PROPERTY** ON GENERALLY LOCATED NORTH OF VASSAR ST., SOUTH OF RUGBY ST., EAST OF HOLLY LN., AND WEST OF EDGEWATER DR.; COMPRISED OF 0.179 ACRES, MORE OR LESS; AMENDING THE ZONING CLASSIFICATION FROM R-3B/T/W/SP/AR TO 1/T/W/SP/AR FOR THE SAME REAL PROPERTY; DIRECTING AMENDMENT OF THE CITY'S OFFICIAL FUTURE LAND USE AND ZONING MAPS; PROVIDING FOR SEVERABILITY, CORRECTION OF SCRIVENER'S ERRORS, AND AN EFFECTIVE DATE.

BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, AS FOLLOWS:

SECTION 1. GMP AMENDMENT. Pursuant to section 163.3187, Florida Statutes, the City of Orlando, Florida, hereby amends the Future Land Use Map designation for the real property described in Exhibit "A" to this ordinance (the "Property") from Residential Medium Intensity to Office Low Intensity, as depicted in Exhibit "B" to this ordinance.

SECTION 2. AMENDMENT OF FLUM. The City Planning Official, or designee, is hereby directed to amend the City's adopted Future Land Use Map in accordance with this ordinance.

SECTION 3. ZONING DESIGNATION. Pursuant to the City's Land Development Code, the zoning designation for the Property is hereby amended from Residential Medium Intensity with Traditional City, Wekiva, Special Planned and Appearance Review Overlay District ("R-3B/T/W/SP/AR") to Office Low Intensity with Traditional City, Wekiva, Special Planned and Appearance Review Overlay District ("O-1/T/W/SP/AR"), as depicted in Exhibit "C" to this ordinance.

SECTION 4. AMENDMENT OF OFFICIAL ZONING MAP. The City Zoning Official, or designee, is hereby directed to amend the City's official zoning map in accordance with this ordinance.

SECTION 5. SCRIVENER'S ERROR. The City Attorney may correct scrivener's errors found in this ordinance by filing a corrected copy of this ordinance with the City Clerk.

SECTION 6. SEVERABILITY. If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are severable.

48 49 **SECTION 7. EFFECTIVE DATE.** The effective date of this plan amendment, if the 50 amendment is not timely challenged, shall be 31 days from the adoption of this ordinance. If 51 timely challenged, this amendment shall become effective on the date the state land planning 52 agency or the Administration Commission enters a final order determining this adopted 53 amendment to be in compliance. No development orders, development permits, or land uses 54 dependent on this amendment may be issued or commence before it has become effective.
