TERMINATION OF STIPULATION AND ACCESS EASEMENT

THIS TERMINATION OF STIPULATION AND ACCESS EASEMENT (the "Agreement") is hereby made as of the _____ day of ______, 2014, by EQUITY ONE (FLORIDA PORTFOLIO) INC., a Florida corporation ("Equity One") whose address is 1600 NE Miami Gardens Drive, North Miami Beach, Florida 33179.

RECITALS:

WHEREAS, Turkey Lake Shopping Center, Inc., a Florida corporation, ("Turkey Lake") entered into that certain Stipulation with the City of Orlando (the "City") dated October 17, 1991 and recorded October 21, 1991 in Official Records Book 4337, Page 4025, of the Public Records of Orange County, Florida (the "Stipulation") which Stipulation provided that Turkey Lake would provide access over a portion of its property (described as "Parcel A" in the Stipulation) for the benefit of an adjoining piece of property (described as "Parcel B" in the Stipulation); and

WHEREAS, pursuant to the terms of the Stipulation, Turkey Lake executed and recorded that certain Declaration of Access Easement dated October 7, 1991 and recorded October 23, 1991 in Official Records Book 4338, Page 4689, of the Public Records of Orange County, Florida (the "Access Easement"); and

WHEREAS, Equity One now owns fee simple title to Parcels A and B and is in the process of replatting both properties and providing reciprocal access over both properties; and

WHEREAS, Equity One, as the owner of Parcels A and B, desires to terminate the Stipulation and Access Easement effective upon the recording of this Agreement in the Public Records of Orange County, Florida; and

WHEREAS, the City has consented to the termination of the Stipulation and the Access Easement as required by the terms thereof.

NOW, THEREFORE, for in consideration of the mutual promises and covenants contained herein, and other good and valuable consideration, the receipt, adequacy and sufficiency of which is hereby acknowledged, Equity One hereby agrees as follows:

1. The Recitals set forth above are true and correct and incorporated by reference herein.

2. The Stipulation and Access Easement are hereby terminated and shall be of no further force and effect, effective upon the recording of this Agreement in the Public Records of Orange County, Florida.

3. The City has executed the attached Joinder and Consent acknowledging its consent to the termination of the Stipulation and Access Easement. The City's consent herein is

based on the fact that Equity One is establishing alternative cross access easement(s) for the benefit of Parcels A and B as part of the replatting process.
