

1           **AN ORDINANCE OF THE CITY COUNCIL OF THE CITY**  
2           **OF ORLANDO, FLORIDA, ANNEXING TO THE**  
3           **CORPORATE LIMITS OF THE CITY OF ORLANDO,**  
4           **FLORIDA, CERTAIN REAL PROPERTY GENERALLY**  
5           **LOCATED AT THE NORTHEAST CORNER OF THE**  
6           **INTERSECTION OF STATE ROAD 417 AND MOSS**  
7           **PARK ROAD, AND COMPRISED OF 16.13 ACRES,**  
8           **MORE OR LESS; PROVIDING FOR SEVERABILITY,**  
9           **CORRECTION OF SCRIVENER'S ERRORS, AND AN**  
10          **EFFECTIVE DATE.**

12           **BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF ORLANDO,**  
13          **FLORIDA, AS FOLLOWS:**

15           **SECTION 1. ANNEXATION.** Pursuant to the authority granted by section  
16          171.044, Florida Statutes, and having determined that the owner or owners of the real  
17          property described in Exhibit "A" (the "Property") to this ordinance have petitioned the  
18          City Council of the City of Orlando, Florida (the "Orlando City Council"), for annexation  
19          into the corporate limits of the City of Orlando, and having determined that the petition  
20          bears the signatures of all owners of property in the area proposed to be annexed, the  
21          Property is hereby annexed into the corporate limits of the City of Orlando, Florida.

23           **SECTION 2. OFFICIAL MAPS.** The City Planning Official, or designee, is  
24          hereby directed to amend the City's official maps in accordance with this ordinance.

26           **SECTION 3. SCRIVENER'S ERROR.** The City Attorney may correct scrivener's  
27          errors found in this ordinance by filing a corrected copy of this ordinance with the City  
28          Clerk.

30           **SECTION 4. SEVERABILITY.** If any provision of this ordinance or its  
31          application to any person or circumstance is held invalid, the invalidity does not affect  
32          other provisions or applications of this ordinance which can be given effect without the  
33          invalid provision or application, and to this end the provisions of this ordinance are  
34          severable.

36           **SECTION 5. EFFECTIVE DATE.** This ordinance takes effect upon adoption  
37          except for sections 1 and 2 which take effect on the 30<sup>th</sup> day after adoption.
