* * Outdoor Loudspeaker Restrictions / Conditions * *

City code 42.07 - Mechanical Loudspeakers or Amplifiers: 1) It shall be unlawful to use any Mechanical Loudspeaker or other sound-amplifying device on a truck or other moving vehicle or out of doors on public or private property except under a permit issued by the Chief of Police. 2) No person shall use a loudspeaker or other sound-amplifying device between the hours of 10:00 pm and 7:00 am. 3) No person shall use a loudspeaker or other sound-amplifying device within 1,000 feet of any school, church, hospital, court of law, or public transportation facility without the permission of that property owner. If this applies to your permit application, do you have the permission (letter must be attached)? 4) the activity will not interfere with any governmental function or with any event scheduled through the Parks and Recreation Department, and is not for a fixed location within 1,000 feet of any activity previously permitted under this section for the same date and time.
