1. Call to order and determination of a quorum

The meeting was called to order at 9:06 A.M.

2. Public comment

Doug Doudney expressed his concern with the referendum process and Orlando Health's role as a stakeholder. Chairman Rex McPherson commented on Orlando Health's PILOT payment. Dan Peterson suggested improving communication and outreach with stakeholders in the district.

3. Review and approval of minutes

Chairman Rex McPherson opened the floor for additions or corrections to the minutes of the May 14, 2014 Advisory Council meeting. Hearing none, the minutes were approved as submitted.

4. Staff reports

Eminent Domain Power

Kyle Shephard briefed the board as a follow up to a question on Eminent Domain posed at May's meeting. Eminent domain is the exercise of the power of government to acquire private property necessary for a public use on the payment of just compensation and following due process of law. In Florida, there are eight different types of neighborhood improvement districts. The DSNID is a local government NID, and does not have Eminent Domain power. DSNID's Board of Directors is the City Council, and the City of Orlando always has the ability to exercise Eminent Domain.

Referendum Results, Projected Revenue, and CIP Update

Jason Burton reported a 41% turnout of 56% of the value of the district for the ad valorem referendum. A total of 514 of the 1,160 ballots mailed were returned. Of the 514 ballots counted, 323 voted "Yes" and 191 voted "No." The results were certified by the City Clerk within the 5 day requirement and presented to City Council. Property

Appraiser Singh's office has been notified, and TRIM notices will be adjusted to reflect the ad valorem assessment. Jason Burton noted the initial projected revenue of approximately \$407,000, and outlined preliminary uses of funding to include administration, marketing, transportation, and Division Avenue improvements. The City of Orlando's Streets and Stormwater Division are working on making improvements to drainage on Division Avenue, which will benefit the water quality of Lake Holden. A potential use of NID funds could include supplementing this project by extending sidewalks (to include the Orlando Urban Trail), streetscape, and on-street parking. Other NID funded enhancements could include bike path improvements, and planting costs for additional street trees. Jon Toothman asked a question about the need for on street parking on Division Avenue. Bill Nassal commented on the problem of trucks parked in the center lane of Division Avenue. Jason Burton addressed Doug Doudney's question regarding landscape islands, which will not be included in the final plans for Division Avenue. Mr. Burton also explained that going forward a capital budget would be set for the district, and NID funds could be used for future projects on an as needed basis. Kyle Shephard noted that some of the district's monies could be used as a local match to receive state and federal funding for capital improvement projects. Mary Hurley asked a question regarding broadband service in the district. Jason Burton reviewed the NID's fiscal year; having \$156,228 for the year and \$129,950 in expenditures to date. He noted these numbers do not include reserves from previous fiscal years.

A more detailed financial accounting will be presented at July's meeting.

5. Calendar

The next meeting will be held on Wednesday, July 16, 2014 at 9:00 A.M. in the Veterans Conference Room, City Hall.

6. Announcements and other business

Jason Burton informed the Board that the City has started using a new financial program called Workday. Mary Hurley and Bill Nassal are not able to attend the July 9, 2014 meeting. The meeting has been rescheduled for July 16th. Kyle Shephard noted that City staff will discuss ways to improve disseminating DSNID information to the public. Chairman Rex McPherson thanked Dana Loncar with Consensus Communications, and Rich Crotty, Molly Delahunty, and Christina Almanzar with Richard Crotty Consulting Group for their consulting services in effectively managing the referendum process to its conclusion.

7. Adjourn

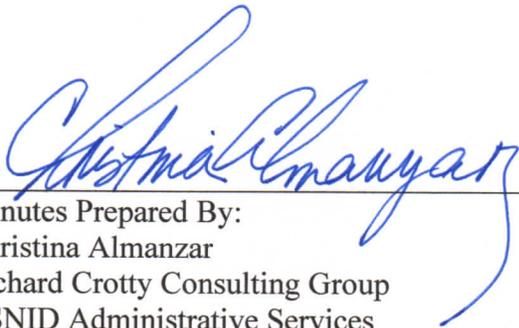

Certification of Results of the Downtown South Neighborhood Improvement District Referendum

On May 21, 2014 at 1:00 p.m., the results of the Downtown South Neighborhood Improvement District Referendum were tallied.

The following individuals participated in the tallying:

The question posed on the ballot was as follows:

“Do you favor authorizing the Downtown South Neighborhood Improvement District to levy up to 2 mills of ad valorem taxes for no more than 15 years?”

A total of 514 ballots were voted. The results were as follows:

Yes	No
\$143,077,711 (323 properties)	\$86,386,493 (191 properties)

Based on these results, the referendum was approved by the voters.

A further accounting of the ballots is as follows:

A total of 1160 ballots (representing 1160 properties) were mailed out on May 5, 2014 representing a total assessed value of \$407,984,343. The ballots were due in the City Clerk’s office by 7 p.m. on May 20, 2014. 514 of those ballots were counted in the referendum. Of the 514 ballots, the following were reviewed as unusual but were counted:

- Three were signed by the voter but their name was not printed on the envelope.
- One voter had added his wife’s signature to the ballot in addition to his signature.
- Three ballots were received from one voter in only one envelope.
- One ballot which had been properly executed and enclosed in the ballot envelope which had then been placed in a plain white envelope and mailed.

All of these ballots were accepted and are included in the 514 total.

646 property holders either did not vote or the ballots were not counted for the following reasons:

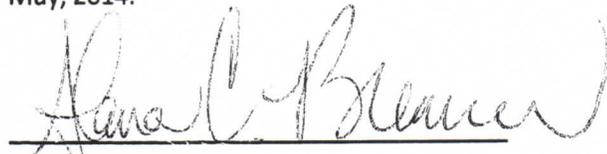
- 29 ballots were returned to the Clerk's Office as undeliverable.
- 4 ballots were received on May 21, 2014, and 2 ballots were received on May 22, 2014, beyond the time frame set up in the ordinance and were thus received too late to be counted.
- Copies of 2 ballots were faxed to the Clerk's office and were rejected as not complying with the ordinance.
- 3 ballots were not signed by the voter nor witnessed as required by the ordinance and thus were rejected.
- 6 ballots were not properly witnessed as required by the ordinance and thus were rejected.
- 2 ballots were not signed by the voter and thus were rejected.
- One ballot was returned but had been cut off so that no vote was included.
