AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, REZONING **CERTAIN** LAND **GENERALLY** LOCATED **NORTHEAST** OF HOURGLASS AND SOUTHWEST OF THE INTERSECTION OF CURRY FORD RD. AND CLOVERLAWN AVE., AND COMPRISED OF 0.96 ACRES OF LAND, MORE OR LESS, FROM THE PLANNED DEVELOPMENT DISTRICT WITH THE TRADITIONAL CITY OVERLAY DISTRICT TO THE R-1 SINGLE FAMILY RESIDENTIAL DISTRICT WITH THE TRADITIONAL CITY OVERLAY DISTRICT; PROVIDING FOR AMENDMENT OF THE CITY'S OFFICIAL ZONING MAPS: PROVIDING FOR SEVERABILITY, **CORRECTION OF** SCRIVENER'S ERRORS, AND AN EFFECTIVE DATE.

WHEREAS, at its regularly scheduled meeting of June 17, 2014, the Municipal Planning Board (the "MPB") of the City of Orlando, Florida (the "City"), considered zoning application case number ZON2014-00011, requesting an amendment to the City's official zoning maps for approximately 0.96 acres of land, generally located northeast of Lake Hourglass and southwest of the intersection of Curry Ford Road and Cloverlawn Avenue, and more precisely described by the legal description attached to this ordinance as Exhibit "A" (hereinafter the "Property"); and

WHEREAS, based upon the evidence presented to the MPB, including the information and analysis contained in the "Staff Report to the Municipal Planning Board" for application case number ZON2014-00011 (entitled "Item #6 – Clarke Rezoning" and hereinafter referred to as the "Staff Report"), the MPB recommended that the City Council of the City of Orlando, Florida (the "Orlando City Council"), approve zoning application case number ZON2014-00011 and adopt an ordinance in accordance therewith; and

WHEREAS, the MPB found that application case number ZON2014-00011 is consistent with:

- The City of Orlando Growth Management Plan, adopted as the City's "comprehensive plan" for purposes of the Florida Community Planning Act, sections 163.3164 through 163.3217, Florida Statutes (2013) (the "GMP"); and
- 2. The City of Orlando Land Development Code, Chapters 58 through 68, Code of the City of Orlando, Florida (the "LDC"); and

WHEREAS, the Orlando City Council hereby finds that this ordinance is in the best interest of the public health, safety, and welfare, and is consistent with the applicable provisions of the City's GMP and LDC; and

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, AS FOLLOWS:

SECTION 1. ZONING MAP DESIGNATION. Pursuant to the City's Land Development Code, the zoning designation for the Property is hereby changed from the Planned Development district with the Traditional City overlay district (denoted as "PD/T" on the City's official zoning maps) to the R-1 Single Family Residential District with the Traditional City overlay district
