# FY2013/14 BUDGET NEW BUSINESS:

### 1. WASTEWATER R&R FUND

A. BR14-70, Project No. CIP0128\_P – Public Works – request to transfer budget to Lift Station 143 Odor Control project necessary for improvements required by development around Mall at Millenia. Transfer of Existing Funds: \$1,036,346.

## 2. GRANT FUND

- A. BA14-71, Grant No. PKS0001\_G and PKS0002\_G Families, Parks & Recreation request to budget the Orange County 2014 Cultural Facilities Grant Replacement of Lake Eola Amphitheater Sound Board and the subsequent matching funds from the CRA and the Orlando Community Youth Trust, as approved by City Council on July 14, 2014. Net increase: Grant Fund \$25,000, Net Increase: Designated Revenue Fund \$25,000 and Transfer of Existing Funding CRA Operating Fund \$12,500.
- B. BA14-72, Grant No. TSP0006\_G Economic Development request to budget funding received from FDOT New Starts Grant to widen Columbia St. between Sligh Blvd. and South Orange Avenue, as approved by City Council on June 23, 2014. Net increase: \$1,500,000.
- C. BA14-74, Grant No. OFD0010\_G and OFD0011\_G Fire Department request to budget funding received from for the Assistance to Firefighters Grant (AFG) 2013 to fund the OFD GOLD Officer Development Program, as approved by City Council on July 28, 2014. Net Increase: Grant Fund \$127,709 and Net Increase: Designated Revenue Fund \$14,189.

3. Designated Revenue Fund

A. BA14-75, Project No. FPR0002\_P – Families, Parks and Recreation - Request to add six (6) Contract positions with full benefits to the PKZ Program in support of Children and Education. The positions will be funded with a donation from the Orlando Community and Youth Trust, Inc., existing City of Orlando seasonal budget and a contribution from the After School All Stars non-profit. Net Increase: Designated Revenue Fund \$307,068 and Net Decrease: General Fund \$86,496.

4. GENERAL FUND

B. Families, Parks and Recreation – FPR0003\_C - Request to add three (3) Youth Activity Coordinators, one (1) Academic Program Support Specialist, one (1)

Marketing Specialist, and one (1) Grants Accountant.
