It was moved by Ramesh Panchal, seconded by Charles Hawkins II and vote carried unanimously to re-certify Interra, Inc., as an MBE in Geotechnical Engineering: Typical; Airports; Research; Quality Assurance; Misc: Material Testing; Urban Planning, Construction Inspection; and Bituminous Mix Designs.

Brown Brothers the Family, LLC. – Laletta Dawson, Owner appeared before the Board. Discussion ensued. It was moved by Charles Hawkins II, seconded by Bruno Portigliatti and vote carried unanimously to re-certify Brown Brothers the Family, LLC., as an M/WBE in Concrete Work – Gutters, Curb Elements, Sidewalks, Traffic Separators, Ditch and Slope Pavements, Manholes and Junction Boxes.

Lawton Printers, Inc. – The applicant did not appear before the Board. Discussion ensued. It was moved by Brikena Tomasic, seconded by Ramesh Panchal and vote carried unanimously to deny WBE status to Lawton Printers, Inc., based on:

- 1. The business concern must be at least 51% owned by minority group members or at least 51% owned by women group members, as characterized by:
 - a. Independent contribution of capital by the minority or the women group members commensurate with percent of ownership claimed. Ownership gifted to minority or women owners, equipment or other assets gifted, and/or funds gifted to purchase ownership or to establish a new business will not be considered independent contributions of capital. Inherited capital or assets will not be considered as gifted for purposes of these rules.
- 2. The company is not considered an independent women-owned enterprise because the husband and/or other male principal:
 - a. Assists in obtaining credit, loans, bonding, leases, etc.

<u>Almond Consulting Group, Inc.</u> – The applicant did not appear before the Board. Discussion ensued.
