### A. MLS Soccer Stadium Art Selection

Paul Wenzel read an email from Allen Johnson stating, "Inform the Board that the process of constructing the Soccer stadium is similar to the Amway Center in that the Soccer team will be responsible for the design, artwork and construction of the stadium not the City so it would be like any other developer process." Discussion ensued by the Board. Mr. Wenzel inquired with Amy lennaco, at the City's Legal department, and she confirmed that there is a 1% commitment by the City for this project.

It was suggested by Ms. lennaco for Mr. Wenzel to speak with Craig Borkon, project manager of the soccer stadium, about meeting with a group regarding the stadium. The group would consist of Craig Borkon, Paul Wenzel, Public Art Coordinator, a member of the Public Art Advisory Board, a representative of Development Team and a member from Orlando City Soccer meet and discuss the art

selection process for the soccer stadium. Robert Bowden, Deputy Director Orlando Venues Department would also be in attendance of the group meeting. Discussion ensued by the Public Art Advisory Board.

Paul Wenzel will report back to the Board after speaking with Craig Borkon. Jim Lussier is available with Mr. Wenzel to meet with Craig Borkon.

The Board reviewed the submission rules and application for the Call to Artists for Orlando City Lions Soccer Stadium. Discussion ensued by the Board on the artistic theme and agreement on emphasizing the essence of the Parramore community.
