Name of Grant: Lake Fairview Renovation Phase 1 FRDAP Grant				

Short description of the project or program that will be pursued with grant funding:

Lake Fairview Park and Trotters Park were re-master planned in 2009 in a manner that coordinates how the two parks work together since they are in close proximity to one other. Improvements to these parks will occur in phases as funding becomes available.

Phase 1 for Lake Fairview Park encompasses the shoreline. Currently an old beach house/concession stand, rented boating facilities, and a shoreline park is located there. The beach house/concession is unused and in poor condition and the beach has not been used for a number of years because of low demand and water quality issues. Phase 1 will remove the beach house/concession, clean up the shore area, construct picnic facilities with pavilions, install a new playground, and if funding allows, build a boardwalk and improve the boat ramp. This grant, if awarded, will not impact the City's current agreements with the Orlando Rowing Club or Edgewater Crew for the boating facilities they rent at the Park.

We seek approval to apply for a Florida Recreation Development Assistance Program (FRDAP) grant to carry out Phase 1 of the Lake Fairview master plan. If awarded, a FRDAP grant will be used to develop an underused portion of the park into a desirable recreation area, without negatively impacting the boating facilities at the park. This will be a re-submission for this project. Although the application scored well in the past funding cycle, State funding was insufficient to fund to the project's ranking. Additional State funds are anticipated for these projects next year.

Short description of the problem or need for the project or program: Currently, the most desirable part of the park, the lake shore, is fenced off and cut off from public access. This renovation will open the shore area up for public use and provide desired amenities for public use, while also creating protective fencing around the rented boating area, designed in collaboration with Orlando Rowing Club and Edgewater Crew.
