RELEASE OF EASEMENT

The City, for itself, and its successors and assigns hereby declares that any and all right, title, interest, claim, or demand of the City, in and to the Easement Property, regardless of how acquired including, but not limited to, pursuant to the Easement, is hereby forever released, discharged, and terminated and shall be of no further force and effect and by these presents the City does release, discharge, and terminate forever all of the right, title, interest, claim and demand which the City may have in and to the Easement Property.
- 2. <u>Counterparts</u>. This Release may be executed in counterparts, each of which shall constitute an original, all of which shall constitute one and the same document and together shall constitute the complete agreement of the parties hereto.
- 3. Recording. Upon execution, this Release shall be recorded in the Public Records of Orange County, Florida and shall run with the property underlying the Easement Property.
