

A meeting of the City of Orlando Certification Board was held on Wednesday, January 28, 2015, at City Hall, 400 S. Orange Avenue, 2nd Floor Agenda Conference Room, Orlando, Florida 32801.

Brikena Tomasic, Chairperson called the Certification Board meeting to order at 9:15 a.m.

The minutes from the December 17, 2014 meeting were approved as written.
