- 3. (a) Board's Purpose The AHAC reviews established policies and procedures, ordinances, land development regulations, and adopted local comprehensive plans and makes recommendations to encourage or facilitate affordable and attainable housing.
  - (b) Number of meetings held from September 30, 2013 October 1, 2014; one (1).
  - (c) No major initiatives or significant accomplishments were undertaken during the year.
    - The following issues were discussed with the Affordable Housing Advisory Committee.
    - ➤ The amendment to the Local Housing Assistant Plan (LHAP) to meet the goals described in Senate Bill 1852 and approved by City Council on August 26, 2013 per AHAC's recommendation. The City will set aside 20% of their SHIP allocation for households with special needs persons. First priority will be given to person with developmental disabilities with an emphasis on home modifications, including technological enhancements and devices, which will allow the

- homeowners to remain independent in their own homes and maintain their homeownership. The funding must be committed by June 30, 2015 and spent by September 30, 2015.
- ➤ Projects that received Affordable Housing Certification by the City: Lexington Court Apartments and The Fountains at Lingo Cove Apartments. Both projects were successful in receiving State Tax Credits for Low-Income Housing.
