 - A. Purpose of Board—administers and enforces the Civil Service Act and Code of Rules for firefighters and police officers; provides examinations, maintains eligibility lists, conducts investigations and hears appeals.
 - B. Number of meetings held during fiscal year October 2013—September 2014 = seven meetings. There were six regularly scheduled meetings and one special meeting held during the fiscal year.
 - C. Workload report: The Board conducted the following business related to the Orlando Police Department and Orlando Fire Department. The Board heard and rendered a decision on one (1) General Appearance (GA #13-03).

The Orlando Police Department (OPD) appointed 42 Temporary Civilian Employees and 15 Probationary Police Officers. Ten employees were promoted to Police Sergeant, six employees were promoted to Police Lieutenant, and four employees were promoted to Police Captain. One employee was appointed to Deputy Chief of Police and an employee was appointed to the Chief of Police. The Civil Service Board modified Section X of the Orlando Police Department's Hiring Standards.

The Orlando Fire Department appointed ten individuals to the position of Probationary Firefighter. Nine employees were promoted to the rank of Engineer and eight employees were promoted to Lieutenant. Additionally, three employees were promoted to District Chief and one was promoted to Assistant Chief. Two employees were appointed to the position of Deputy Chief. A promotional examination was held for the rank of Engineer (promotional list certified December 17, 2013). Two promotional examinations were held for the rank of Assistant Chief (promotional lists certified January 30, 2014 and August 28, 2014). A hiring process was held for the rank of Firefighter (hiring eligibility list certified March 27, 2014). A promotional examination was held for the rank of District Chief (promotional list certified June 27, 2014).

The Civil Service Board held a workshop meeting where the Orlando Fire Department's Engineer's Promotional Process was discussed.
