Any additional funds included within the budget by the attached amendment constitute additional revenue anticipated and/or the excess of surplus from the fiscal year beginning October 1, 2014, and ending September 30, 2015. Such Budget Amendment Nos. BA15-40, BA15-53, BA15-38, BA15-52, BA15-45, BA15-46, BA15-47 and BA15-48 were approved by the Budget Review Committee at its meeting held April 14, 2015.
