

1 **AN ORDINANCE OF THE CITY COUNCIL OF THE CITY**
2 **OF ORLANDO, FLORIDA, DELETING IN ITS ENTIRETY**
3 **AND RESERVING FOR FUTURE USE CHAPTER 15 OF**
4 **THE CODE OF THE CITY OF ORLANDO, FLORIDA,**
5 **ENTITLED, "CAMPING GROUNDS"; PROVIDING FOR**
6 **CODIFICATION, CORRECTION OF SCRIVENER'S**
7 **ERRORS, SEVERABILITY, AND AN EFFECTIVE DATE.**

10 **NOW, THEREFORE, BE IT ENACTED AND ORDAINED BY THE CITY**
11 **COUNCIL OF THE CITY OF ORLANDO, FLORIDA:**

13 **SECTION ONE.** Chapter 15 of the City Code of the City of Orlando is hereby
14 deleted in its entirety and reserved for future use.

16 **SECTION TWO. CODIFICATION.** The City Clerk and the City Attorney shall cause
17 the Code of the City of Orlando, Florida, to be amended as provided by this ordinance and may
18 renumber, re-letter, and rearrange the codified parts of this ordinance if necessary to facilitate
19 finding the law.

21 **SECTION THREE. SCRIVENER'S ERROR.** The City Attorney may correct
22 scrivener's errors found in this ordinance by filing a corrected copy of this ordinance with the
23 City Clerk.

25 **SECTION FOUR. SEVERABILITY.** If any provision of this ordinance or its
26 application to any person or circumstance is held invalid, the invalidity does not affect other
27 provisions or applications of this ordinance which can be given effect without the invalid
28 provision or application, and to this end the provisions of this ordinance are severable.

30 **SECTION FIVE. EFFECTIVE DATE.** This ordinance takes effect upon adoption.
