Call to Order

Chairman Rex McPherson called the meeting to order at 9:03 A.M.

Public Comment

There was no public comment

Chairman Rex McPherson opened the floor for additions or corrections to:

Meeting Minutes of March 11, 2015

Hearing no objections, Chairman McPherson asked that the Advisory Council accept the minutes, which was done by unanimous voice of those present.

Staff Reports

- a. New Board Member. Chairman McPherson introduced new Advisory Council member, Mr. Adam Freeman. Mr. Freeman is employed with A-1 Block located at 1617 S. Division Street and serves as the appointed representative of the industrial property owners. He is a life-long resident of Orlando.
- b. Executive Director's Report & Financials. Mr. Jerry Presley, Executive Director, provided a brief overview of the District's finances. As of May 12, 2015, the DSNID has collected \$502,146.49 in Ad Valorem Taxes and \$3,425.00 in interest income. The total revenues collected were \$505,571.49. The District incurred \$7,684.60 in expenses and encumbered \$34,378.61 for contractual services with Downtown South Main Street. Mr. Presley then provided a brief review of staff activities since the last Advisory Council meeting. (See attached reports for details.)

c. Downtown South Project Updates

- I-4 Palm Tree Relocations. Mr. Presley reported that the palm tree relocation has begun. Five palms have been relocated to three properties in the District and were installed on May 11th and 12th. Two Canary Island Date Palms were placed at Iberia Bank and two were placed at the Purdy property. One Dactylifera Date Palm was placed at the Pulse Club. Mr. Presley reported that the agreement with BB&T and Compton Properties fell through because the parties could not reach agreement. Compton asked to have the property removed from consideration in the relocation program. The total cost to DSNID was \$26,000.00. (See attached report for details.) There was a brief discussion on the matter. Chairman McPherson requested that staff take pictures of the project and send to the members. **Council Actions: *No action was required.***
- Division Avenue Upgrades. Mr. Presley reported that DSNID is actively partnering with the City of Orlando to make improvements to Division Avenue as part of the I-4 Project. The goal is to enhance stormwater management, improve heavy truck and vehicle mobility, add pedestrian and bicycle facilities and enhance aesthetics along the corridor. Mr. Presley indicated that funds previously identified for the project had been diverted to repairs along Bumby Avenue. This will result in a delay in the project for up to a year. The DSNID has the opportunity to assist the City and could possible kick-start the project by committing some funding for preliminary design & engineering. There was brief discussion on the matter. **Council Actions: *No action was required.***
- d. New Development Report. Mr. Burton presented a map detailing current projects within the District and provided a brief description of recent construction activity that has occurred and what stage each project was in. The projects discussed included: Westminster expansion, Lucerene Hospital redevelopment, Hampton Inn, Columbia Street medical office building, AmTrack Station rehab, ORMC Expansions, Lake of the Woods Apts, Lake Copeland development, Winters Hotel, Newton Corner retail, Hughes Supply redevelopment, Icon Residential, Christ Church expansion, ABC redevelopment, Noodles & Co., Twistee Treat and an unnamed restraint/retail development near Orange & Muriel. **Council Actions: *No action was required.***

Action Items

- a. FY 2015-16 Proposed Budget. Mr. Presley provided a brief summary of the proposed FY 2015-16 Budget drafted for the DSNID. He explained that total projected expenses would be \$450,000 and projected revenues would be \$450,000 in the budget. Anticipated expenses included \$70,000 for Administration Contractual Services, \$24,000 for Marketing services, \$100,000 for Michigan & Orange Avenue improvements, \$171,000 for Division Street improvements and \$85,000 for aesthetic improvements. The actual funding of projects may vary based on the approved Capital Improvements Plan for the District which has yet to be created. There was an

in-depth discussion among the Council on the matter. Council member Gravitte inquired about the generic presentation of the budget. Staff explained that the City doesn't require specifics only general categorical expenditures. The DSNID would determine the specific projects that would be funded. Council member Toothman inquired about marketing expenses. Staff explained that an actual marketing program has not yet been developed but is something that is planned. There was a discussion about Division Avenue funding and Orange/Michigan Intersection improvements. Council member Toothman expressed concern and reservation about funding such a project because he felt it would better serve the community to route trucks further south closer to Lancaster Drive or Oakridge Road rather than bringing them into Downtown South. Staff explained that FDOT would not likely be favorable of the matter and it could negatively impact current plans. Council member Koch further inquired if the project was in-line with overall improvement goals of the District.

ACTION: Council Member Gravitte made a motion to approve the proposed budget for FY 15-16. Council member Toothman seconded the motion. The motion was unanimously approved.

Discussion Items

- a. Downtown South Vision & Capital Improvements Plan. Mr. Presley provided a brief summary of the current established Vision of the DSNID. He also reviewed the vision created under the Downtown South Master Plan and the Michigan/Orange Avenues vision. Finally he reviewed the specific goals established under the DSNID Improvement Plan. Mr. Presley advised that over the next couple of months the NID needs to create a long-term Capital Improvements Plan (10-20yr Plan) and a short-term CIP (1-5 year plan). The purpose is to establish a clear plan and strategy for executing infrastructure improvements within the District. He added that DSNID would also look at establishing clear policies and programs that further land use, economic development and crime prevention goals and objectives within the District. This item will appear on the next agenda for detailed discussions by the Advisory Council. Chairman McPherson requested that the planning documents be emailed to the Advisory Council. **Council Actions: *No action was required.***
- b. Downtown South Pillars Initiative. Mr. Presley provided a brief overview of the item. He advised that the purpose of the Pillar's Initiative is to build a volunteer force for advocating positive and constructive change within Downtown South. The program is a voluntary, honor based program whereby participants sign a pledge making a personal commitment to be leaders in the community and embrace three key principals necessary for success. (See attachments for details.) Mr. Presley explained that the exact wording of the document may change depending on how the Advisory Council felt. The Downtown South Main Street Board approved participation at its April meeting. Mr. Presley advised that the document presented is just a draft document and is an example based on what he used in the Pine Hills Community while serving there. Mr. Presley explained that prior to implementation the Advisory Council will need to approve the program and then it will be sent to the Board of Directors (City Council) for final

approval. There was a brief discussion on the matter. Council member Toothman inquired how the program would be marketed to stakeholders. Mr. Presley advised that the typical process is grass roots and marketing would be done via door-to-visits to local businesses and promotions at community events. Staff would also reach out to property owners by targeting key property owners in the District. Most of the cost would be incurred by Main Street. **Council Actions: *No action was required.***

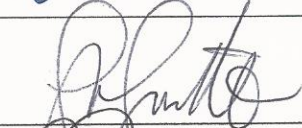

Executive Director's DSNID Monthly Report

Financial Summary

As of 5/12/15 the DSNID has received **\$502,146.49** from Ad Valorem Tax collections and **\$3,425.00** in Interest Revenues for FY 2014-15. Total Revenues are **\$505,571.49**. DSNID incurred **\$7,684.60** in expenses. An additional **\$34,378.61** is encumbered for Administration Contractual Services with Downtown South Main Street for the Executive Director's Salary and Benefits for the remainder of FY 14-15. (See attached financial report for complete details.)

Monthly Activities Update

DTS Executive Director, Mr. Jerry Presley, began his official service with DTS on Monday, March 23, 2015. Since that time he has committed his effort to orienting himself to the DSNID. He has been developing relationships with property owners, key stakeholders, city officials and various agency representatives.

During the last two months, Downtown South staff engaged in the following activities:

➤ Key events/meetings:

- Executive Director met w/City of Orlando Main Street and NID program staff to discuss programs and projects of both organizations.
- Executive Director attended City of Orlando Staff Meet-N-Greet on March 26th.
- Executive Director Met w/DSNID Chair Rex McPherson to discuss DSNID.
- Executive Director attended City of Orlando Recording Secretary Training (mandated).
- Met w/City Staff to discuss FY 2015-16 Budget and develop a draft budget for approval.
- Met w/City of Orlando Public Works/Transportation staff to discuss current City projects and potential DSNID CIP.
- Met w/Shellie Gisclair re I-4 Ultimate Project impacts on Downtown South on April 16th.
- Attended Wadeview Neighborhood event to meet area residents on April 25th.
- Staff attended various Downtown South meetings and spent time meeting local business leaders and property owners.

➤ Key Project/Program Updates:

- I-4 Palm Tree Relocations – DSNID is currently working with the City of Orlando and FDOT to remove up to 18 Palm Trees currently located along I-4 and relocate some of these palm trees to various locations within Downtown South to enhance area aesthetics. On May 11th and 12th, two (2) Canary Island Date Palms were relocated to Iberia Bank, two (2) Canary Island Date Palms were placed at the Purdy property, and one (1) Dactylifera Date Palm was placed at the Pulse Club. Unfortunately, BB&T Bank and

Compton Properties couldn't reach agreement on a couple of points, so Compton asked us to remove BB&T from the list of DSNID relocation sites. The final quote to move these palms came in higher than anticipated, so the City of Orlando ended up scaling back the number of palms to stay within the approved budget cap (\$100,000 between City Parks Division, Downtown Development Board, and DSNID). The cost of moving five large date palms to three DSNID sites at a cost of \$5,200 each is \$26,000. DSNID had approved \$30,000 for the project. This remains a very good deal as new palms of this type generally cost at least \$10,000 each.

- *Division Street* – DSNID is actively partnering with the City of Orlando to make improvements to Division Street in conjunction with the I-4 Project. The goal was to enhance stormwater management, improve heavy truck and vehicle mobility, add bicycle and pedestrian facilities and enhance corridor aesthetics. Stormwater funds had been identified for the project but have since been allocated for projects along Bumby. As a result the project is delayed until further notice. The DSNID has the opportunity to assist the City and kick-start the project by committing some funding for preliminary design work.

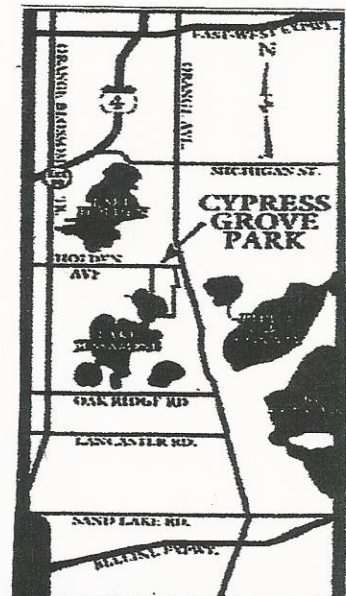
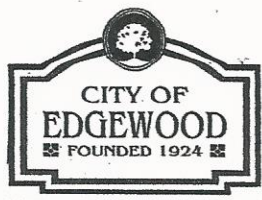
